

NOTE. HOUSEHOLDS AND FAMILIES: In 2007 there were 37,000 households in Kailua (Honolulu County)--Kaneohe, HI Urbanized Area. The average household size was 3.2 people.

Families made up 81 percent of the households in Kailua (Honolulu County)--Kaneohe, HI Urbanized Area. This figure includes both married-couple families (61 percent) and other families (19 percent). Nonfamily households made up 19 percent of all households in Kailua (Honolulu County)--Kaneohe, HI Urbanized Area. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.




## The Types of Households in Kailua (Honolulu County)--Kaneohe, HI Urbanized Area in 2007

NATIVITY AND LANGUAGE: Data for this section cannot be displayed because the number of sample cases is too small. Displaying the data would risk disclosing information for individuals.

GEOGRAPHIC MOBILITY: In 2007, 85 percent of the people at least one year old living in Kailua (Honolulu County)--Kaneohe, HI Urbanized Area were living in the same residence one year earlier; 8 percent had moved during the past year from another residence in the same county, less than 0.5 percent from another county in the same state, 5 percent from another state, and 1 percent from abroad.

## Geographic Mobility of Residents of Kailua (Honolulu County)--Kaneohe, HI Urbanized Area in 2007



EDUCATION: In 2007, 93 percent of people 25 years and over had at least graduated from high school and 34 percent had a bachelor's degree or higher. Seven percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Kailua (Honolulu County)--Kaneohe, HI Urbanized Area was 30,000 in 2007. Nursery school and kindergarten enrollment was 4,100 and elementary or high school enrollment was 18,000 children. College or graduate school enrollment was 7,900.

# The Educational Attainment of People in Kailua (Honolulu County)--Kaneohe, HI Urbanized Area in 2007






DISABILITY: In Kailua (Honolulu County)--Kaneohe, HI Urbanized Area, among people at least five years old in 2007, 12 percent reported a disability. The likelihood of having a disability varied by age - from 4 percent of people 5 to 15 years old, to 9 percent of people 16 to 64 years old, and to 32 percent of those 65 and older.

INDUSTRIES: In 2007, for the employed population 16 years and older, the leading industries in Kailua (Honolulu County)--Kaneohe, HI Urbanized Area were Educational services, and health care, and social assistance, 22 percent, and Retail trade, 11 percent.

OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Management, professional, and related occupations, 39 percent; Sales and office occupations, 28 percent; Service occupations, 15 percent; Construction, extraction, maintenance and repair occupations, 9 percent; and Production, transportation, and material moving occupations, 9 percent. Seventy-two percent of the people employed were Private wage and salary workers; 21 percent was Federal, state, or local government workers; and 7 percent was Self-employed in own not incorporated business workers.


TRAVEL TO WORK: Seventy-one percent of Kailua (Honolulu County)--Kaneohe, HI Urbanized Area workers drove to work alone in 2007, 16 percent carpooled, 4 percent took public transportation, and 6 percent used other means. The remaining 3 percent worked at home. Among those who commuted to work, it took them on average 27.2 minutes to get to work.

INCOME: The median income of households in Kailua (Honolulu County)--Kaneohe, HI Urbanized Area was \$81,274. Eighty-six percent of the households received earnings and 28 percent received retirement income other than Social Security. Thirty-three percent of the households received Social Security. The average income from Social Security was \$15,626. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2007, 7 percent of people

were in poverty. Eight percent of related children under 18 were below the poverty level, compared with 2 percent of people 65 years old and over. Five percent of all families and 10 percent of families with a female householder and no husband present had incomes below the poverty level.


### Poverty Rates in Kailua (Honolulu County)--Kaneohe, HI Urbanized Area in 2007



POPULATION OF Kailua (Honolulu County)--Kaneohe, HI Urbanized Area: In 2007, Kailua (Honolulu County)--Kaneohe, HI Urbanized Area had a total population of 120,000 - 60,000 (49 percent) females and 61,000 (51 percent) males. The median age was 36.1 years. Twenty-four percent of the population was under 18 years and 13 percent was 65 years and older.

#### The Age Distribution of People in Kailua (Honolulu County)--Kaneohe, HI Urbanized Area in 2007







For people reporting one race alone, 50 percent was White; 3 percent was Black or African American; 1 percent was American Indian and Alaska Native; 28 percent was Asian; 16 percent was Native Hawaiian and Other Pacific Islander, and 3 percent was Some other race. Twenty-nine percent reported Two or more races. Nine percent of the people in Kailua (Honolulu County)--Kaneohe, HI Urbanized Area was Hispanic. Thirty-three percent of the people in Kailua (Honolulu County)--Kaneohe, HI Urbanized Area was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2007, Kailua (Honolulu County)--Kaneohe, HI Urbanized Area had a total of 40,000 housing units, 8 percent of which were vacant. Of the total housing units, 77 percent was in single-unit structures, 22 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Ten percent of the housing units were built since 1990.

OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2007, Kailua (Honolulu County)--Kaneohe, HI Urbanized Area had 37,000 occupied housing units - 24,000 (65 percent) owner occupied and 13,000 (35 percent) renter occupied. Five percent of the households did not have telephone service and 5 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Forty percent had two vehicles and another 26 percent had three or more.
