
NOTE. HOUSEHOLDS AND FAMILIES: In 2006-2008 there were 12,000 households in Kaneohe CDP. The average household size was 2.9 people.

Families made up 77 percent of the households in Kaneohe CDP. This figure includes both married-couple families (55 percent) and other families (22 percent). Nonfamily households made up 23 percent of all households in Kaneohe CDP. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

The Types of Households in Kaneohe CDP, Hawaii in 2006-2008





GEOGRAPHIC MOBILITY: In 2006-2008, 87 percent of the people at least one year old living in Kaneohe CDP were living in the same residence one year earlier; 8 percent had moved during the past year from another residence in the same county, less than 0.5 percent from another county in the same state, 4 percent from another state, and 1 percent from abroad.

Same residence	87%



EDUCATION: In 2006-2008, 92 percent of people 25 years and over had at least graduated from high school and 30 percent had a bachelor's degree or higher. Eight percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Kaneohe CDP was 7,600 in 2006-2008. Nursery school and kindergarten enrollment was 830 and elementary or high school enrollment was 4,400 children. College or graduate school enrollment was 2,300.

The Educational Attainment of People in Kaneohe CDP, Hawaii in 2006-2008






INDUSTRIES: In 2006-2008, for the employed population 16 years and older, the leading industries in Kaneohe CDP were Educational services, and health care, and social assistance, 25 percent, and Arts, entertainment, and recreation, and accommodation, and food services, 11 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Management, professional, and related occupations, 38 percent; Sales and office occupations, 27 percent; Service occupations, 16 percent; Construction, extraction, maintenance and repair occupations, 11 percent; and Production, transportation, and material moving occupations, 7 percent. Seventy-two percent of the people employed were Private wage and salary workers; 22 percent was Federal, state, or local government workers; and 6 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Seventy percent of Kaneohe CDP workers drove to work alone in 2006-2008, 21 percent carpooled, 3 percent took public transportation, and 3 percent used other means. The remaining 2 percent worked at home. Among those who commuted to work, it took them on average 27.2 minutes to get to work.

INCOME: The median income of households in Kaneohe CDP was \$78,069. Eighty-two percent of the households received earnings and 32 percent received retirement income other than Social Security. Thirty-six percent of the households received Social Security. The average income from Social Security was \$15,016. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2006-2008, 6 percent of people were in poverty. Twelve percent of related children under 18 were below the poverty level, compared with 3 percent of people 65 years old and over. Four percent of all families and 11 percent of families with a female householder and no husband present had incomes below the poverty level.


Poverty Rates in Kaneohe CDP, Hawaii in 2006-2008

POPULATION OF Kaneohe CDP: In 2006-2008, Kaneohe CDP had a total population of 34,000 - 18,000 (53 percent) females and 16,000 (47 percent) males. The median age was 42.4 years. Nineteen percent of the population was under 18 years and 18 percent was 65 years and older.

The Age Distribution of People in Kaneohe CDP, Hawaii in 2006-2008



For people reporting one race alone, 22 percent was White; 1 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; 33 percent was Asian; 13 percent was Native Hawaiian and Other Pacific Islander, and 1 percent was Some other race. Thirty percent reported Two or more races. Seven percent of the people in Kaneohe CDP was Hispanic. Twenty percent of the people in Kaneohe CDP was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2006-2008, Kaneohe CDP had a total of 12,000 housing units, 5 percent of which were vacant. Of the total housing units, 69 percent was in single-unit structures, 30 percent was in multi-unit structures, and 1 percent was mobile homes. Eight percent of the housing units were built since 1990.

The Types of Housing Units in Kaneohe CDP, Hawaii in 2006-2008



OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2006-2008, Kaneohe CDP had 12,000 occupied housing units - 8,200 (69 percent) owner occupied and 3,700 (31 percent) renter occupied. Three percent of the households did not have telephone service and 7 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Thirty-seven percent had two vehicles and another 26 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$2,267, nonmortgaged owners \$436, and renters \$1,525. Forty-five percent of owners with mortgages, 6 percent of owners without mortgages, and 48 percent of renters in Kaneohe CDP spent 30 percent or more of household income on housing.
