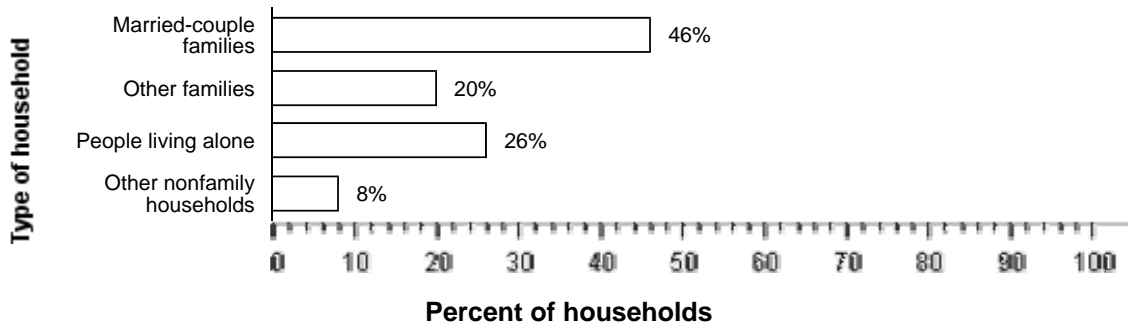
NOTE. **HOUSEHOLDS AND FAMILIES:** In 2009 there were 66,000 households in PUMA5 00200. The average household size was 2.6 people.

Families made up 66 percent of the households in PUMA5 00200. This figure includes both married-couple families (46 percent) and other families (20 percent). Nonfamily households made up 34 percent of all households in PUMA5 00200. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

**The Types of Households in PUMA5 00200, Hawaii in 2009**



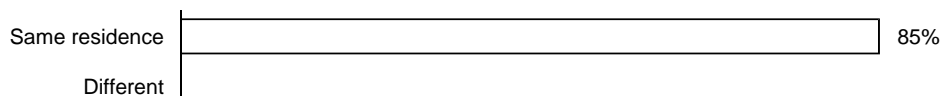

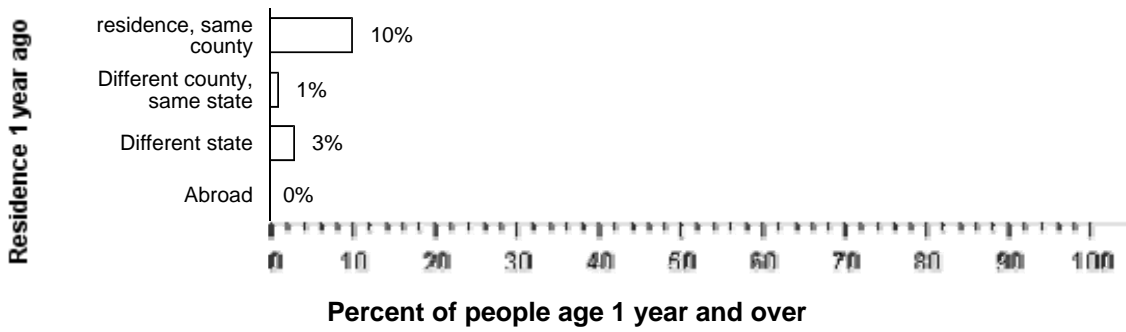
**NATIVITY AND LANGUAGE:** Nine percent of the people living in PUMA5 00200 in 2009 were foreign born. Ninety-one percent was native, including 58 percent who were born in Hawaii.

Among people at least five years old living in PUMA5 00200 in 2009, 18 percent spoke a language other than English at home. Of those speaking a language other than English at home, 16 percent spoke Spanish and 84 percent spoke some other language; 31 percent reported that they did not speak English "very well."

**GEOGRAPHIC MOBILITY:** In 2009, 85 percent of the people at least one year old living in PUMA5 00200 were living in the same residence one year earlier; 10 percent had moved during the past year from another residence in the same county, 1 percent from another county in the same state, 3 percent from another state, and less than 0.5 percent from abroad.

**Geographic Mobility of Residents of PUMA5 00200, Hawaii in 2009**



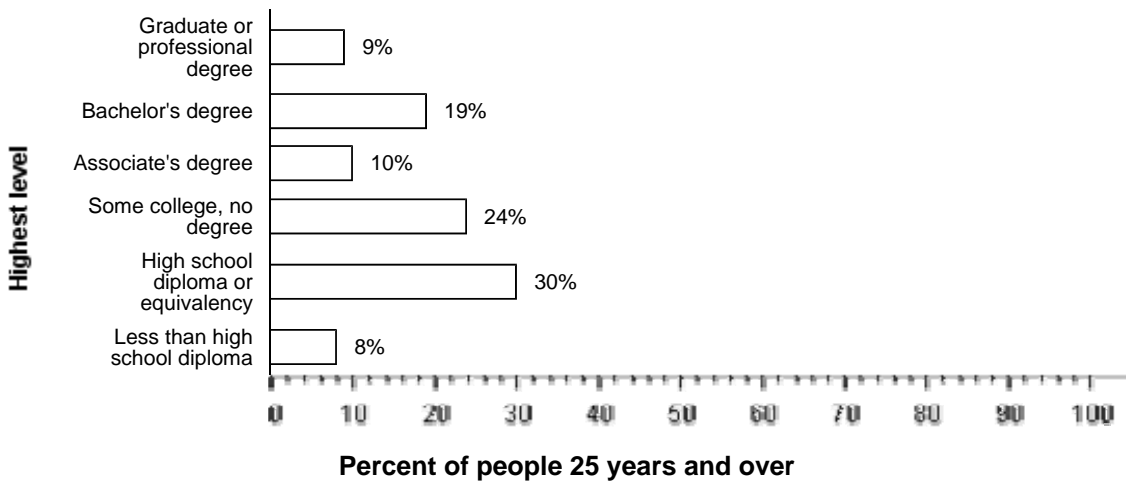

**EDUCATION:** In 2009, 92 percent of people 25 years and over had at least graduated from high school and 27 percent had a bachelor's degree or higher. Eight percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in PUMA5 00200 was 43,000 in 2009. Nursery school and kindergarten enrollment was 4,800 and elementary or high school enrollment was 28,000 children. College or graduate school enrollment was 10,000.

**The Educational Attainment of People in PUMA5 00200, Hawaii in 2009**

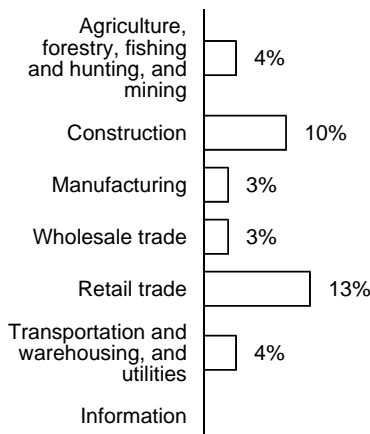


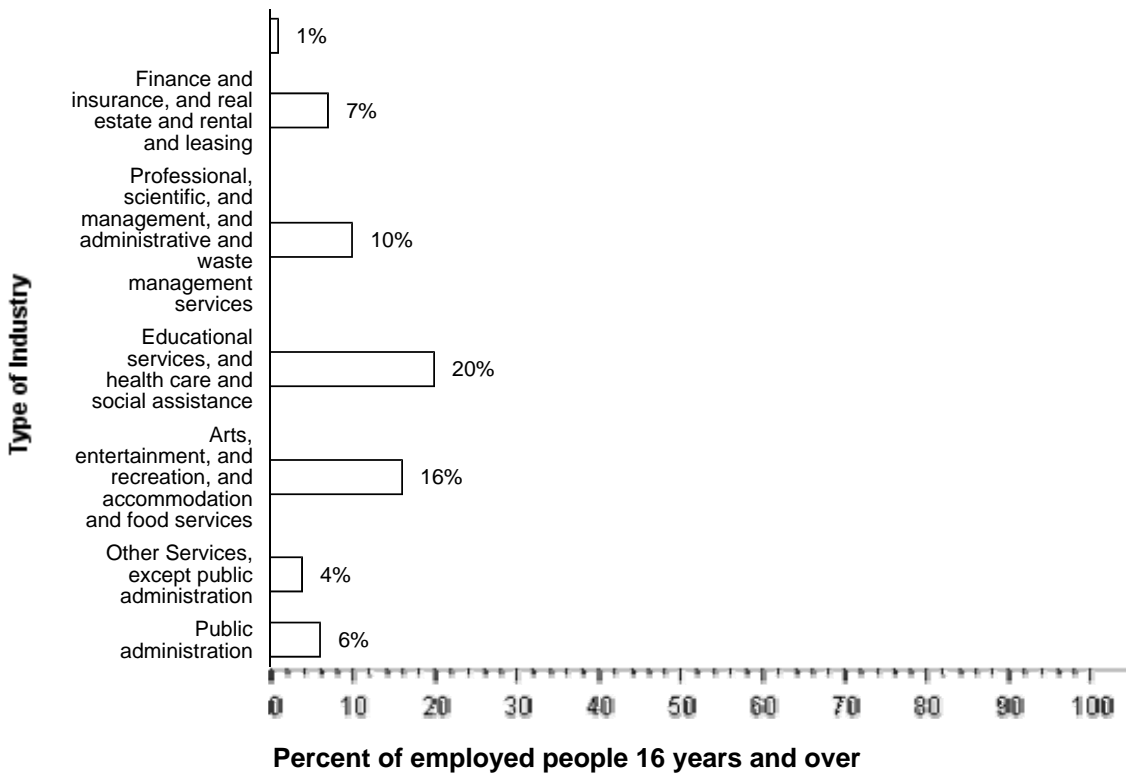

**DISABILITY:** In PUMA5 00200, among people at least five years old in 2009, 13 percent reported a disability. The likelihood of having a disability varied by age - from 2 percent of people 5 to 15 years old, to 11 percent of people 16 to 64 years old, and to 39 percent of those 65 and older.

**INDUSTRIES:** In 2009, for the employed population 16 years and older, the leading industries in PUMA5 00200 were Educational services, and health care, and social assistance, 20 percent, and Arts, entertainment, and recreation, and accommodation and food services, 16 percent.

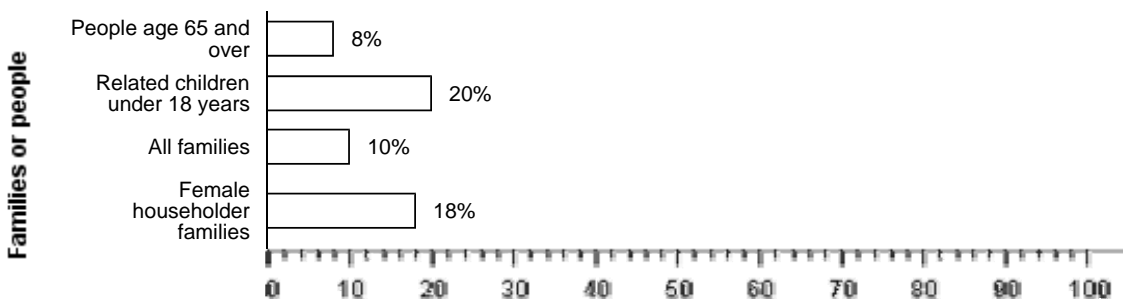
**OCCUPATIONS AND TYPE OF EMPLOYER:** Among the most common occupations were: Management, professional, and related occupations, 31 percent; Sales and office occupations, 26 percent; Service occupations, 23 percent; Construction, extraction, maintenance, and repair occupations, 11 percent; and Production, transportation, and material moving occupations, 9 percent. Sixty-five percent of the people employed were Private wage and salary workers; 20 percent was Federal, state, or local government workers; and 14 percent was Self-employed in own not incorporated business workers.

**TRAVEL TO WORK:** Seventy-one percent of PUMA5 00200 workers drove to work alone in 2009, 13 percent carpooled, 1 percent took public transportation, and 6 percent used other means. The remaining 9 percent worked at home. Among those who commuted to work, it took them on average 23 minutes to get to work.

**INCOME:** The median income of households in PUMA5 00200 was \$55,460. Seventy-nine percent of the households received earnings and 21 percent received retirement income other than Social Security. Thirty-three percent of the households received Social Security. The average income from Social Security was \$15,893. These income sources are not mutually exclusive; that is, some households received income from more than one source.

**POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS:** In 2009, 14 percent of people were in poverty. Twenty percent of related children under 18 were below the poverty level, compared with 8 percent of people 65 years old and over. Ten percent of all families and 18 percent of families with a female householder and no husband present had incomes below the poverty level.

Poverty Rates in PUMA5 00200, Hawaii in 2009

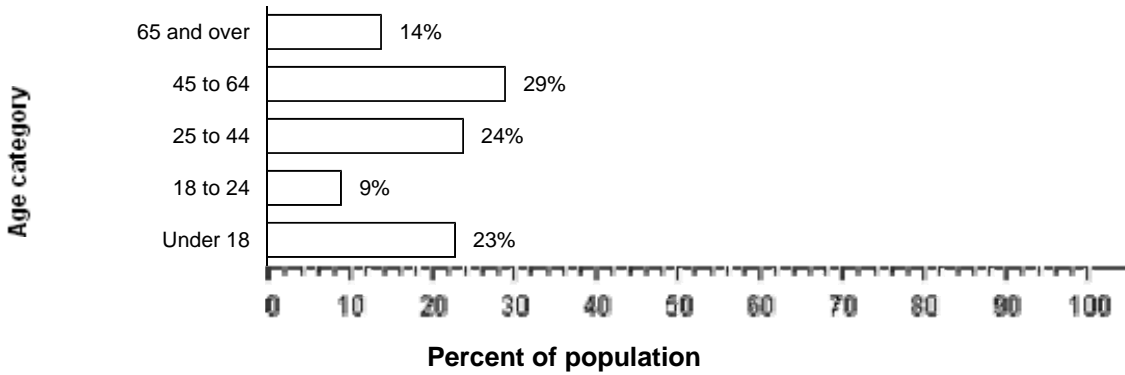


**Percent below poverty level**

POPULATION OF PUMA5 00200: In 2009, PUMA5 00200 had a total population of 178,000 - 87,000 (49 percent) females and 91,000 (51 percent) males. The median age was 39.5 years. Twenty-three percent of the population was under 18 years and 14 percent was 65 years and older.

**The Age Distribution of People in PUMA5 00200, Hawaii in 2009**

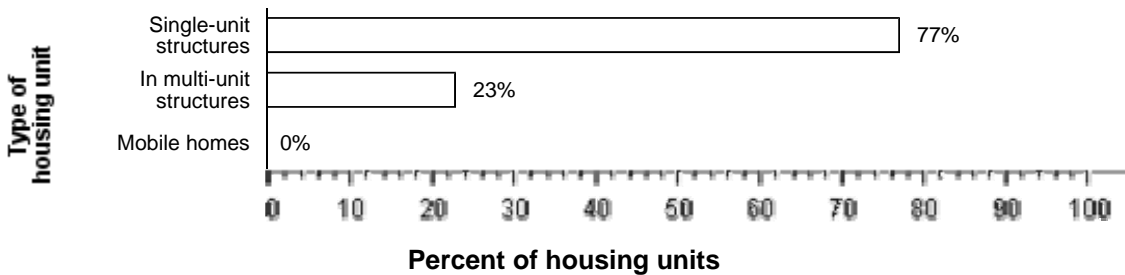

For people reporting one race alone, 35 percent was White; 1 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; 23 percent was Asian; 11 percent was Native Hawaiian and Other Pacific Islander, and 2 percent was Some other race. Twenty-seven percent reported Two or more races. Twelve percent of the people in PUMA5 00200 was Hispanic. Thirty-three percent of the people in PUMA5 00200 was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2009, PUMA5 00200 had a total of 81,000 housing units, 18 percent of which were vacant. Of the total housing units, 77 percent was in single-unit structures, 23 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Thirty-five percent of the housing units were built since 1990.

**The Types of Housing Units in PUMA5 00200, Hawaii in 2009**

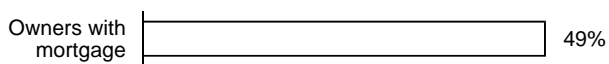


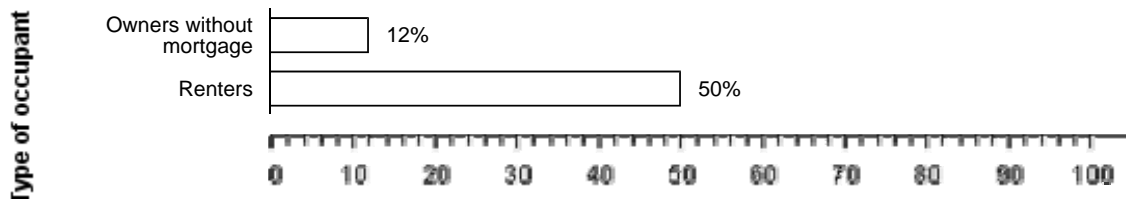

OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2009, PUMA5 00200 had 66,000 occupied housing units - 42,000 (63 percent) owner occupied and 24,000 (37 percent) renter occupied. Two percent of the households did not have telephone service and 5 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Thirty-eight percent had two vehicles and another 24 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,688, nonmortgaged owners \$323, and renters \$1,067. Forty-nine percent of owners with mortgages, 12 percent of owners without mortgages, and 50 percent of renters in PUMA5 00200 spent 30 percent or more of household income on housing.
