
NOTE. HOUSEHOLDS AND FAMILIES: In 2009 there were 37,000 households in PUMA5 00303. The average household size was 2.8 people.

Families made up 75 percent of the households in PUMA5 00303. This figure includes both married-couple families (59 percent) and other families (16 percent). Nonfamily households made up 25 percent of all households in PUMA5 00303. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

The Types of Households in PUMA5 00303, Hawaii in 2009





NATIVITY AND LANGUAGE: Data for this section cannot be displayed because the number of sample cases is too small. Displaying the data would risk disclosing information for individuals.

GEOGRAPHIC MOBILITY: In 2009, 86 percent of the people at least one year old living in PUMA5 00303 were living in the same residence one year earlier; 8 percent had moved during the past year from another residence in the same county, less than 0.5 percent from another county in the same state, 3 percent from another state, and 2 percent from abroad.


Percent of people age 1 year and over

EDUCATION: In 2009, 94 percent of people 25 years and over had at least graduated from high school and 44 percent had a bachelor's degree or higher. Six percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in PUMA5 00303 was 25,000 in 2009. Nursery school and kindergarten enrollment was 3,400 and elementary or high school enrollment was 13,000 children. College or graduate school enrollment was 8,300.

The Educational Attainment of People in PUMA5 00303, Hawaii in 2009






DISABILITY: In PUMA5 00303, among people at least five years old in 2009, 10 percent reported a disability. The likelihood of having a disability varied by age - from 3 percent of people 5 to 15 years old, to 4 percent of people 16 to 64 years old, and to 30 percent of those 65 and older.

INDUSTRIES: In 2009, for the employed population 16 years and older, the leading industries in PUMA5 00303 were Educational services, and health care, and social assistance, 26 percent, and Arts, entertainment, and recreation, and accommodation and food services, 14 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Management, professional, and related occupations, 47 percent; Sales and office occupations, 22 percent; Service occupations, 19 percent; Production, transportation, and material moving occupations, 7 percent; and Construction, extraction, maintenance, and repair occupations, 5 percent. Seventy-one percent of the people employed were Private wage and salary workers; 19 percent was Federal, state, or local government workers; and 9 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Sixty-eight percent of PUMA5 00303 workers drove to work alone in 2009, 19 percent carpooled, 3 percent took public transportation, and 5 percent used other means. The remaining 5 percent worked at home. Among those who commuted to work, it took them on average 26.8 minutes to get to work.

INCOME: The median income of households in PUMA5 00303 was \$86,064. Eighty-one percent of the households received earnings and 27 percent received retirement income other than Social Security. Forty percent of the households received Social Security. The average income from Social Security was \$20,014. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2009, 4 percent of people were in poverty. Three percent of related children under 18 were below the poverty level, compared with 3 percent of people 65 years old and over. Three percent of all families and 7 percent of families with a female householder and no husband present had incomes below the poverty level.





POPULATION OF PUMA5 00303: In 2009, PUMA5 00303 had a total population of 103,000 - 51,000 (49 percent) females and 53,000 (51 percent) males. The median age was 45.1 years. Eighteen percent of the population was under 18 years and 22 percent was 65 years and older.

The Age Distribution of People in PUMA5 00303, Hawaii in 2009





For people reporting one race alone, 31 percent was White; less than 0.5 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; 47 percent was Asian; 3 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Nineteen percent reported Two or more races. Six percent of the people in PUMA5 00303 was Hispanic. Twenty-eight percent of the people in PUMA5 00303 was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2009, PUMA5 00303 had a total of 41,000 housing units, 10 percent of which were vacant. Of the total housing units, 74 percent was in single-unit structures, 26 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Eighteen percent of the housing units were built since 1990.

The Types of Housing Units in PUMA5 00303, Hawaii in 2009



OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2009, PUMA5 00303 had 37,000 occupied housing units - 26,000 (70 percent) owner occupied and 11,000 (30 percent) renter occupied. Two percent of the households did not have telephone service and 5 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Fortyfour percent had two vehicles and another 23 percent had three or more.


HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$2,971, nonmortgaged owners \$515, and renters \$1,537. Forty-nine percent of owners with mortgages, 14 percent of owners without mortgages, and 51 percent of renters in PUMA5 00303 spent 30 percent or more of household income on housing.
