
NOTE. Although the American Community Survey (ACS) produces population, demographic and housing unit estimates, it is the Census Bureau's Population Estimates Program that produces and disseminates the official estimates of the population for the nation, states, counties, cities and towns and estimates of housing units for states and counties.

HOUSEHOLDS AND FAMILIES: In 2009 there were 67,000 households in PUMA5 00307. The average household size was 3.2 people.

Families made up 79 percent of the households in PUMA5 00307. This figure includes both married-couple families (60 percent) and other families (19 percent). Nonfamily households made up 21 percent of all households in PUMA5 00307. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.


NATIVITY AND LANGUAGE: Twenty-one percent of the people living in PUMA5 00307 in 2009 were foreign born. Seventy-nine percent was native, including 54 percent who were born in Hawaii.

Among people at least five years old living in PUMA5 00307 in 2009, 29 percent spoke a language other than English at home. Of those speaking a language other than English at home, 6 percent spoke Spanish and 94 percent spoke some other language; 51 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2009, 86 percent of the people at least one year old living in PUMA5 00307 were living in the same residence one year earlier; 9 percent had moved during the past year from another residence in the same county, less than 0.5 percent from another county in the same state, 3 percent from another state, and 1 percent from abroad.

Same residence	86%



EDUCATION: In 2009, 91 percent of people 25 years and over had at least graduated from high school and 28 percent had a bachelor's degree or higher. Nine percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in PUMA5 00307 was 56,000 in 2009. Nursery school and kindergarten enrollment was 6,600 and elementary or high school enrollment was 34,000 children. College or graduate school enrollment was 15,000.

The Educational Attainment of People in PUMA5 00307, Hawaii in 2009






DISABILITY: In PUMA5 00307, among people at least five years old in 2009, 9 percent reported a disability. The likelihood of having a disability varied by age - from 2 percent of people 5 to 15 years old, to 7 percent of people 16 to 64 years old, and to 40 percent of those 65 and older.

INDUSTRIES: In 2009, for the employed population 16 years and older, the leading industries in PUMA5 00307 were Educational services, and health care, and social assistance, 23 percent, and Arts, entertainment, and recreation, and accommodation and food services, 12 percent.

Employment by Industry in PUMA5 00307, Hawaii in 2009








OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Management, professional, and related occupations, 34 percent; Sales and office occupations, 24 percent; Service occupations, 21 percent; Construction, extraction, maintenance, and repair occupations, 11 percent; and Production, transportation, and material moving occupations, 10 percent. Sixty-nine percent of the people employed were Private wage and salary workers; 26 percent was Federal, state, or local government workers; and 4 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Seventy-four percent of PUMA5 00307 workers drove to work alone in 2009, 15 percent carpooled, 5 percent took public transportation, and 3 percent used other means. The remaining 2 percent worked at home. Among those who commuted to work, it took them on average 31.9 minutes to get to work.

INCOME: The median income of households in PUMA5 00307 was \$81,132. Ninety-one percent of the households received earnings and 23 percent received retirement income other than Social Security. Twenty-three percent of the households received Social Security. The average income from Social Security was \$15,451. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2009, 8 percent of people were in poverty. Ten percent of related children under 18 were below the poverty level, compared with 11 percent of people 65 years old and over. Six percent of all families and 25 percent of families with a female householder and no husband present had incomes below the poverty level.







POPULATION OF PUMA5 00307: In 2009, PUMA5 00307 had a total population of 219,000 - 109,000 (50 percent) females and 110,000 (50 percent) males. The median age was 34.8 years. Twenty-five percent of the population was under 18 years and 10 percent was 65 years and older.



For people reporting one race alone, 17 percent was White; 5 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; 45 percent was Asian; 6 percent was Native Hawaiian and Other Pacific Islander, and 1 percent was Some other race. Twenty-six percent reported Two or more races. Nine percent of the people in PUMA5 00307 was Hispanic. Fifteen percent of the people in PUMA5 00307 was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2009, PUMA5 00307 had a total of 70,000 housing units, 5 percent of which were vacant. Of the total housing units, 67 percent was in single-unit structures, 33 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Forty-eight percent of the housing units were built since 1990.

The Types of Housing Units in PUMA5 00307, Hawaii in 2009




OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2009, PUMA5 00307 had 67,000 occupied housing units - 46,000 (69 percent) owner occupied and 21,000 (31 percent) renter occupied. One percent of the households did not have telephone service and 4 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Forty-five percent had two vehicles and another 26 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$2,462, nonmortgaged owners \$458, and renters \$1,603. Forty-eight percent of owners with mortgages, 14 percent of owners without mortgages, and 59 percent of renters in PUMA5 00307 spent 30 percent or more of household income on housing.
