In addition to sampling variability, the ACS estimates are subject to nonsampling error (for a discussion of nonsampling variability, see Accuracy of the Data). The effect of nonsampling error is not represented in these tables.

- •The Census Bureau introduced a new set of disability questions in the 2008 ACS questionnaire. Multi-year estimates of disability status will become available once three consecutive years of data are collected. - ·Occupation codes are 4-digit codes and are based on Standard Occupational Classification 2000.
- Industry codes are 4-digit codes and are based on the North American Industry Classification System 2002 and 2007.
