

NOTE. HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 2,800 households in Aiea CDP. The average household size was 3 people.

Families made up 76 percent of the households in Aiea CDP. This figure includes both marriedcouple families (62 percent) and other families (14 percent). Nonfamily households made up 24 percent of all households in Aiea CDP. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

NATIVITY AND LANGUAGE: Thirteen percent of the people living in Aiea CDP in 2005-2009 were foreign born. Eighty-seven percent was native, including 66 percent who were born in Hawaii.

Among people at least five years old living in Aiea CDP in 2005-2009, 22 percent spoke a language other than English at home. Of those speaking a language other than English at home, 7 percent spoke Spanish and 93 percent spoke some other language; 44 percent reported that they did not speak English "very well."


GEOGRAPHIC MOBILITY: In 2005-2009, 91 percent of the people at least one year old living in Aiea CDP were living in the same residence one year earlier; 7 percent had moved during the past year from another residence in the same county, less than 0.5 percent from another county in the same state, 3 percent from another state, and less than 0.5 percent from abroad.

Different



EDUCATION: In 2005-2009, 89 percent of people 25 years and over had at least graduated from high school and 32 percent had a bachelor's degree or higher. Eleven percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Aiea CDP was 1,700 in 2005-2009. Nursery school and kindergarten enrollment was 260 and elementary or high school enrollment was 990 children. College or graduate school enrollment was 420.




The Educational Attainment of People in Aiea CDP, Hawaii in 2005-2009



DISABILITY: In Aiea CDP, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Aiea CDP were Educational services, and health care, and social assistance, 22 percent, and Arts, entertainment, and recreation, and accommodation and food services, 13 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Management, professional, and related occupations, 34 percent; Service occupations, 22 percent; Sales and office occupations, 20 percent; Construction, extraction, maintenance, and repair occupations, 12 percent; and Production, transportation, and material moving occupations, 11 percent. Sixty-eight percent of the people employed were Private wage and salary workers; 24 percent was Federal, state, or local government workers; and 7 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Seventy percent of Aiea CDP workers drove to work alone in 2005-2009, 15 percent carpooled, 4 percent took public transportation, and 8 percent used other means. The remaining 3 percent worked at home. Among those who commuted to work, it took them on average 25.2 minutes to get to work.

INCOME: The median income of households in Aiea CDP was \$78,750. Eighty-one percent of the households received earnings and 34 percent received retirement income other than Social Security. Forty-five percent of the households received Social Security. The average income from Social Security was \$16,405. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 5 percent of people were in poverty. Three percent of related children under 18 were below the poverty level, compared with 5 percent of people 65 years old and over. One percent of all families and 10 percent of families with a female householder and no husband present had incomes below the poverty level.

Poverty Rates in Aiea CDP, Hawaii in 2005-2009




Percent below poverty level

POPULATION OF Aiea CDP: In 2005-2009, Aiea CDP had a total population of 8,300 - 4,200 (50 percent) females and 4,100 (50 percent) males. The median age was 43.8 years. Nineteen percent of the population was under 18 years and 23 percent was 65 years and older.


The Age Distribution of People in Aiea CDP, Hawaii in 2005-2009

For people reporting one race alone, 18 percent was White; 1 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; 58 percent was Asian; 2 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Twenty percent reported Two or more races. Five percent of the people in Aiea CDP was Hispanic. Sixteen percent of the people in Aiea CDP was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Aiea CDP had a total of 2,800 housing units, 1 percent of which were vacant. Of the total housing units, 96 percent was in single-unit structures, 4 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Fourteen percent of the housing units were built since 1990.

OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Aiea CDP had 2,800 occupied housing units - 2,100 (78 percent) owner occupied and 620 (22 percent) renter occupied. One percent of the households did not have telephone service and 4 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Thirty-eight percent had two vehicles and another 33 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$2,394, nonmortgaged owners \$389, and renters \$1,738. Fifty-one percent of owners with mortgages, 5 percent of owners without mortgages, and 57 percent of renters in Aiea CDP spent 30 percent or more of household income on housing.


Occupants with a Housing Cost Burden in Aiea CDP, Hawaii in 2005-2009
