
NOTE. Although the American Community Survey (ACS) produces population, demographic and housing unit estimates, it is the Census Bureau's Population Estimates Program that produces and disseminates the official estimates of the population for the nation, states, counties, cities and towns and estimates of housing units for states and counties.

HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 160 households in Halaula CDP. The average household size was 3.1 people.

Families made up 70 percent of the households in Halaula CDP. This figure includes both married-couple families (43 percent) and other families (28 percent). Nonfamily households made up 30 percent of all households in Halaula CDP. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.


NATIVITY AND LANGUAGE: Nineteen percent of the people living in Halaula CDP in 2005-2009 were foreign born. Eighty-one percent was native, including 67 percent who were born in Hawaii.

Among people at least five years old living in Halaula CDP in 2005-2009, 23 percent spoke a language other than English at home. Of those speaking a language other than English at home, 18 percent spoke Spanish and 82 percent spoke some other language; 36 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 83 percent of the people at least one year old living in Halaula CDP were living in the same residence one year earlier; 12 percent had moved during the past year from another residence in the same county, less than 0.5 percent from another county in the same state, 3 percent from another state, and 2 percent from abroad.



EDUCATION: In 2005-2009, 92 percent of people 25 years and over had at least graduated from high school and 12 percent had a bachelor's degree or higher. Eight percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Halaula CDP was 91 in 2005-2009. Nursery school and kindergarten enrollment was 22 and elementary or high school enrollment was 60 children. College or graduate school enrollment was 9.

The Educational Attainment of People in Halaula CDP, Hawaii in 2005-2009






DISABILITY: In Halaula CDP, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Halaula CDP were Arts, entertainment, and recreation, and accommodation and food services, 50 percent, and Retail trade, 11 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Service occupations, 36 percent; Sales and office occupations, 21 percent; Management, professional, and related occupations, 19 percent; Construction, extraction, maintenance, and repair occupations, 14 percent; and Production, transportation, and material moving occupations, 9 percent. Sixty-six percent of the people employed were Private wage and salary workers; 23 percent was Federal, state, or local government workers; and 11 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Eighty-one percent of Halaula CDP workers drove to work alone in 2005-2009, 14 percent carpooled, 1 percent took public transportation, and less than 0.5 percent used other means. The remaining 4 percent worked at home. Among those who commuted to work, it took them on average 36.7 minutes to get to work.

INCOME: The median income of households in Halaula CDP was \$61,875. Ninety-three percent of the households received earnings and 28 percent received retirement income other than Social Security. Forty percent of the households received Social Security. The average income from Social Security was \$14,055. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 6 percent of people were in poverty. Four percent of related children under 18 were below the poverty level, compared with less than 0.5 percent of people 65 years old and over. Four percent of all families and 19 percent of families with a female householder and no husband present had incomes below the poverty level.






Percent below poverty level

POPULATION OF Halaula CDP: In 2005-2009, Halaula CDP had a total population of 500 - 210 (41 percent) females and 300 (59 percent) males. The median age was 36 years. Twenty-three percent of the population was under 18 years and 15 percent was 65 years and older.

The Age Distribution of People in Halaula CDP, Hawaii in 2005-2009



For people reporting one race alone, 26 percent was White; less than 0.5 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; 43 percent was Asian; 9 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Twenty-two percent reported Two or more races. Fifteen percent of the people in Halaula CDP was Hispanic. Twenty-two percent of the people in Halaula CDP was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Halaula CDP had a total of 180 housing units, 11 percent of which were vacant. Of the total housing units, 92 percent was in single-unit structures, 8 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Five percent of the housing units were built since 1990.


OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Halaula CDP had 160 occupied housing units - 100 (62 percent) owner occupied and 61 (38 percent) renter occupied. Less than 0.5 percent of the households did not have telephone service and 2 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Thirty percent had two vehicles and another 40 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,354, nonmortgaged owners \$272, and renters \$1,045. Thirty-eight percent of owners with mortgages, less than 0.5 percent of owners without mortgages, and 48 percent of renters in Halaula CDP spent 30 percent or more of household income on housing.
