
NOTE. Although the American Community Survey (ACS) produces population, demographic and housing unit estimates, it is the Census Bureau's Population Estimates Program that produces and disseminates the official estimates of the population for the nation, states, counties, cities and towns and estimates of housing units for states and counties.

HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 160 households in Hanalei CDP. The average household size was 3.6 people.

Families made up 81 percent of the households in Hanalei CDP. This figure includes both married-couple families (43 percent) and other families (38 percent). Nonfamily households made up 19 percent of all households in Hanalei CDP. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.


NATIVITY AND LANGUAGE: Five percent of the people living in Hanalei CDP in 2005-2009 were foreign born. Ninety-five percent was native, including 52 percent who were born in Hawaii.

Among people at least five years old living in Hanalei CDP in 2005-2009, 11 percent spoke a language other than English at home. Of those speaking a language other than English at home, 39 percent spoke Spanish and 61 percent spoke some other language; 4 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 88 percent of the people at least one year old living in Hanalei CDP were living in the same residence one year earlier; 8 percent had moved during the past year from another residence in the same county, less than 0.5 percent from another county in the same state, 4 percent from another state, and less than 0.5 percent from abroad.



EDUCATION: In 2005-2009, 93 percent of people 25 years and over had at least graduated from high school and 23 percent had a bachelor's degree or higher. Seven percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Hanalei CDP was 120 in 2005-2009. Nursery school and kindergarten enrollment was 21 and elementary or high school enrollment was 89 children. College or graduate school enrollment was 6.

The Educational Attainment of People in Hanalei CDP, Hawaii in 2005-2009






DISABILITY: In Hanalei CDP, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Hanalei CDP were Construction, 20 percent, and Retail trade, 16 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Sales and office occupations, 34 percent; Service occupations, 25 percent; Management, professional, and related occupations, 17 percent; Construction, extraction, maintenance, and repair occupations, 16 percent; and Farming, fishing, and forestry occupations, 6 percent. Sixty-three percent of the people employed were Private wage and salary workers; 8 percent was Federal, state, or local government workers; and 24 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Sixty-one percent of Hanalei CDP workers drove to work alone in 2005-2009, 11 percent carpooled, less than 0.5 percent took public transportation, and 18 percent used other means. The remaining 10 percent worked at home. Among those who commuted to work, it took them on average 10.9 minutes to get to work.

INCOME: The median income of households in Hanalei CDP was \$72,917. Ninety-three percent of the households received earnings and 19 percent received retirement income other than Social Security. Thirty-two percent of the households received Social Security. The average income from Social Security was \$14,859. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 1 percent of people were in poverty. Less than 0.5 percent of related children under 18 were below the poverty level, compared with less than 0.5 percent of people 65 years old and over. Less than 0.5 percent of all families and less than 0.5 percent of families with a female householder and no husband present had incomes below the poverty level.






POPULATION OF Hanalei CDP: In 2005-2009, Hanalei CDP had a total population of 570 - 280 (48 percent) females and 300 (52 percent) males. The median age was 40.4 years. Twenty-two percent of the population was under 18 years and 11 percent was 65 years and older.

The Age Distribution of People in Hanalei CDP, Hawaii in 2005-2009







For people reporting one race alone, 59 percent was White; 1 percent was Black or African American; 1 percent was American Indian and Alaska Native; 19 percent was Asian; 2 percent was Native Hawaiian and Other Pacific Islander, and 1 percent was Some other race. Seventeen percent reported Two or more races. Twelve percent of the people in Hanalei CDP was Hispanic. Fifty-four percent of the people in Hanalei CDP was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Hanalei CDP had a total of 360 housing units, 56 percent of which were vacant. Of the total housing units, 85 percent was in single-unit structures, 14 percent was in multi-unit structures, and 2 percent was mobile homes. Forty percent of the housing units were built since 1990.


OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Hanalei CDP had 160 occupied housing units - 89 (55 percent) owner occupied and 72 (45 percent) renter occupied. Four percent of the households did not have telephone service and less than 0.5 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Fifty-two percent had two vehicles and another 29 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$2,554, nonmortgaged owners \$764, and renters \$1,554. Sixty percent of owners with mortgages, 22 percent of owners without mortgages, and 52 percent of renters in Hanalei CDP spent 30 percent or more of household income on housing.
