

NOTE. HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 820 households in Hanapepe CDP. The average household size was 2.9 people.

Families made up 69 percent of the households in Hanapepe CDP. This figure includes both married-couple families (50 percent) and other families (19 percent). Nonfamily households made up 31 percent of all households in Hanapepe CDP. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

NATIVITY AND LANGUAGE: Fifteen percent of the people living in Hanapepe CDP in 2005-2009 were foreign born. Eighty-five percent was native, including 69 percent who were born in Hawaii.

Among people at least five years old living in Hanapepe CDP in 2005-2009, 18 percent spoke a language other than English at home. Of those speaking a language other than English at home, 2 percent spoke Spanish and 98 percent spoke some other language; 41 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 93 percent of the people at least one year old living in Hanapepe CDP were living in the same residence one year earlier; 5 percent had moved during the past year from another residence in the same county, 1 percent from another county in the same state, 1 percent from another state, and less than 0.5 percent from abroad.


Geographic Mobility of Residents of Hanapepe CDP, Hawaii in 2005-2009



EDUCATION: In 2005-2009, 87 percent of people 25 years and over had at least graduated from high school and 17 percent had a bachelor's degree or higher. Thirteen percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Hanapepe CDP was 570 in 2005-2009. Nursery school and kindergarten enrollment was 10 and elementary or high school enrollment was 430 children. College or graduate school enrollment was 130.




The Educational Attainment of People in Hanapepe CDP, Hawaii in 2005-2009



DISABILITY: In Hanapepe CDP, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Hanapepe CDP were Arts, entertainment, and recreation, and accommodation and food services, 30 percent, and Retail trade, 13 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Service occupations, 28 percent; Management, professional, and related occupations, 22 percent; Sales and office occupations, 21 percent; Construction, extraction, maintenance, and repair occupations, 13 percent; and Production, transportation, and material moving occupations, 13 percent. Eighty-two percent of the people employed were Private wage and salary workers; 16 percent was Federal, state, or local government workers; and 2 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Eighty-six percent of Hanapepe CDP workers drove to work alone in 2005-2009, 9 percent carpooled, less than 0.5 percent took public transportation, and 3 percent used other means. The remaining 2 percent worked at home. Among those who commuted to work, it took them on average 24.7 minutes to get to work.

INCOME: The median income of households in Hanapepe CDP was \$63,158. Eighty-two percent of the households received earnings and 20 percent received retirement income other than Social Security. Twenty-seven percent of the households received Social Security. The average income from Social Security was \$15,518. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 3 percent of people were in poverty. Less than 0.5 percent of related children under 18 were below the poverty level, compared with 5 percent of people 65 years old and over. Two percent of all families and less than 0.5 percent of families with a female householder and no husband present had incomes below the poverty level.

Poverty Rates in Hanapepe CDP, Hawaii in 2005-2009




Percent below poverty level

POPULATION OF Hanapepe CDP: In 2005-2009, Hanapepe CDP had a total population of 2,400 - 1,100 (48 percent) females and 1,200 (52 percent) males. The median age was 36.9 years. Twenty-two percent of the population was under 18 years and 13 percent was 65 years and older.


The Age Distribution of People in Hanapepe CDP, Hawaii in 2005-2009

For people reporting one race alone, 20 percent was White; less than 0.5 percent was Black or African American; 2 percent was American Indian and Alaska Native; 55 percent was Asian; 9 percent was Native Hawaiian and Other Pacific Islander, and 1 percent was Some other race. Thirteen percent reported Two or more races. Eight percent of the people in Hanapepe CDP was Hispanic. Sixteen percent of the people in Hanapepe CDP was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Hanapepe CDP had a total of 870 housing units, 6 percent of which were vacant. Of the total housing units, 90 percent was in single-unit structures, 8 percent was in multi-unit structures, and 3 percent was mobile homes. Forty-six percent of the housing units were built since 1990.


OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Hanapepe CDP had 820 occupied housing units - 490 (59 percent) owner occupied and 330 (41 percent) renter occupied. Eleven percent of the households did not have telephone service and 2 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Thirty percent had two vehicles and another 38 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,798, nonmortgaged owners \$416, and renters \$826. Forty-four percent of owners with mortgages, 12 percent of owners without mortgages, and 33 percent of renters in Hanapepe CDP spent 30 percent or more of household income on housing.
