

NOTE. HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 320 households in Hawi CDP. The average household size was 3.2 people.

Families made up 81 percent of the households in Hawi CDP. This figure includes both marriedcouple families (58 percent) and other families (22 percent). Nonfamily households made up 19 percent of all households in Hawi CDP. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

NATIVITY AND LANGUAGE: Five percent of the people living in Hawi CDP in 2005-2009 were foreign born. Ninety-five percent was native, including 79 percent who were born in Hawaii.

Among people at least five years old living in Hawi CDP in 2005-2009, 7 percent spoke a language other than English at home. Of those speaking a language other than English at home, less than 0.5 percent spoke Spanish and 100 percent spoke some other language; 13 percent reported that they did not speak English "very well."


GEOGRAPHIC MOBILITY: In 2005-2009, 85 percent of the people at least one year old living in Hawi CDP were living in the same residence one year earlier; 14 percent had moved during the past year from another residence in the same county, less than 0.5 percent from another county in the same state, 1 percent from another state, and less than 0.5 percent from abroad.



EDUCATION: In 2005-2009, 91 percent of people 25 years and over had at least graduated from high school and 15 percent had a bachelor's degree or higher. Nine percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Hawi CDP was 280 in 2005-2009. Nursery school and kindergarten enrollment was 16 and elementary or high school enrollment was 240 children. College or graduate school enrollment was 28.




## The Educational Attainment of People in Hawi CDP, Hawaii in 2005-2009



DISABILITY: In Hawi CDP, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Hawi CDP were Arts, entertainment, and recreation, and accommodation and food services, 32 percent, and Construction, 17 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Service occupations, 33 percent; Sales and office occupations, 27 percent; Construction, extraction, maintenance, and repair occupations, 18 percent; Management, professional, and related occupations, 17 percent; and Production, transportation, and material moving occupations, 5 percent. Seventy-four percent of the people employed were Private wage and salary workers; 20 percent was Federal, state, or local government workers; and 7 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Seventy-two percent of Hawi CDP workers drove to work alone in 2005-2009, 23 percent carpooled, less than 0.5 percent took public transportation, and 1 percent used other means. The remaining 4 percent worked at home. Among those who commuted to work, it took them on average 30 minutes to get to work.

INCOME: The median income of households in Hawi CDP was \$61,607. Eighty percent of the households received earnings and 28 percent received retirement income other than Social Security. Thirty-eight percent of the households received Social Security. The average income from Social Security was \$15,612. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 3 percent of people were in poverty. Two percent of related children under 18 were below the poverty level, compared with 4 percent of people 65 years old and over. Five percent of all families and 14 percent of families with a female householder and no husband present had incomes below the poverty level.

### Poverty Rates in Hawi CDP, Hawaii in 2005-2009





POPULATION OF Hawi CDP: In 2005-2009, Hawi CDP had a total population of 1,000 - 490 (48 percent) females and 540 (52 percent) males. The median age was 36.3 years. Thirty-one percent of the population was under 18 years and 12 percent was 65 years and older.


## The Age Distribution of People in Hawi CDP, Hawaii in 2005-2009

For people reporting one race alone, 18 percent was White; less than 0.5 percent was Black or African American; 1 percent was American Indian and Alaska Native; 19 percent was Asian; 10 percent was Native Hawaiian and Other Pacific Islander, and 2 percent was Some other race. Fifty-one percent reported Two or more races. Twenty-one percent of the people in Hawi CDP was Hispanic. Fifteen percent of the people in Hawi CDP was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Hawi CDP had a total of 370 housing units, 14 percent of which were vacant. Of the total housing units, 92 percent was in single-unit structures, 8 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Twenty-four percent of the housing units were built since 1990.


OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Hawi CDP had 320 occupied housing units - 240 (75 percent) owner occupied and 80 (25 percent) renter occupied. Less than 0.5 percent of the households did not have telephone service and less than 0.5 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Forty-three percent had two vehicles and another 30 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,313, nonmortgaged owners \$348, and renters \$975. Twenty-nine percent of owners with mortgages, 16 percent of owners without mortgages, and 29 percent of renters in Hawi CDP spent 30 percent or more of household income on housing.
