

NOTE. HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 380 households in Kalihiwai CDP. The average household size was 2.5 people.

Families made up 68 percent of the households in Kalihiwai CDP. This figure includes both married-couple families (54 percent) and other families (14 percent). Nonfamily households made up 32 percent of all households in Kalihiwai CDP. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

NATIVITY AND LANGUAGE: Nine percent of the people living in Kalihiwai CDP in 2005-2009 were foreign born. Ninety-one percent was native, including 36 percent who were born in Hawaii.

Among people at least five years old living in Kalihiwai CDP in 2005-2009, 12 percent spoke a language other than English at home. Of those speaking a language other than English at home, 37 percent spoke Spanish and 63 percent spoke some other language; 39 percent reported that they did not speak English "very well."


GEOGRAPHIC MOBILITY: In 2005-2009, 89 percent of the people at least one year old living in Kalihiwai CDP were living in the same residence one year earlier; 9 percent had moved during the past year from another residence in the same county, less than 0.5 percent from another county in the same state, 2 percent from another state, and 1 percent from abroad.

Different



EDUCATION: In 2005-2009, 97 percent of people 25 years and over had at least graduated from high school and 51 percent had a bachelor's degree or higher. Three percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Kalihiwai CDP was 280 in 2005-2009. Nursery school and kindergarten enrollment was 19 and elementary or high school enrollment was 210 children. College or graduate school enrollment was 46.



The Educational Attainment of People in Kalihiwai CDP, Hawaii in 2005-2009



DISABILITY: In Kalihiwai CDP, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Kalihiwai CDP were Arts, entertainment, and recreation, and accommodation and food services, 25 percent, and Educational services, and health care, and social assistance, 23 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Management, professional, and related occupations, 36 percent; Sales and office occupations, 28 percent; Service occupations, 25 percent; Construction, extraction, maintenance, and repair occupations, 7 percent; and Production, transportation, and material moving occupations, 3 percent. Seventy percent of the people employed were Private wage and salary workers; 14 percent was Federal, state, or local government workers; and 16 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Seventy percent of Kalihiwai CDP workers drove to work alone in 2005-2009, 13 percent carpooled, less than 0.5 percent took public transportation, and 4 percent used other means. The remaining 13 percent worked at home. Among those who commuted to work, it took them on average 14.4 minutes to get to work.

INCOME: The median income of households in Kalihiwai CDP was \$63,611. Ninety-four percent of the households received earnings and 8 percent received retirement income other than Social Security. Nine percent of the households received Social Security. The average income from Social Security was \$24,909. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 4 percent of people were in poverty. Five percent of related children under 18 were below the poverty level, compared with less than 0.5 percent of people 65 years old and over. Three percent of all families and 20 percent of families with a female householder and no husband present had incomes below the poverty level.

Poverty Rates in Kalihiwai CDP, Hawaii in 2005-2009




Percent below poverty level

POPULATION OF Kalihiwai CDP: In 2005-2009, Kalihiwai CDP had a total population of 950 -470 (50 percent) females and 480 (50 percent) males. The median age was 40.6 years. Twentyfour percent of the population was under 18 years and 7 percent was 65 years and older.


The Age Distribution of People in Kalihiwai CDP, Hawaii in 2005-2009

For people reporting one race alone, 73 percent was White; less than 0.5 percent was Black or African American; 1 percent was American Indian and Alaska Native; 9 percent was Asian; 6 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Eleven percent reported Two or more races. Five percent of the people in Kalihiwai CDP was Hispanic. Seventy percent of the people in Kalihiwai CDP was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Kalihiwai CDP had a total of 610 housing units, 38 percent of which were vacant. Of the total housing units, 76 percent was in single-unit structures, 24 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Fifty-four percent of the housing units were built since 1990.

OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Kalihiwai CDP had 380 occupied housing units - 220 (57 percent) owner occupied and 160 (43 percent) renter occupied. Less than 0.5 percent of the households did not have telephone service and 3 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Forty-nine percent had two vehicles and another 17 percent had three or more.


HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$3,250, nonmortgaged owners \$600, and renters \$1,373. Sixty percent of owners with mortgages, less than 0.5 percent of owners without mortgages, and 71 percent of renters in Kalihiwai CDP spent 30 percent or more of household income on housing.
