



NOTE. Although the American Community Survey (ACS) produces population, demographic and housing unit estimates, it is the Census Bureau's Population Estimates Program that produces and disseminates the official estimates of the population for the nation, states, counties, cities and towns and estimates of housing units for states and counties.

HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 900 households in Kaunakakai CDP. The average household size was 2.8 people.

Families made up 68 percent of the households in Kaunakakai CDP. This figure includes both married-couple families (53 percent) and other families (16 percent). Nonfamily households made up 32 percent of all households in Kaunakakai CDP. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

NATIVITY AND LANGUAGE: Fifteen percent of the people living in Kaunakakai CDP in 2005-2009 were foreign born. Eighty-five percent was native, including 71 percent who were born in Hawaii.


Among people at least five years old living in Kaunakakai CDP in 2005-2009, 22 percent spoke a language other than English at home. Of those speaking a language other than English at home, 1 percent spoke Spanish and 99 percent spoke some other language; 14 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 89 percent of the people at least one year old living in Kaunakakai CDP were living in the same residence one year earlier; 8 percent had moved during the past year from another residence in the same county, less than 0.5 percent from another county in the same state, 3 percent from another state, and less than 0.5 percent from abroad.

Same residence



EDUCATION: In 2005-2009, 86 percent of people 25 years and over had at least graduated from high school and 18 percent had a bachelor's degree or higher. Fourteen percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Kaunakakai CDP was 740 in 2005-2009. Nursery school and kindergarten enrollment was 110 and elementary or high school enrollment was 500 children. College or graduate school enrollment was 130.




The Educational Attainment of People in Kaunakakai CDP, Hawaii in 2005-2009



DISABILITY: In Kaunakakai CDP, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Kaunakakai CDP were Educational services, and health care, and social assistance, 23 percent, and Retail trade, 15 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Service occupations, 25 percent; Sales and office occupations, 23 percent; Management, professional, and related occupations, 22 percent; Construction, extraction, maintenance, and repair occupations, 15 percent; and Production, transportation, and material moving occupations, 11 percent. Seventy-seven percent of the people employed were Private wage and salary workers; 19 percent was Federal, state, or local government workers; and 4 percent was Selfemployed in own not incorporated business workers.

TRAVEL TO WORK: Eighty-three percent of Kaunakakai CDP workers drove to work alone in 2005-2009, 8 percent carpooled, 1 percent took public transportation, and 6 percent used other means. The remaining 2 percent worked at home. Among those who commuted to work, it took them on average 12.1 minutes to get to work.

INCOME: The median income of households in Kaunakakai CDP was \$50,360. Seventy-five percent of the households received earnings and 18 percent received retirement income other than Social Security. Twenty-eight percent of the households received Social Security. The average income from Social Security was \$12,823. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 17 percent of people were in poverty. Twenty-one percent of related children under 18 were below the poverty level, compared with 19 percent of people 65 years old and over. Twelve percent of all families and 38 percent of families with a female householder and no husband present had incomes below the poverty level.

Poverty Rates in Kaunakakai CDP, Hawaii in 2005-2009





POPULATION OF Kaunakakai CDP: In 2005-2009, Kaunakakai CDP had a total population of 2,500 - 1,400 (57 percent) females and 1,100 (43 percent) males. The median age was 37.5 years. Twenty-seven percent of the population was under 18 years and 13 percent was 65 years and older.


The Age Distribution of People in Kaunakakai CDP, Hawaii in 2005-2009

For people reporting one race alone, 15 percent was White; 1 percent was Black or African American; 1 percent was American Indian and Alaska Native; 24 percent was Asian; 32 percent was Native Hawaiian and Other Pacific Islander, and 1 percent was Some other race. Twenty-seven percent reported Two or more races. One percent of the people in Kaunakakai CDP was Hispanic. Fifteen percent of the people in Kaunakakai CDP was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Kaunakakai CDP had a total of 990 housing units, 9 percent of which were vacant. Of the total housing units, 85 percent was in single-unit structures, 13 percent was in multi-unit structures, and 2 percent was mobile homes. Ten percent of the housing units were built since 1990.

OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Kaunakakai CDP had 900 occupied housing units - 540 (60 percent) owner occupied and 360 (40 percent) renter occupied. Fourteen percent of the households did not have telephone service and 10 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Thirty-three percent had two vehicles and another 26 percent had three or more.


HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,307, nonmortgaged owners \$356, and renters \$981. Thirty-five percent of owners with mortgages, 13 percent of owners without mortgages, and 50 percent of renters in Kaunakakai CDP spent 30 percent or more of household income on housing.
