
NOTE. Although the American Community Survey (ACS) produces population, demographic and housing unit estimates, it is the Census Bureau's Population Estimates Program that produces and disseminates the official estimates of the population for the nation, states, counties, cities and towns and estimates of housing units for states and counties.

HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 150 households in Kawela Bay CDP. The average household size was 2.3 people.

Families made up 60 percent of the households in Kawela Bay CDP. This figure includes both married-couple families (42 percent) and other families (17 percent). Nonfamily households made up 40 percent of all households in Kawela Bay CDP. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

The Types of Households in Kawela Bay CDP, Hawaii in 2005-2009





NATIVITY AND LANGUAGE: Thirteen percent of the people living in Kawela Bay CDP in 2005-2009 were foreign born. Eighty-seven percent was native, including 28 percent who were born in Hawaii.

Among people at least five years old living in Kawela Bay CDP in 2005-2009, 5 percent spoke a language other than English at home. Of those speaking a language other than English at home, less than 0.5 percent spoke Spanish and 100 percent spoke some other language; 53 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 72 percent of the people at least one year old living in Kawela Bay CDP were living in the same residence one year earlier; 25 percent had moved during the past year from another residence in the same county, less than 0.5 percent from another county in the same state, 3 percent from another state, and less than 0.5 percent from abroad.

Geographic Mobility of Residents of Kawela Bay CDP, Hawaii in 2005-2009



EDUCATION: In 2005-2009, 98 percent of people 25 years and over had at least graduated from high school and 44 percent had a bachelor's degree or higher. Two percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Kawela Bay CDP was 91 in 2005-2009. Nursery school and kindergarten enrollment was 17 and elementary or high school enrollment was 66 children. College or graduate school enrollment was 8.

The Educational Attainment of People in Kawela Bay CDP, Hawaii in 2005-2009






DISABILITY: In Kawela Bay CDP, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Kawela Bay CDP were Educational services, and health care, and social assistance, 21 percent, and Construction, 15 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Management, professional, and related occupations, 51 percent; Sales and office occupations, 21 percent; Service occupations, 13 percent; Construction, extraction, maintenance, and repair occupations, 8 percent; and Production, transportation, and material moving occupations, 5 percent. Seventy percent of the people employed were Private wage and salary workers; 14 percent was Federal, state, or local government workers; and 16 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Sixty-seven percent of Kawela Bay CDP workers drove to work alone in 2005-2009, 20 percent carpooled, 1 percent took public transportation, and 7 percent used other means. The remaining 5 percent worked at home. Among those who commuted to work, it took them on average 35 minutes to get to work.

INCOME: The median income of households in Kawela Bay CDP was \$74,250. Eighty-five percent of the households received earnings and 22 percent received retirement income other than Social Security. Twenty percent of the households received Social Security. The average income from Social Security was \$15,137. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 2 percent of people were in poverty. Four percent of related children under 18 were below the poverty level, compared with less than 0.5 percent of people 65 years old and over. Two percent of all families and 9 percent of families with a female householder and no husband present had incomes below the poverty level.

Poverty Rates in Kawela Bay CDP, Hawaii in 2005-2009





POPULATION OF Kawela Bay CDP: In 2005-2009, Kawela Bay CDP had a total population of 340 - 180 (54 percent) females and 160 (46 percent) males. The median age was 43.9 years. Twenty-four percent of the population was under 18 years and 16 percent was 65 years and older.

The Age Distribution of People in Kawela Bay CDP, Hawaii in 2005-2009



For people reporting one race alone, 79 percent was White; 1 percent was Black or African American; 3 percent was American Indian and Alaska Native; 4 percent was Asian; 1 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Twelve percent reported Two or more races. Two percent of the people in Kawela Bay CDP was Hispanic. Seventy-seven percent of the people in Kawela Bay CDP was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Kawela Bay CDP had a total of 410 housing units, 64 percent of which were vacant. Of the total housing units, 18 percent was in single-unit structures, 82 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Seven percent of the housing units were built since 1990.

The Types of Housing Units in Kawela Bay CDP, Hawaii in 2005-2009





OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Kawela Bay CDP had 150 occupied housing units - 84 (56 percent) owner occupied and 65 (44 percent) renter occupied. Seven percent of the households did not have telephone service and 3 percent of the households did not have access to a car, truck, or van for private use. Forty percent had two vehicles and another 5 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$2,188, nonmortgaged owners \$693, and renters \$1,417. Twenty-five percent of owners with mortgages, 31 percent of owners without mortgages, and 35 percent of renters in Kawela Bay CDP spent 30 percent or more of household income on housing.
