
NOTE. Although the American Community Survey (ACS) produces population, demographic and housing unit estimates, it is the Census Bureau's Population Estimates Program that produces and disseminates the official estimates of the population for the nation, states, counties, cities and towns and estimates of housing units for states and counties.

HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 1,200 households in Kekaha CDP. The average household size was 2.7 people.

Families made up 70 percent of the households in Kekaha CDP. This figure includes both married-couple families (48 percent) and other families (22 percent). Nonfamily households made up 30 percent of all households in Kekaha CDP. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.


NATIVITY AND LANGUAGE: Thirteen percent of the people living in Kekaha CDP in 2005-2009 were foreign born. Eighty-seven percent was native, including 66 percent who were born in Hawaii.

Among people at least five years old living in Kekaha CDP in 2005-2009, 19 percent spoke a language other than English at home. Of those speaking a language other than English at home, 4 percent spoke Spanish and 96 percent spoke some other language; 21 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 92 percent of the people at least one year old living in Kekaha CDP were living in the same residence one year earlier; 7 percent had moved during the past year from another residence in the same county, less than 0.5 percent from another county in the same state, 1 percent from another state, and less than 0.5 percent from abroad.



EDUCATION: In 2005-2009, 85 percent of people 25 years and over had at least graduated from high school and 15 percent had a bachelor's degree or higher. Sixteen percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Kekaha CDP was 690 in 2005-2009. Nursery school and kindergarten enrollment was 53 and elementary or high school enrollment was 510 children. College or graduate school enrollment was 130.

The Educational Attainment of People in Kekaha CDP, Hawaii in 2005-2009






DISABILITY: In Kekaha CDP, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Kekaha CDP were Educational services, and health care, and social assistance, 20 percent, and Arts, entertainment, and recreation, and accommodation and food services, 14 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Management, professional, and related occupations, 30 percent; Service occupations, 29 percent; Sales and office occupations, 20 percent; Construction, extraction, maintenance, and repair occupations, 10 percent; and Production, transportation, and material moving occupations, 8 percent. Seventy-two percent of the people employed were Private wage and salary workers; 22 percent was Federal, state, or local government workers; and 5 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Eighty-one percent of Kekaha CDP workers drove to work alone in 2005-2009, 13 percent carpooled, less than 0.5 percent took public transportation, and 5 percent used other means. The remaining less than 0.5 percent worked at home. Among those who commuted to work, it took them on average 22.5 minutes to get to work.

INCOME: The median income of households in Kekaha CDP was \$56,729. Seventy-seven percent of the households received earnings and 19 percent received retirement income other than Social Security. Thirty-four percent of the households received Social Security. The average income from Social Security was \$12,674. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 10 percent of people were in poverty. Five percent of related children under 18 were below the poverty level, compared with 6 percent of people 65 years old and over. Fifteen percent of all families and 18 percent of families with a female householder and no husband present had incomes below the poverty level.

Poverty Rates in Kekaha CDP, Hawaii in 2005-2009




Percent below poverty level

POPULATION OF Kekaha CDP: In 2005-2009, Kekaha CDP had a total population of 3,100 - 1,500 (49 percent) females and 1,600 (51 percent) males. The median age was 40.6 years. Twenty-three percent of the population was under 18 years and 15 percent was 65 years and older.

The Age Distribution of People in Kekaha CDP, Hawaii in 2005-2009





For people reporting one race alone, 25 percent was White; less than 0.5 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; 32 percent was Asian; 32 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Eleven percent reported Two or more races. Nine percent of the people in Kekaha CDP was Hispanic. Twenty-three percent of the people in Kekaha CDP was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Kekaha CDP had a total of 1,400 housing units, 14 percent of which were vacant. Of the total housing units, 85 percent was in single-unit structures, 14 percent was in multi-unit structures, and 1 percent was mobile homes. Fourteen percent of the housing units were built since 1990.

OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Kekaha CDP had 1,200 occupied housing units - 770 (66 percent) owner occupied and 410 (34 percent) renter occupied. Eleven percent of the households did not have telephone service and 2 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Forty-two percent had two vehicles and another 25 percent had three or more.


HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,753, nonmortgaged owners \$313, and renters \$981. Forty-four percent of owners with mortgages, 27 percent of owners without mortgages, and 34 percent of renters in Kekaha CDP spent 30 percent or more of household income on housing.
