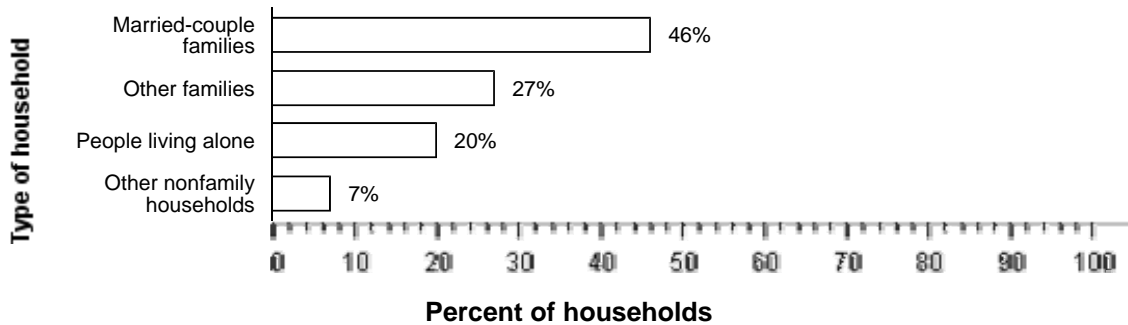
NOTE. HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 750 households in Koloa CDP. The average household size was 3.1 people.

Families made up 73 percent of the households in Koloa CDP. This figure includes both married-couple families (46 percent) and other families (27 percent). Nonfamily households made up 27 percent of all households in Koloa CDP. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

The Types of Households in Koloa CDP, Hawaii in 2005-2009



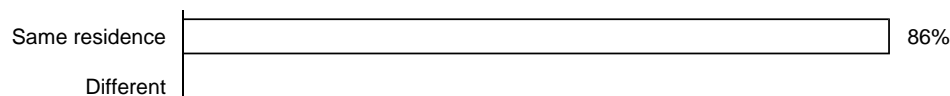

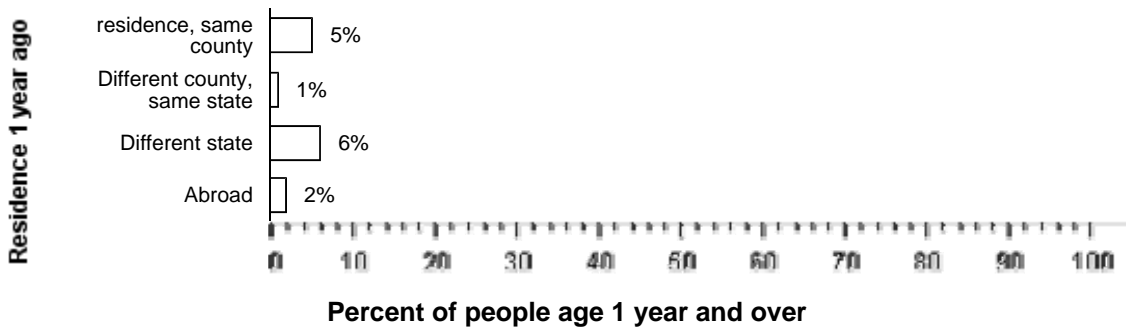
NATIVITY AND LANGUAGE: Seventeen percent of the people living in Koloa CDP in 2005-2009 were foreign born. Eighty-three percent was native, including 63 percent who were born in Hawaii.

Among people at least five years old living in Koloa CDP in 2005-2009, 30 percent spoke a language other than English at home. Of those speaking a language other than English at home, 6 percent spoke Spanish and 94 percent spoke some other language; 47 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 86 percent of the people at least one year old living in Koloa CDP were living in the same residence one year earlier; 5 percent had moved during the past year from another residence in the same county, 1 percent from another county in the same state, 6 percent from another state, and 2 percent from abroad.

Geographic Mobility of Residents of Koloa CDP, Hawaii in 2005-2009



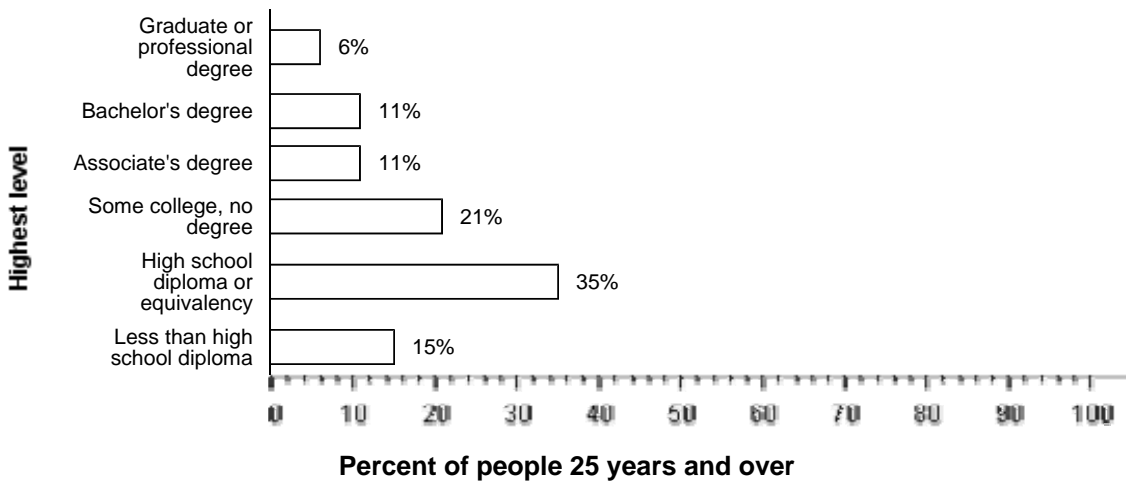

EDUCATION: In 2005-2009, 85 percent of people 25 years and over had at least graduated from high school and 17 percent had a bachelor's degree or higher. Fifteen percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Koloa CDP was 410 in 2005-2009. Nursery school and kindergarten enrollment was 22 and elementary or high school enrollment was 280 children. College or graduate school enrollment was 110.

The Educational Attainment of People in Koloa CDP, Hawaii in 2005-2009

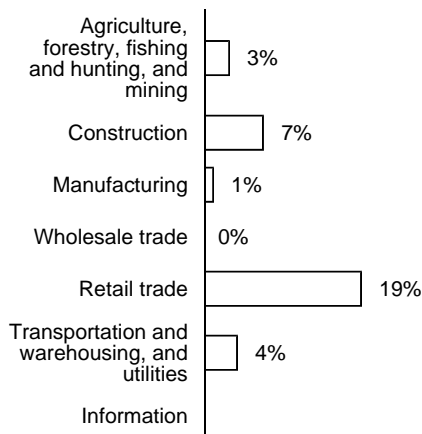


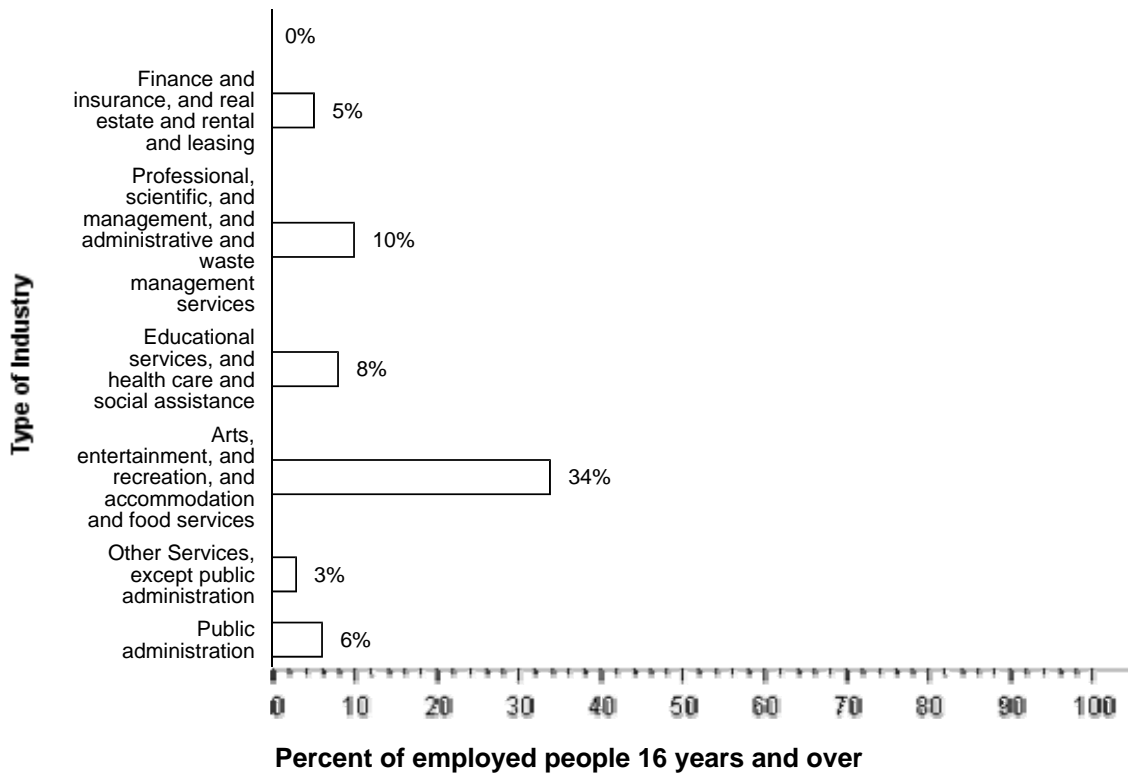

DISABILITY: In Koloa CDP, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Koloa CDP were Arts, entertainment, and recreation, and accommodation and food services, 34 percent, and Retail trade, 19 percent.

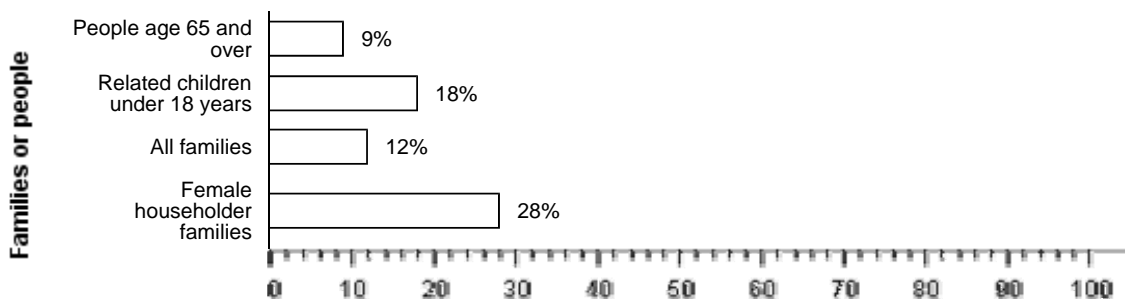
OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Service occupations, 36 percent; Sales and office occupations, 24 percent; Management, professional, and related occupations, 21 percent; Construction, extraction, maintenance, and repair occupations, 9 percent; and Production, transportation, and material moving occupations, 8 percent. Eighty-four percent of the people employed were Private wage and salary workers; 11 percent was Federal, state, or local government workers; and 6 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Seventy-one percent of Koloa CDP workers drove to work alone in 2005-2009, 16 percent carpooled, 1 percent took public transportation, and 8 percent used other means. The remaining 5 percent worked at home. Among those who commuted to work, it took them on average 16.3 minutes to get to work.

INCOME: The median income of households in Koloa CDP was \$55,219. Seventy-seven percent of the households received earnings and 21 percent received retirement income other than Social Security. Thirty-seven percent of the households received Social Security. The average income from Social Security was \$15,222. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 13 percent of people were in poverty. Eighteen percent of related children under 18 were below the poverty level, compared with 9 percent of people 65 years old and over. Twelve percent of all families and 28 percent of families with a female householder and no husband present had incomes below the poverty level.

Poverty Rates in Koloa CDP, Hawaii in 2005-2009

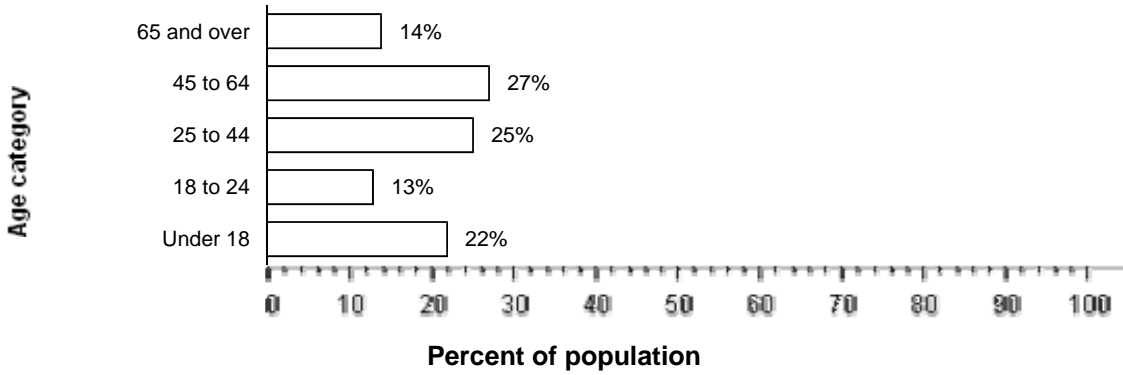


Percent below poverty level

POPULATION OF Koloa CDP: In 2005-2009, Koloa CDP had a total population of 2,300 - 1,200 (53 percent) females and 1,100 (47 percent) males. The median age was 34.8 years. Twenty-two percent of the population was under 18 years and 14 percent was 65 years and older.

The Age Distribution of People in Koloa CDP, Hawaii in 2005-2009

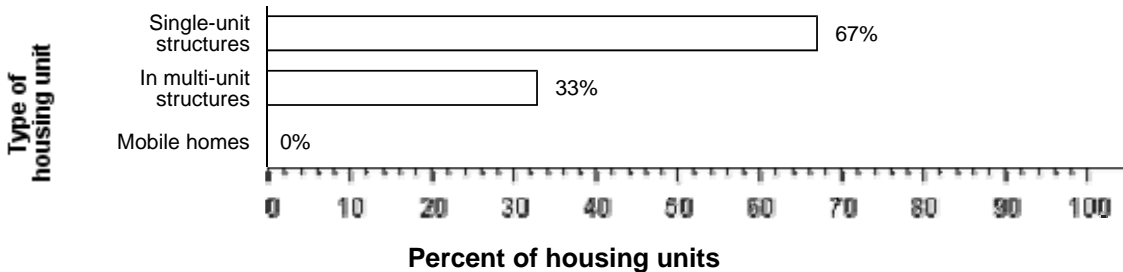

For people reporting one race alone, 22 percent was White; 1 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; 38 percent was Asian; 12 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Twenty-seven percent reported Two or more races. Fourteen percent of the people in Koloa CDP was Hispanic. Nineteen percent of the people in Koloa CDP was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Koloa CDP had a total of 830 housing units, 11 percent of which were vacant. Of the total housing units, 67 percent was in single-unit structures, 33 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Twenty-one percent of the housing units were built since 1990.

The Types of Housing Units in Koloa CDP, Hawaii in 2005-2009

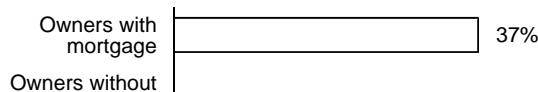


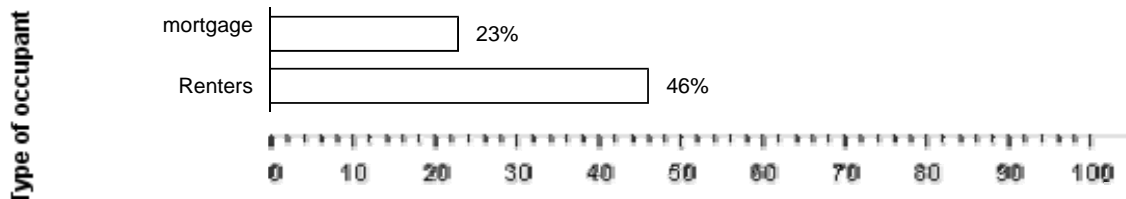

OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Koloa CDP had 750 occupied housing units - 360 (48 percent) owner occupied and 390 (52 percent) renter occupied. Eight percent of the households did not have telephone service and 11 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Thirty-six percent had two vehicles and another 29 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,667, nonmortgaged owners \$395, and renters \$892. Thirty-seven percent of owners with mortgages, 23 percent of owners without mortgages, and 46 percent of renters in Koloa CDP spent 30 percent or more of household income on housing.
