
NOTE. Although the American Community Survey (ACS) produces population, demographic and housing unit estimates, it is the Census Bureau's Population Estimates Program that produces and disseminates the official estimates of the population for the nation, states, counties, cities and towns and estimates of housing units for states and counties.

HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 370 households in Kurtistown CDP. The average household size was 2.8 people.

Families made up 70 percent of the households in Kurtistown CDP. This figure includes both married-couple families (52 percent) and other families (17 percent). Nonfamily households made up 30 percent of all households in Kurtistown CDP. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.


NATIVITY AND LANGUAGE: Eight percent of the people living in Kurtistown CDP in 2005-2009 were foreign born. Ninety-two percent was native, including 74 percent who were born in Hawaii.

Among people at least five years old living in Kurtistown CDP in 2005-2009, 21 percent spoke a language other than English at home. Of those speaking a language other than English at home, less than 0.5 percent spoke Spanish and 100 percent spoke some other language; 37 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 96 percent of the people at least one year old living in Kurtistown CDP were living in the same residence one year earlier; 3 percent had moved during the past year from another residence in the same county, 1 percent from another county in the same state, less than 0.5 percent from another state, and less than 0.5 percent from abroad.



EDUCATION: In 2005-2009, 89 percent of people 25 years and over had at least graduated from high school and 28 percent had a bachelor's degree or higher. Eleven percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Kurtistown CDP was 260 in 2005-2009. Nursery school and kindergarten enrollment was 10 and elementary or high school enrollment was 140 children. College or graduate school enrollment was 110.

The Educational Attainment of People in Kurtistown CDP, Hawaii in 2005-2009






DISABILITY: In Kurtistown CDP, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Kurtistown CDP were Educational services, and health care, and social assistance, 27 percent, and Agriculture, forestry, fishing and hunting, and mining, 19 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Management, professional, and related occupations, 39 percent; Service occupations, 22 percent; Sales and office occupations, 21 percent; Production, transportation, and material moving occupations, 7 percent; and Farming, fishing, and forestry occupations, 6 percent. Fifty-eight percent of the people employed were Private wage and salary workers; 29 percent was Federal, state, or local government workers; and 13 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Sixty-eight percent of Kurtistown CDP workers drove to work alone in 2005-2009, 15 percent carpooled, less than 0.5 percent took public transportation, and 4 percent used other means. The remaining 13 percent worked at home. Among those who commuted to work, it took them on average 22.4 minutes to get to work.

INCOME: The median income of households in Kurtistown CDP was \$54,250. Eighty percent of the households received earnings and 28 percent received retirement income other than Social Security. Thirty-three percent of the households received Social Security. The average income from Social Security was \$15,742. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 7 percent of people were in poverty. Eight percent of related children under 18 were below the poverty level, compared with 7 percent of people 65 years old and over. Two percent of all families and 12 percent of families with a female householder and no husband present had incomes below the poverty level.

Poverty Rates in Kurtistown CDP, Hawaii in 2005-2009




Percent below poverty level

POPULATION OF Kurtistown CDP: In 2005-2009, Kurtistown CDP had a total population of 1,100 - 480 (45 percent) females and 580 (55 percent) males. The median age was 43.5 years. Twenty-one percent of the population was under 18 years and 14 percent was 65 years and older.



For people reporting one race alone, 31 percent was White; less than 0.5 percent was Black or African American; 1 percent was American Indian and Alaska Native; 38 percent was Asian; 5 percent was Native Hawaiian and Other Pacific Islander, and 1 percent was Some other race. Twenty-four percent reported Two or more races. Three percent of the people in Kurtistown CDP was Hispanic. Twenty-eight percent of the people in Kurtistown CDP was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Kurtistown CDP had a total of 450 housing units, 16 percent of which were vacant. Of the total housing units, 99 percent was in single-unit structures, 1 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Nineteen percent of the housing units were built since 1990.


OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Kurtistown CDP had 370 occupied housing units - 250 (66 percent) owner occupied and 130 (34 percent) renter occupied. Three percent of the households did not have telephone service and 6 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Forty percent had two vehicles and another 31 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,186, nonmortgaged owners \$279, and renters \$663. Twenty-five percent of owners with mortgages, 4 percent of owners without mortgages, and 59 percent of renters in Kurtistown CDP spent 30 percent or more of household income on housing.
