

NOTE. HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 9,200 households in Mililani Town CDP. The average household size was 3 people.

Families made up 84 percent of the households in Mililani Town CDP. This figure includes both married-couple families (65 percent) and other families (19 percent). Nonfamily households made up 16 percent of all households in Mililani Town CDP. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

NATIVITY AND LANGUAGE: Eleven percent of the people living in Mililani Town CDP in 2005-2009 were foreign born. Eighty-nine percent was native, including 62 percent who were born in Hawaii.

Among people at least five years old living in Mililani Town CDP in 2005-2009, 17 percent spoke a language other than English at home. Of those speaking a language other than English at home, 10 percent spoke Spanish and 90 percent spoke some other language; 33 percent reported that they did not speak English "very well."


GEOGRAPHIC MOBILITY: In 2005-2009, 86 percent of the people at least one year old living in Mililani Town CDP were living in the same residence one year earlier; 9 percent had moved during the past year from another residence in the same county, less than 0.5 percent from another county in the same state, 4 percent from another state, and 1 percent from abroad.



EDUCATION: In 2005-2009, 95 percent of people 25 years and over had at least graduated from high school and 33 percent had a bachelor's degree or higher. Five percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Mililani Town CDP was 7,400 in 2005-2009. Nursery school and kindergarten enrollment was 600 and elementary or high school enrollment was 4,700 children. College or graduate school enrollment was 2,100.




The Educational Attainment of People in Mililani Town CDP, Hawaii in 2005-2009



DISABILITY: In Mililani Town CDP, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Mililani Town CDP were Educational services, and health care, and social assistance, 22 percent, and Public administration, 12 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Management, professional, and related occupations, 39 percent; Sales and office occupations, 28 percent; Service occupations, 17 percent; Construction, extraction, maintenance, and repair occupations, 9 percent; and Production, transportation, and material moving occupations, 7 percent. Sixty-eight percent of the people employed were Private wage and salary workers; 26 percent was Federal, state, or local government workers; and 5 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Seventy-eight percent of Mililani Town CDP workers drove to work alone in 2005-2009, 14 percent carpooled, 3 percent took public transportation, and 3 percent used other means. The remaining 2 percent worked at home. Among those who commuted to work, it took them on average 31.3 minutes to get to work.

INCOME: The median income of households in Mililani Town CDP was \$90,109. Ninety percent of the households received earnings and 30 percent received retirement income other than Social Security. Twenty-six percent of the households received Social Security. The average income from Social Security was \$16,155. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 3 percent of people were in poverty. Four percent of related children under 18 were below the poverty level, compared with 2 percent of people 65 years old and over. Three percent of all families and 16 percent of families with a female householder and no husband present had incomes below the poverty level.

Poverty Rates in Mililani Town CDP, Hawaii in 2005-2009





POPULATION OF Mililani Town CDP: In 2005-2009, Mililani Town CDP had a total population of 28,000 - 14,000 (50 percent) females and 14,000 (50 percent) males. The median age was 37.6 years. Twenty-three percent of the population was under 18 years and 11 percent was 65 years and older.

For people reporting one race alone, 18 percent was White; 5 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; 45 percent was Asian; 6 percent was Native Hawaiian and Other Pacific Islander, and 1 percent was Some other race. Twenty-five percent reported Two or more races. Eight percent of the people in Mililani Town CDP was Hispanic. Seventeen percent of the people in Mililani Town CDP was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Mililani Town CDP had a total of 9,400 housing units, 2 percent of which were vacant. Of the total housing units, 71 percent was in single-unit structures, 29 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Six percent of the housing units were built since 1990.


OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Mililani Town CDP had 9,200 occupied housing units - 7,000 (77 percent) owner occupied and 2,100 (23 percent) renter occupied. Two percent of the households did not have telephone service and 3 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Forty-seven percent had two vehicles and another 30 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$2,151, nonmortgaged owners \$439, and renters \$1,822. Forty-two percent of owners with mortgages, 5 percent of owners without mortgages, and 59 percent of renters in Mililani Town CDP spent 30 percent or more of household income on housing.
