



NOTE. Although the American Community Survey (ACS) produces population, demographic and housing unit estimates, it is the Census Bureau's Population Estimates Program that produces and disseminates the official estimates of the population for the nation, states, counties, cities and towns and estimates of housing units for states and counties.

HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 240 households in Pahoa CDP. The average household size was 3.2 people.

Families made up 68 percent of the households in Pahoa CDP. This figure includes both marriedcouple families (47 percent) and other families (21 percent). Nonfamily households made up 32 percent of all households in Pahoa CDP. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

NATIVITY AND LANGUAGE: Forty-one percent of the people living in Pahoa CDP in 2005-2009 were foreign born. Fifty-nine percent was native, including 46 percent who were born in Hawaii.

Among people at least five years old living in Pahoa CDP in 2005-2009, 55 percent spoke a language other than English at home. Of those speaking a language other than English at home, 4 percent spoke Spanish and 96 percent spoke some other language; 61 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 91 percent of the people at least one year old living in Pahoa CDP were living in the same residence one year earlier; 4 percent had moved during the past year from another residence in the same county, 1 percent from another county in the same state, 4 percent from another state, and less than 0.5 percent from abroad.


Geographic Mobility of Residents of Pahoa CDP, Hawaii in 2005-2009



EDUCATION: In 2005-2009, 77 percent of people 25 years and over had at least graduated from high school and 14 percent had a bachelor's degree or higher. Twenty-three percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Pahoa CDP was 130 in 2005-2009. Nursery school and kindergarten enrollment was 18 and elementary or high school enrollment was 70 children. College or graduate school enrollment was 37.




The Educational Attainment of People in Pahoa CDP, Hawaii in 2005-2009



DISABILITY: In Pahoa CDP, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Pahoa CDP were Agriculture, forestry, fishing and hunting, and mining, 35 percent, and Educational services, and health care, and social assistance, 16 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Management, professional, and related occupations, 31 percent; Farming, fishing, and forestry occupations, 26 percent; Sales and office occupations, 17 percent; Service occupations, 16 percent; and Construction, extraction, maintenance, and repair occupations, 5 percent. Seventy percent of the people employed were Private wage and salary workers; 16 percent was Federal, state, or local government workers; and 14 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Sixty-three percent of Pahoa CDP workers drove to work alone in 2005-2009, 27 percent carpooled, 5 percent took public transportation, and 1 percent used other means. The remaining 5 percent worked at home. Among those who commuted to work, it took them on average 37 minutes to get to work.

INCOME: The median income of households in Pahoa CDP was \$58,000. Eighty-four percent of the households received earnings and 38 percent received retirement income other than Social Security. Fifty-two percent of the households received Social Security. The average income from Social Security was \$13,440. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 9 percent of people were in poverty. Sixteen percent of related children under 18 were below the poverty level, compared with 11 percent of people 65 years old and over. Eight percent of all families and 21 percent of families with a female householder and no husband present had incomes below the poverty level.

Poverty Rates in Pahoa CDP, Hawaii in 2005-2009





POPULATION OF Pahoa CDP: In 2005-2009, Pahoa CDP had a total population of 760 - 380 (49 percent) females and 390 (51 percent) males. The median age was 45.2 years. Nineteen percent of the population was under 18 years and 20 percent was 65 years and older.


The Age Distribution of People in Pahoa CDP, Hawaii in 2005-2009

For people reporting one race alone, 9 percent was White; less than 0.5 percent was Black or African American; 1 percent was American Indian and Alaska Native; 62 percent was Asian; 7 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Twenty percent reported Two or more races. Eleven percent of the people in Pahoa CDP was Hispanic. Seven percent of the people in Pahoa CDP was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Pahoa CDP had a total of 330 housing units, 27 percent of which were vacant. Of the total housing units, 90 percent was in single-unit structures, 10 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Nine percent of the housing units were built since 1990.


OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Pahoa CDP had 240 occupied housing units - 190 (76 percent) owner occupied and 57 (24 percent) renter occupied. Four percent of the households did not have telephone service and 6 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Twenty-four percent had two vehicles and another 42 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,267, nonmortgaged owners \$353, and renters \$665. Twenty-nine percent of owners with mortgages, less than 0.5 percent of owners without mortgages, and 46 percent of renters in Pahoa CDP spent 30 percent or more of household income on housing.
