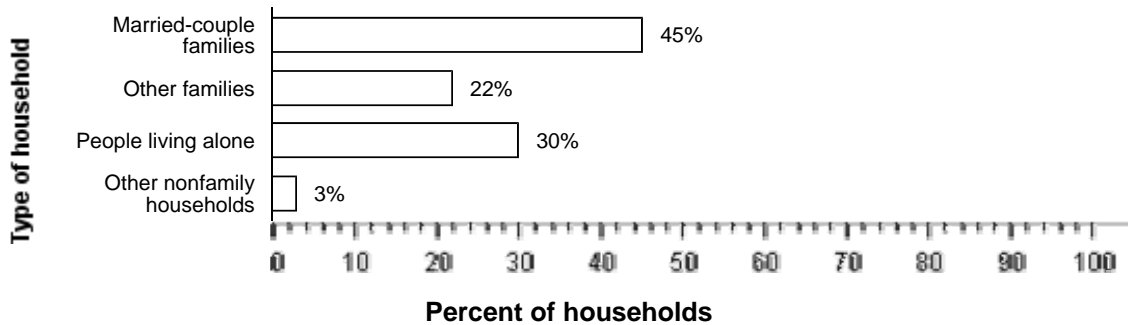
NOTE. **HOUSEHOLDS AND FAMILIES:** In 2005-2009 there were 220 households in Paukaa CDP. The average household size was 2.4 people.

Families made up 67 percent of the households in Paukaa CDP. This figure includes both married-couple families (45 percent) and other families (22 percent). Nonfamily households made up 33 percent of all households in Paukaa CDP. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

**The Types of Households in Paukaa CDP, Hawaii in 2005-2009**



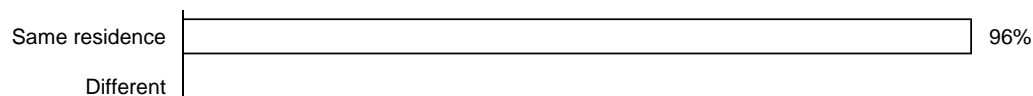

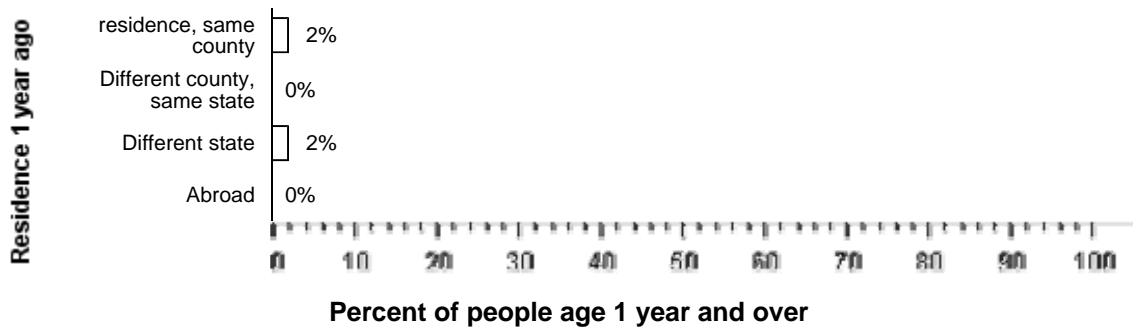
**NATIVITY AND LANGUAGE:** Nine percent of the people living in Paukaa CDP in 2005-2009 were foreign born. Ninety-one percent was native, including 63 percent who were born in Hawaii.

Among people at least five years old living in Paukaa CDP in 2005-2009, 10 percent spoke a language other than English at home. Of those speaking a language other than English at home, less than 0.5 percent spoke Spanish and 100 percent spoke some other language; 30 percent reported that they did not speak English "very well."

**GEOGRAPHIC MOBILITY:** In 2005-2009, 96 percent of the people at least one year old living in Paukaa CDP were living in the same residence one year earlier; 2 percent had moved during the past year from another residence in the same county, less than 0.5 percent from another county in the same state, 2 percent from another state, and less than 0.5 percent from abroad.

**Geographic Mobility of Residents of Paukaa CDP, Hawaii in 2005-2009**



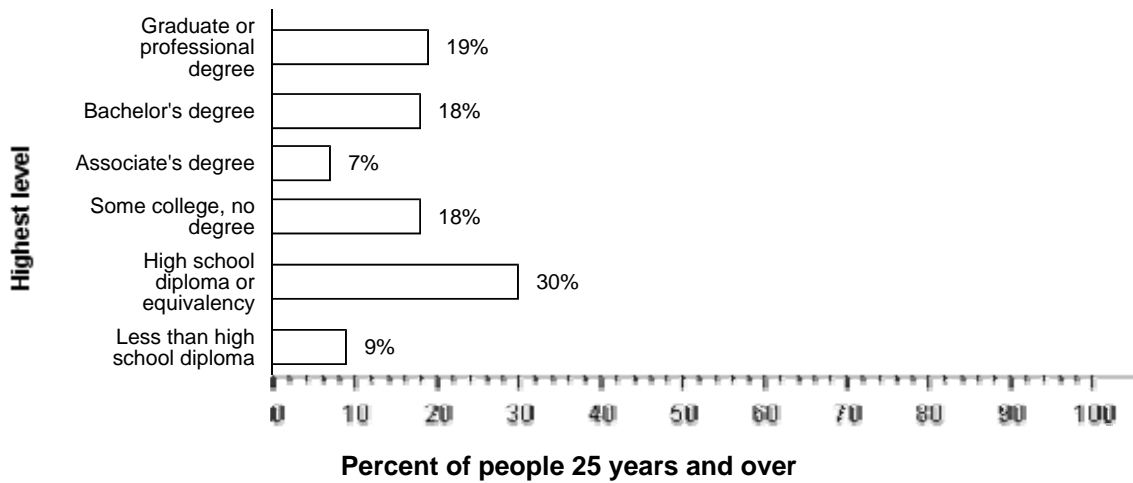

**EDUCATION:** In 2005-2009, 91 percent of people 25 years and over had at least graduated from high school and 37 percent had a bachelor's degree or higher. Nine percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Paukaa CDP was 71 in 2005-2009. Nursery school and kindergarten enrollment was 3 and elementary or high school enrollment was 42 children. College or graduate school enrollment was 26.

**The Educational Attainment of People in Paukaa CDP, Hawaii in 2005-2009**

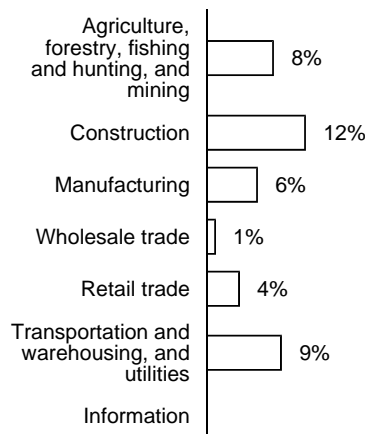


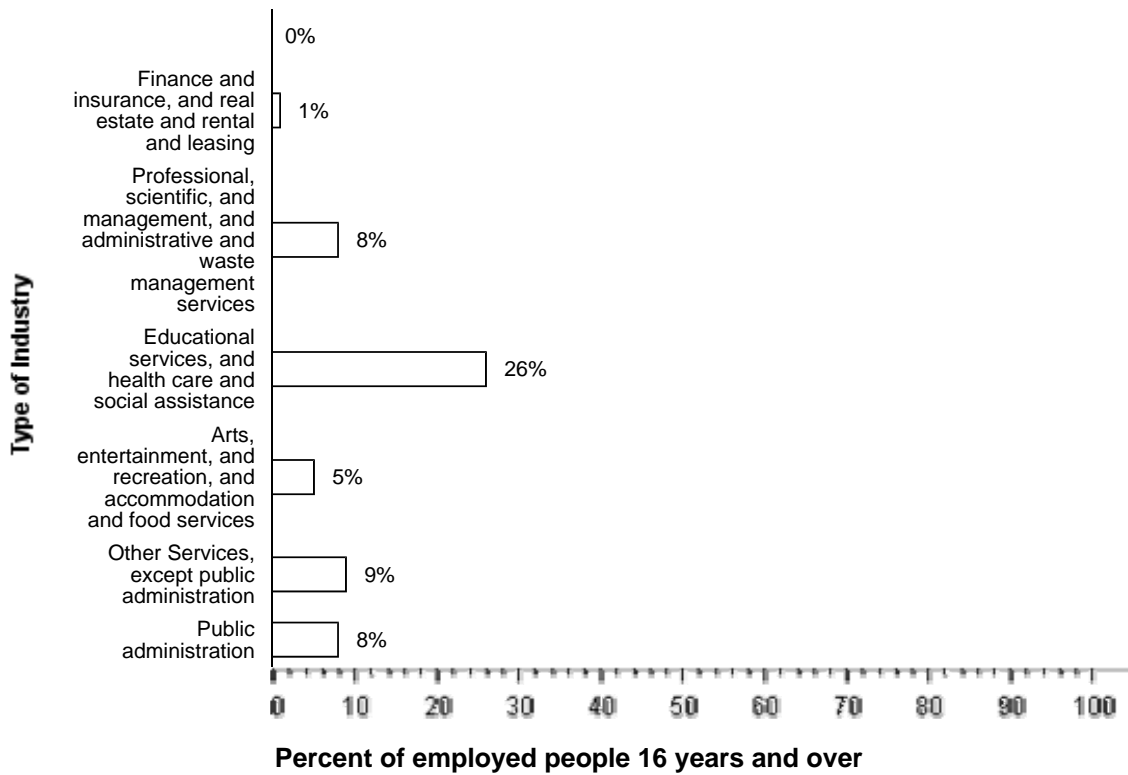

**DISABILITY:** In Paukaa CDP, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

**INDUSTRIES:** In 2005-2009, for the employed population 16 years and older, the leading industries in Paukaa CDP were Educational services, and health care, and social assistance, 26 percent, and Construction, 12 percent.

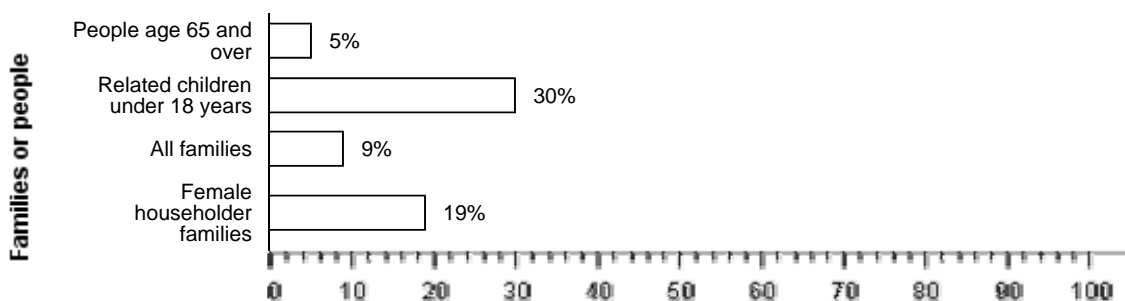
**OCCUPATIONS AND TYPE OF EMPLOYER:** Among the most common occupations were: Management, professional, and related occupations, 45 percent; Sales and office occupations, 27 percent; Service occupations, 10 percent; Farming, fishing, and forestry occupations, 8 percent; and Construction, extraction, maintenance, and repair occupations, 7 percent. Fifty-eight percent of the people employed were Private wage and salary workers; 27 percent was Federal, state, or local government workers; and 15 percent was Self-employed in own not incorporated business workers.

**TRAVEL TO WORK:** Seventy percent of Paukaa CDP workers drove to work alone in 2005-2009, 22 percent carpooled, less than 0.5 percent took public transportation, and less than 0.5 percent used other means. The remaining 8 percent worked at home. Among those who commuted to work, it took them on average 21.6 minutes to get to work.

**INCOME:** The median income of households in Paukaa CDP was \$50,455. Sixty-seven percent of the households received earnings and 30 percent received retirement income other than Social Security. Forty-two percent of the households received Social Security. The average income from Social Security was \$16,868. These income sources are not mutually exclusive; that is, some households received income from more than one source.

**POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS:** In 2005-2009, 14 percent of people were in poverty. Thirty percent of related children under 18 were below the poverty level, compared with 5 percent of people 65 years old and over. Nine percent of all families and 19 percent of families with a female householder and no husband present had incomes below the poverty level.

Poverty Rates in Paukaa CDP, Hawaii in 2005-2009

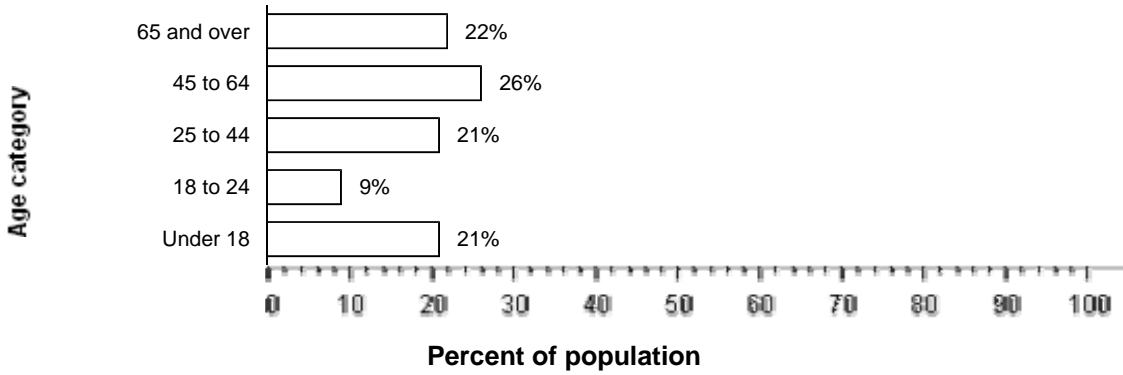


**Percent below poverty level**

POPULATION OF Paukaa CDP: In 2005-2009, Paukaa CDP had a total population of 520 - 260 (49 percent) females and 270 (51 percent) males. The median age was 42.8 years. Twenty-one percent of the population was under 18 years and 22 percent was 65 years and older.

**The Age Distribution of People in Paukaa CDP, Hawaii in 2005-2009**

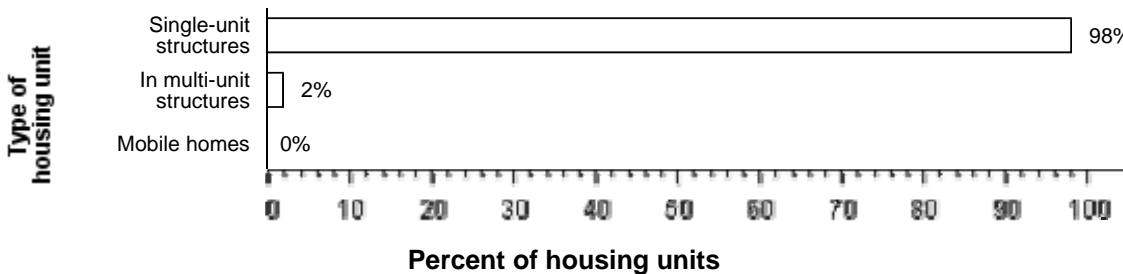

For people reporting one race alone, 48 percent was White; less than 0.5 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; 28 percent was Asian; 8 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Sixteen percent reported Two or more races. Three percent of the people in Paukaa CDP was Hispanic. Forty-five percent of the people in Paukaa CDP was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Paukaa CDP had a total of 220 housing units, less than 0.5 percent of which were vacant. Of the total housing units, 98 percent was in single-unit structures, 2 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Nine percent of the housing units were built since 1990.

**The Types of Housing Units in Paukaa CDP, Hawaii in 2005-2009**

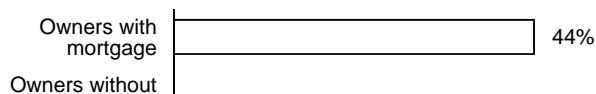


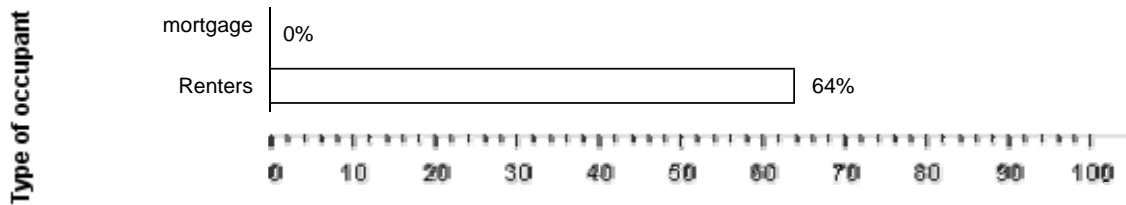

OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Paukaa CDP had 220 occupied housing units - 170 (76 percent) owner occupied and 53 (24 percent) renter occupied. Less than 0.5 percent of the households did not have telephone service and 4 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Thirty-nine percent had two vehicles and another 15 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,688, nonmortgaged owners \$281, and renters \$850. Forty-four percent of owners with mortgages, less than 0.5 percent of owners without mortgages, and 64 percent of renters in Paukaa CDP spent 30 percent or more of household income on housing.
