
NOTE. Although the American Community Survey (ACS) produces population, demographic and housing unit estimates, it is the Census Bureau's Population Estimates Program that produces and disseminates the official estimates of the population for the nation, states, counties, cities and towns and estimates of housing units for states and counties.

HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 350 households in Puhi CDP. The average household size was 3.5 people.

Families made up 89 percent of the households in Puhi CDP. This figure includes both married-couple families (74 percent) and other families (15 percent). Nonfamily households made up 11 percent of all households in Puhi CDP. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.


NATIVITY AND LANGUAGE: Twenty-eight percent of the people living in Puhi CDP in 2005-2009 were foreign born. Seventy-two percent was native, including 59 percent who were born in Hawaii.

Among people at least five years old living in Puhi CDP in 2005-2009, 31 percent spoke a language other than English at home. Of those speaking a language other than English at home, 1 percent spoke Spanish and 99 percent spoke some other language; 59 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 95 percent of the people at least one year old living in Puhi CDP were living in the same residence one year earlier; 3 percent had moved during the past year from another residence in the same county, less than 0.5 percent from another county in the same state, 2 percent from another state, and less than 0.5 percent from abroad.



EDUCATION: In 2005-2009, 82 percent of people 25 years and over had at least graduated from high school and 15 percent had a bachelor's degree or higher. Eighteen percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Puhi CDP was 260 in 2005-2009. Nursery school and kindergarten enrollment was 35 and elementary or high school enrollment was 190 children. College or graduate school enrollment was 34.

### The Educational Attainment of People in Puhi CDP, Hawaii in 2005-2009






DISABILITY: In Puhi CDP, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Puhi CDP were Arts, entertainment, and recreation, and accommodation and food services, 20 percent, and Retail trade, 18 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Service occupations, 27 percent; Sales and office occupations, 27 percent; Management, professional, and related occupations, 20 percent; Construction, extraction, maintenance, and repair occupations, 15 percent; and Production, transportation, and material moving occupations, 10 percent. Seventy-eight percent of the people employed were Private wage and salary workers; 14 percent was Federal, state, or local government workers; and 8 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Seventy-eight percent of Puhi CDP workers drove to work alone in 2005-2009, 10 percent carpooled, 2 percent took public transportation, and 6 percent used other means. The remaining 4 percent worked at home. Among those who commuted to work, it took them on average 13.2 minutes to get to work.

INCOME: The median income of households in Puhi CDP was \$84,853. Ninety-seven percent of the households received earnings and 35 percent received retirement income other than Social Security. Forty percent of the households received Social Security. The average income from Social Security was \$14,010. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 3 percent of people were in poverty. Less than 0.5 percent of related children under 18 were below the poverty level, compared with 4 percent of people 65 years old and over. Less than 0.5 percent of all families and less than 0.5 percent of families with a female householder and no husband present had incomes below the poverty level.






#### Percent below poverty level

POPULATION OF Puhi CDP: In 2005-2009, Puhi CDP had a total population of 1,200 - 610 (49 percent) females and 630 (51 percent) males. The median age was 45.4 years. Twenty percent of the population was under 18 years and 15 percent was 65 years and older.

## The Age Distribution of People in Puhi CDP, Hawaii in 2005-2009



For people reporting one race alone, 15 percent was White; less than 0.5 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; 64 percent was Asian; 3 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Seventeen percent reported Two or more races. Seven percent of the people in Puhi CDP was Hispanic. Thirteen percent of the people in Puhi CDP was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Puhi CDP had a total of 350 housing units, less than 0.5 percent of which were vacant. Of the total housing units, 91 percent was in single-unit structures, 9 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Twenty-three percent of the housing units were built since 1990.


OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Puhi CDP had 350 occupied housing units - 300 (85 percent) owner occupied and 52 (15 percent) renter occupied. One percent of the households did not have telephone service and 1 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Forty-seven percent had two vehicles and another 39 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,717, nonmortgaged owners \$416, and renters \$1,214. Forty-four percent of owners with mortgages, less than 0.5 percent of owners without mortgages, and 8 percent of renters in Puhi CDP spent 30 percent or more of household income on housing.
