
NOTE. Although the American Community Survey (ACS) produces population, demographic and housing unit estimates, it is the Census Bureau's Population Estimates Program that produces and disseminates the official estimates of the population for the nation, states, counties, cities and towns and estimates of housing units for states and counties.

HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 63,000 households in Hawaii County. The average household size was 2.7 people.

Families made up 69 percent of the households in Hawaii County. This figure includes both married-couple families (49 percent) and other families (20 percent). Nonfamily households made up 31 percent of all households in Hawaii County. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.


NATIVITY AND LANGUAGE: Eleven percent of the people living in Hawaii County in 2005-2009 were foreign born. Eighty-nine percent was native, including 58 percent who were born in Hawaii.

Among people at least five years old living in Hawaii County in 2005-2009, 18 percent spoke a language other than English at home. Of those speaking a language other than English at home, 16 percent spoke Spanish and 84 percent spoke some other language; 37 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 86 percent of the people at least one year old living in Hawaii County were living in the same residence one year earlier; 9 percent had moved during the past year from another residence in the same county, 1 percent from another county in the same state, 4 percent from another state, and 1 percent from abroad.



EDUCATION: In 2005-2009, 90 percent of people 25 years and over had at least graduated from high school and 26 percent had a bachelor's degree or higher. Ten percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Hawaii County was 42,000 in 2005-2009. Nursery school and kindergarten enrollment was 4,600 and elementary or high school enrollment was 28,000 children. College or graduate school enrollment was 9,800.

The Educational Attainment of People in Hawaii County, Hawaii in 2005-2009






DISABILITY: In Hawaii County, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Hawaii County were Educational services, and health care, and social assistance, 19 percent, and Arts, entertainment, and recreation, and accommodation and food services, 18 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Management, professional, and related occupations, 29 percent; Sales and office occupations, 26 percent; Service occupations, 23 percent; Construction, extraction, maintenance, and repair occupations, 12 percent; and Production, transportation, and material moving occupations, 7 percent. Sixty-nine percent of the people employed were Private wage and salary workers; 18 percent was Federal, state, or local government workers; and 13 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Sixty-nine percent of Hawaii County workers drove to work alone in 2005-2009, 17 percent carpooled, 1 percent took public transportation, and 5 percent used other means. The remaining 8 percent worked at home. Among those who commuted to work, it took them on average 26.1 minutes to get to work.

INCOME: The median income of households in Hawaii County was \$55,645. Seventy-nine percent of the households received earnings and 20 percent received retirement income other than Social Security. Thirty-two percent of the households received Social Security. The average income from Social Security was \$15,342. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 14 percent of people were in poverty. Seventeen percent of related children under 18 were below the poverty level, compared with 9 percent of people 65 years old and over. Ten percent of all families and 26 percent of families with a female householder and no husband present had incomes below the poverty level.






Percent below poverty level

POPULATION OF Hawaii County: In 2005-2009, Hawaii County had a total population of 172,000 - 86,000 (50 percent) females and 87,000 (50 percent) males. The median age was 39.4 years. Twenty-three percent of the population was under 18 years and 14 percent was 65 years and older.

The Age Distribution of People in Hawaii County, Hawaii in 2005-2009





For people reporting one race alone, 36 percent was White; 1 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; 25 percent was Asian; 11 percent was Native Hawaiian and Other Pacific Islander, and 2 percent was Some other race. Twenty-six percent reported Two or more races. Eleven percent of the people in Hawaii County was Hispanic. Thirty-three percent of the people in Hawaii County was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Hawaii County had a total of 77,000 housing units, 18 percent of which were vacant. Of the total housing units, 78 percent was in single-unit structures, 22 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Thirty-one percent of the housing units were built since 1990.

OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Hawaii County had 63,000 occupied housing units - 42,000 (66 percent) owner occupied and 22,000 (34 percent) renter occupied. Three percent of the households did not have telephone service and 5 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Forty percent had two vehicles and another 23 percent had three or more.


HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,648, nonmortgaged owners \$315, and renters \$1,011. Forty-six percent of owners with mortgages, 10 percent of owners without mortgages, and 47 percent of renters in Hawaii County spent 30 percent or more of household income on housing.
