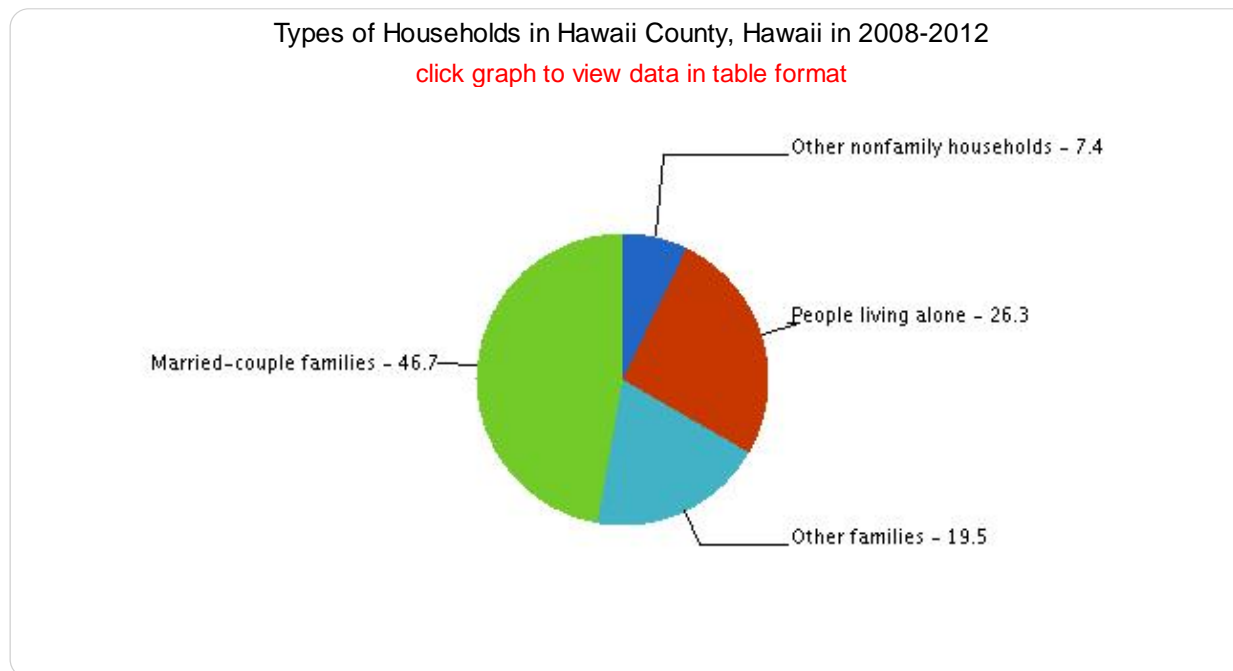

▶ Households and Families

In 2008-2012 there were 64,600 households in Hawaii County, Hawaii. The average household size was 2.8 people.

Families made up 66 percent of the households in Hawaii County, Hawaii. This figure includes both married-couple families (47 percent) and other families (20 percent). Of other families, 7 percent are female householder families with no husband present and own children under 18 years. Nonfamily households made up 34 percent of all households in Hawaii County, Hawaii. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

In Hawaii County, Hawaii, 31 percent of all households have one or more people under the age of 18; 30 percent of all households have one or more people 65 years and over.

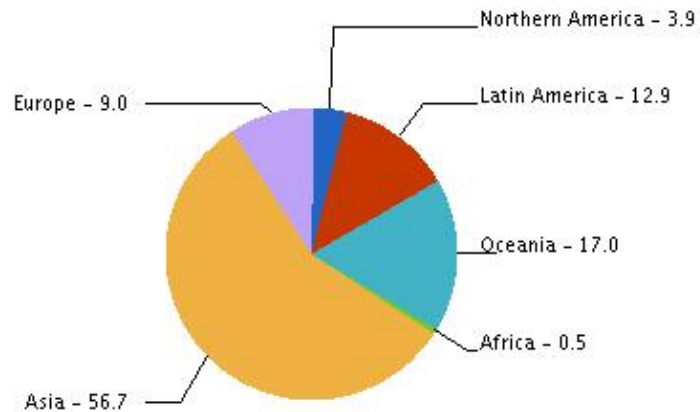
An estimated 88 percent of the people living in Hawaii County, Hawaii in 2008-2012 were native residents of the United States and 57 percent of these residents were living in the state in which they were born.

An estimated 12 percent of the people living in Hawaii County, Hawaii in 2008-2012 were foreign born. Of the foreign born population, 44 percent were naturalized U.S. citizens, and 97 percent entered the country before the year 2010. An estimated 3 percent of the foreign born entered the country in 2010 or later.

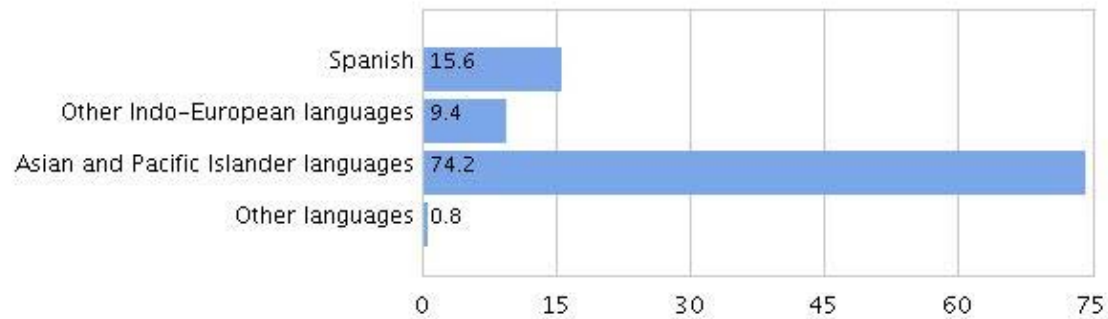


▶ Language

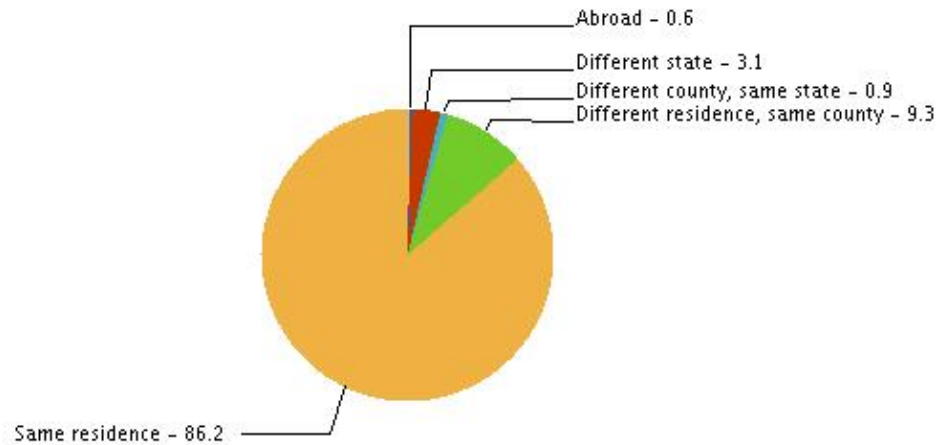

Geographic Mobility of Residents of Hawaii County, Hawaii in 2008-2012

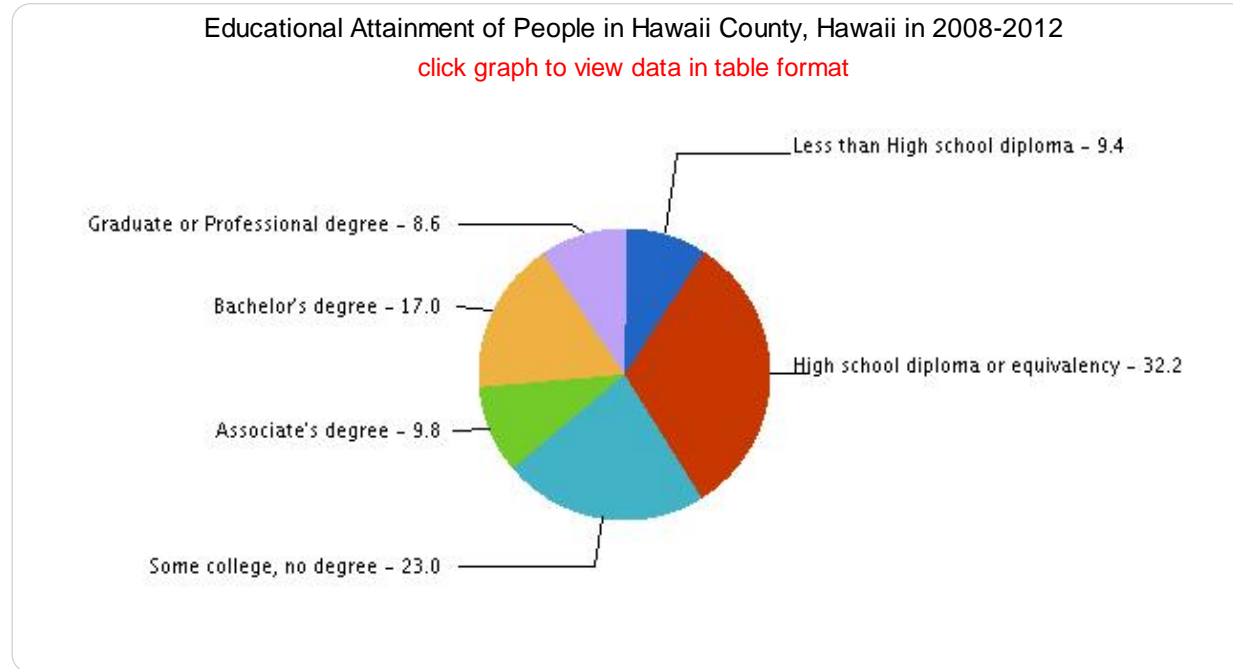

► Education

In 2008-2012, 91 percent of people 25 years and over had at least graduated from high school and 26 percent had a bachelor's degree or higher. An estimated 9 percent did not complete high school.

The total school enrollment in Hawaii County, Hawaii was 42,900 in 2008-2012. Nursery school and kindergarten enrollment was 4,900 and elementary or high school enrollment was 28,500 children. College or graduate school enrollment was 9,600.



► Disability

In Hawaii County, Hawaii, among the civilian noninstitutionalized population in 2008-2012, 13 percent reported a disability. The likelihood of having a disability varied by age - from 3 percent of people under 18 years old, to 11 percent of people 18 to 64 years old, and to 40 percent of those 65 and over.

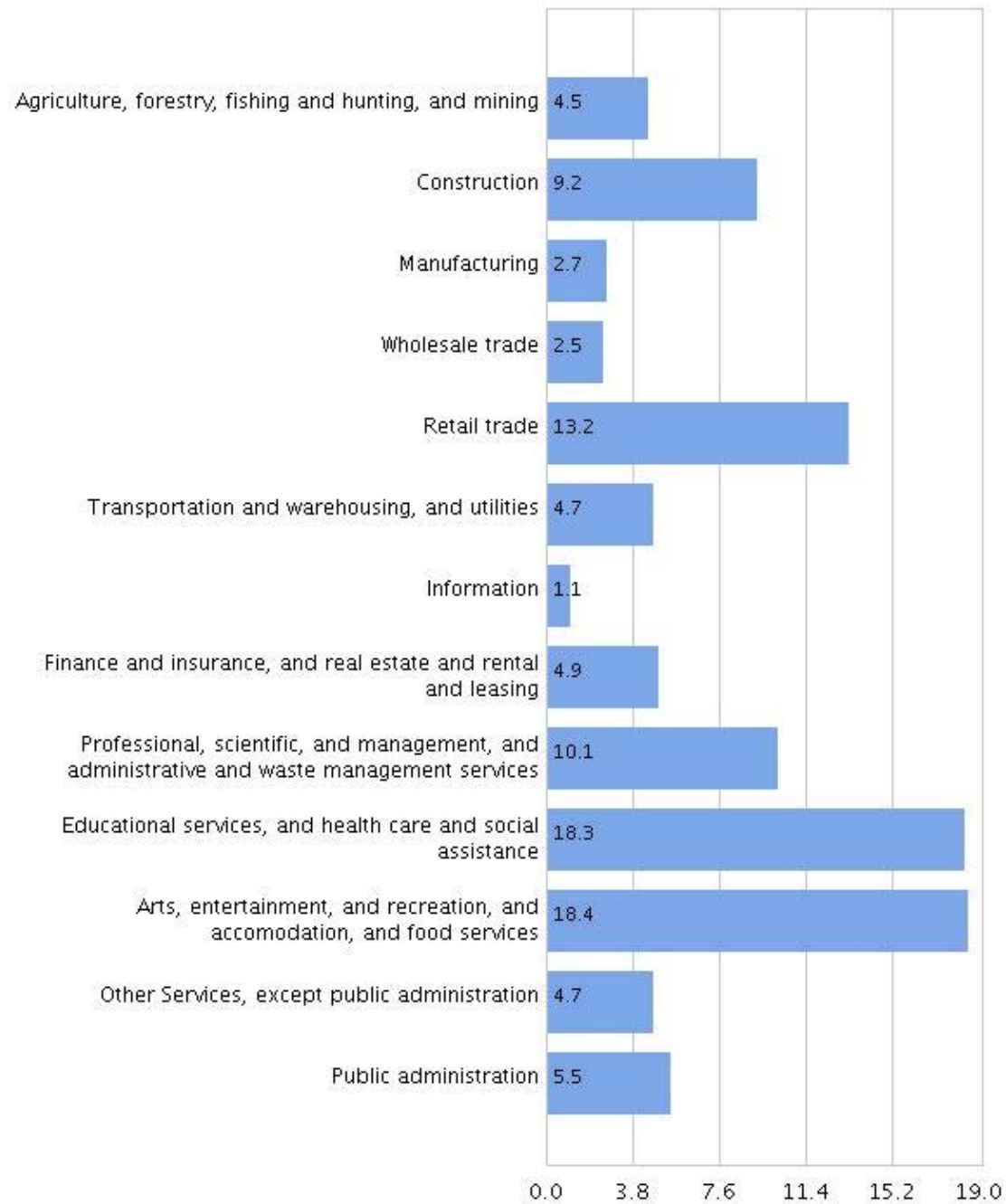

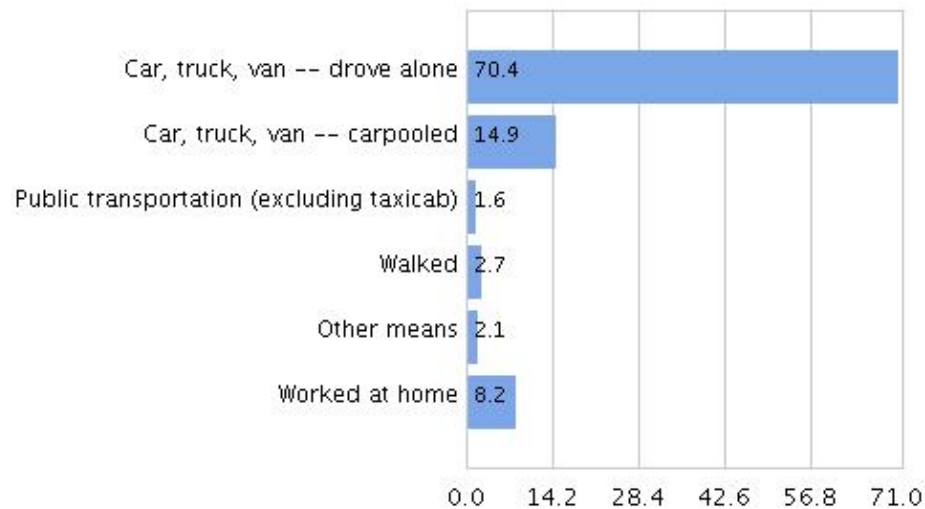

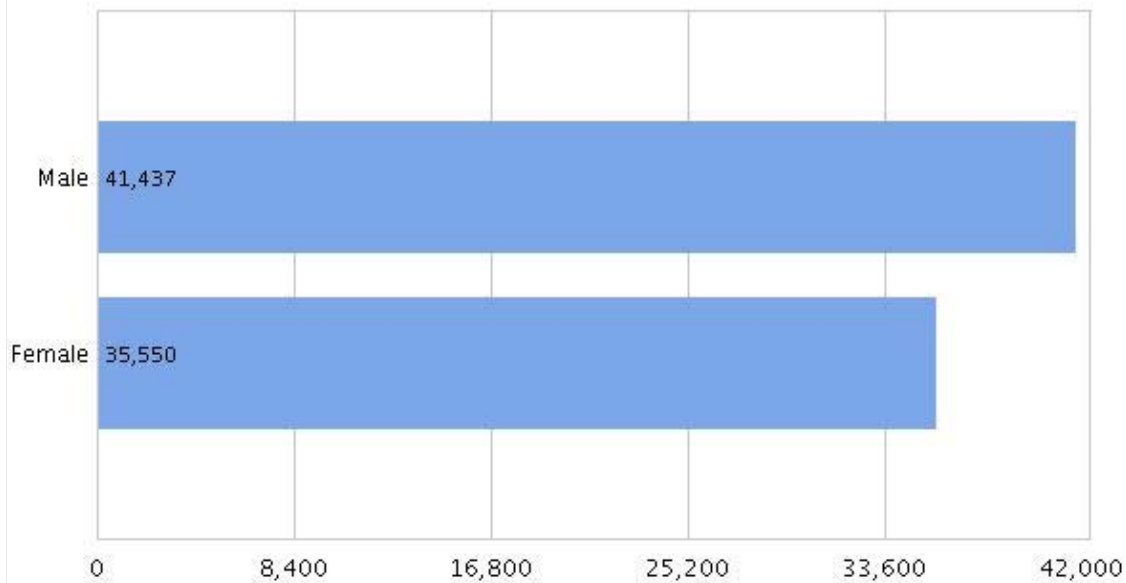


Income

Median Earnings for Full-Time Year-Round Workers by Sex in Hawaii County, Hawaii in 2008-2012

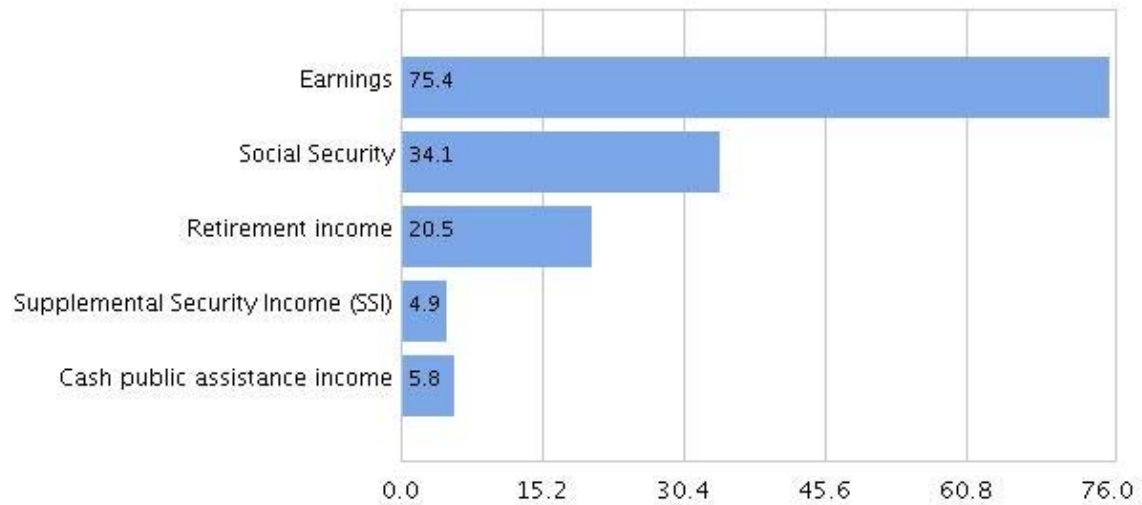

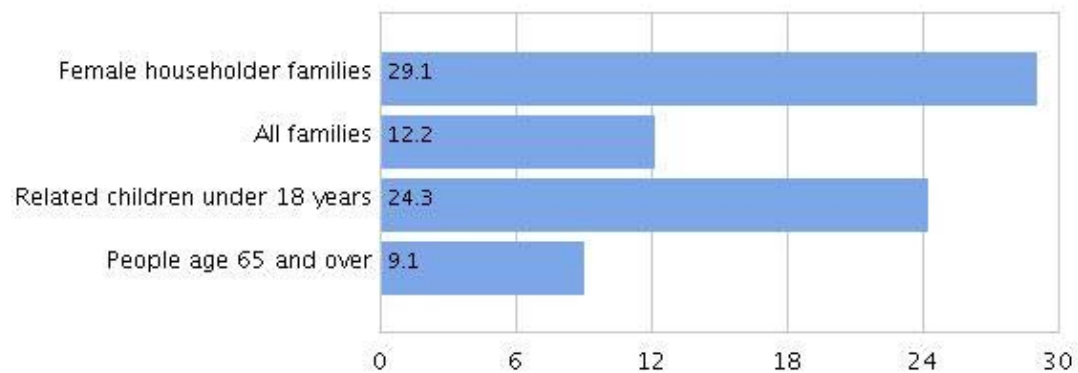


► Poverty and Participation in Government Programs

In 2008-2012, 17 percent of people were in poverty. An estimated 24 percent of related children under 18 were below the poverty level, compared with 9 percent of people 65 years old and over. An estimated 12 percent of all families and 29 percent of families with a female householder and no husband present had incomes below the poverty level.

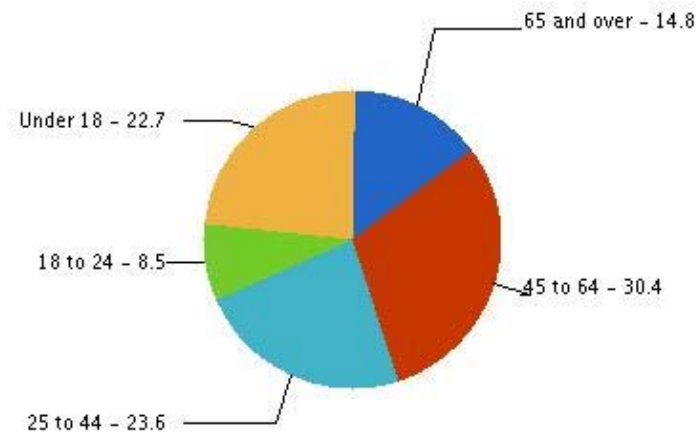
Among the civilian noninstitutionalized population in Hawaii County, Hawaii in 2008-2012, 90 percent had health insurance coverage and 10 percent did not have health insurance coverage. For those under 18 years of age, 5 percent had no health insurance coverage. The civilian noninstitutionalized population had both private and public health insurance, with 67 percent having private coverage and 36 percent having public coverage.

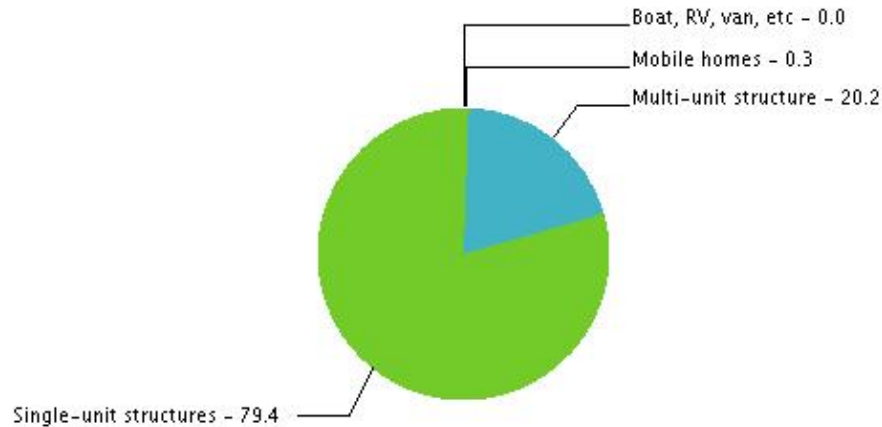

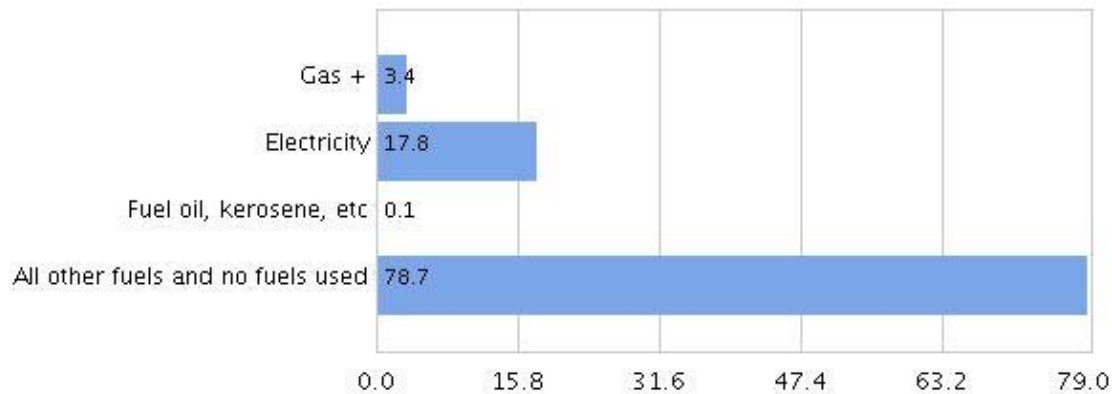

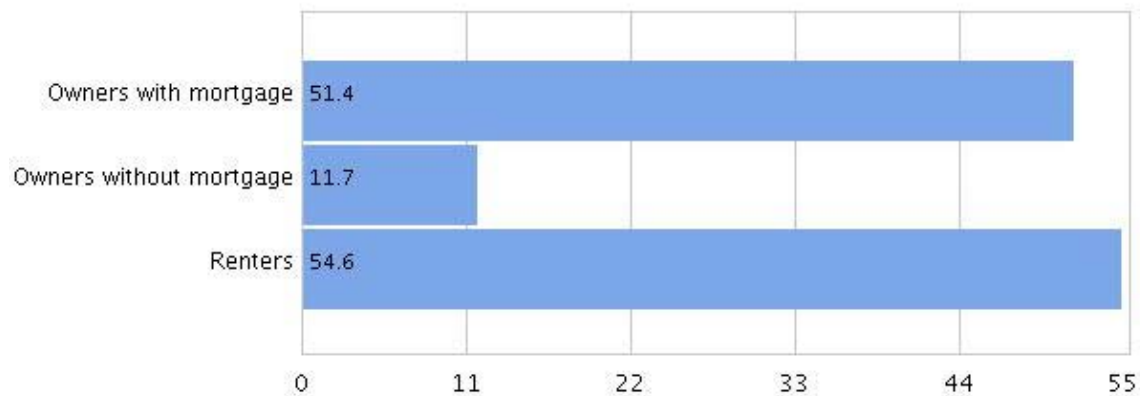

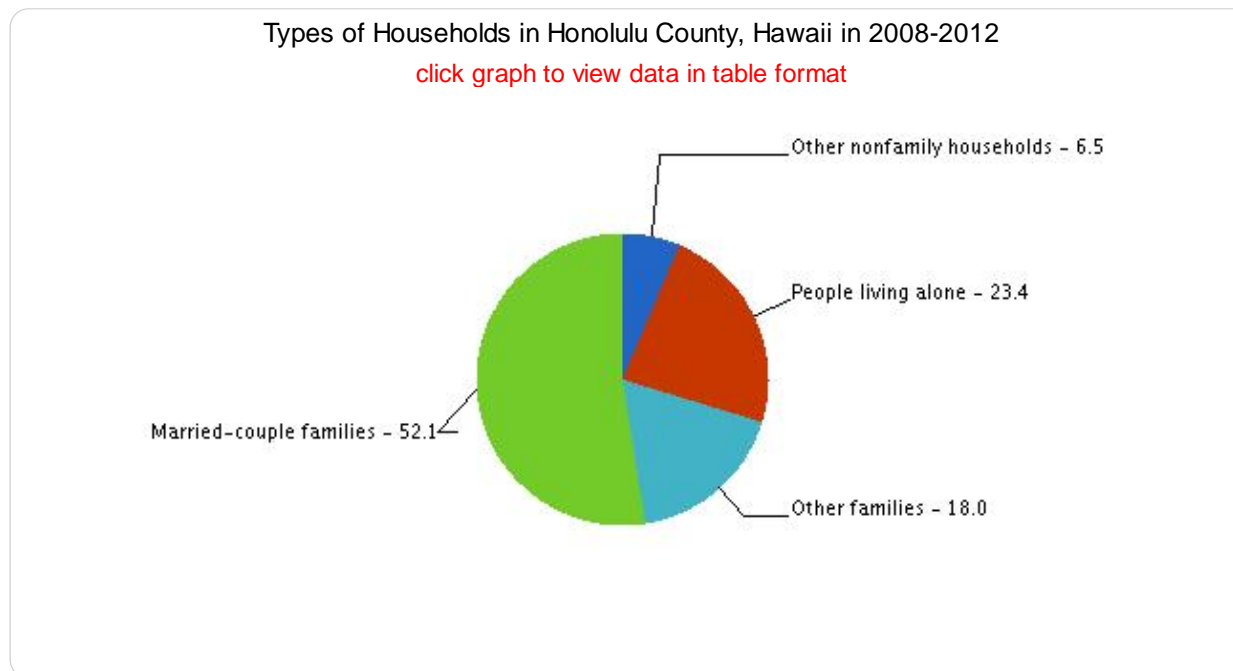

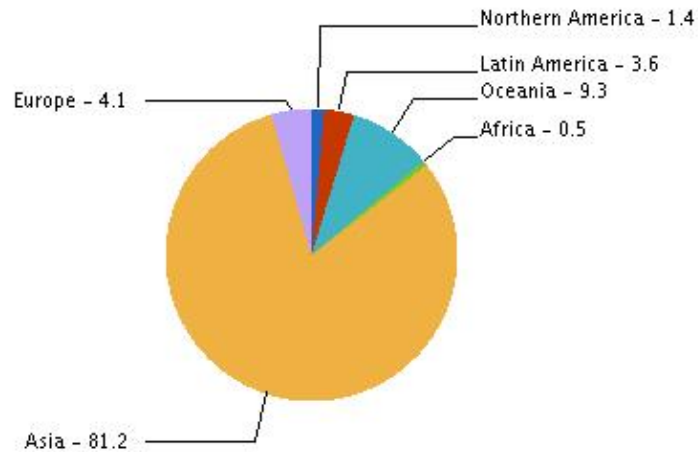

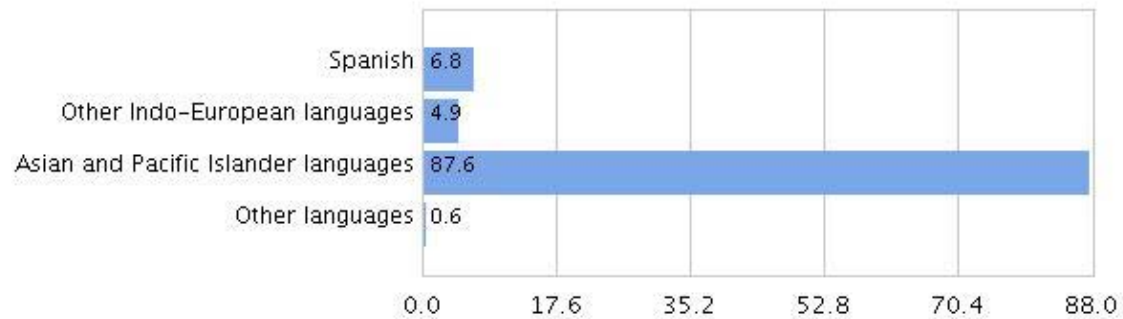

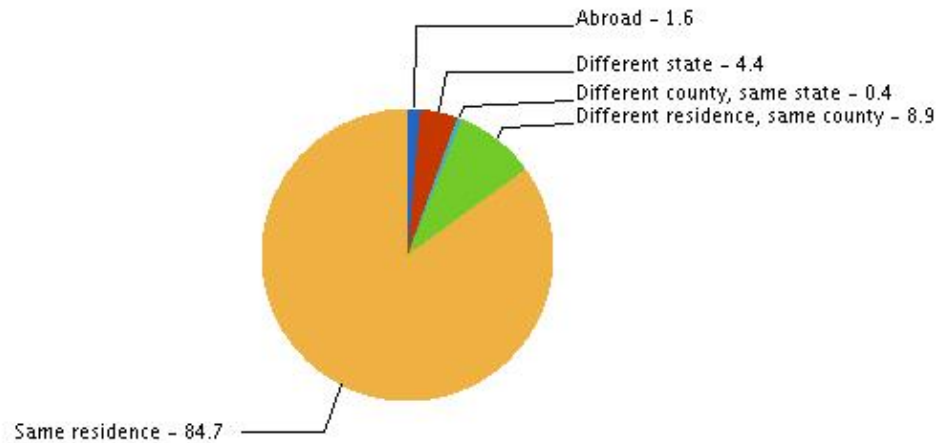

Geographic Mobility of Residents of Honolulu County, Hawaii in 2008-2012

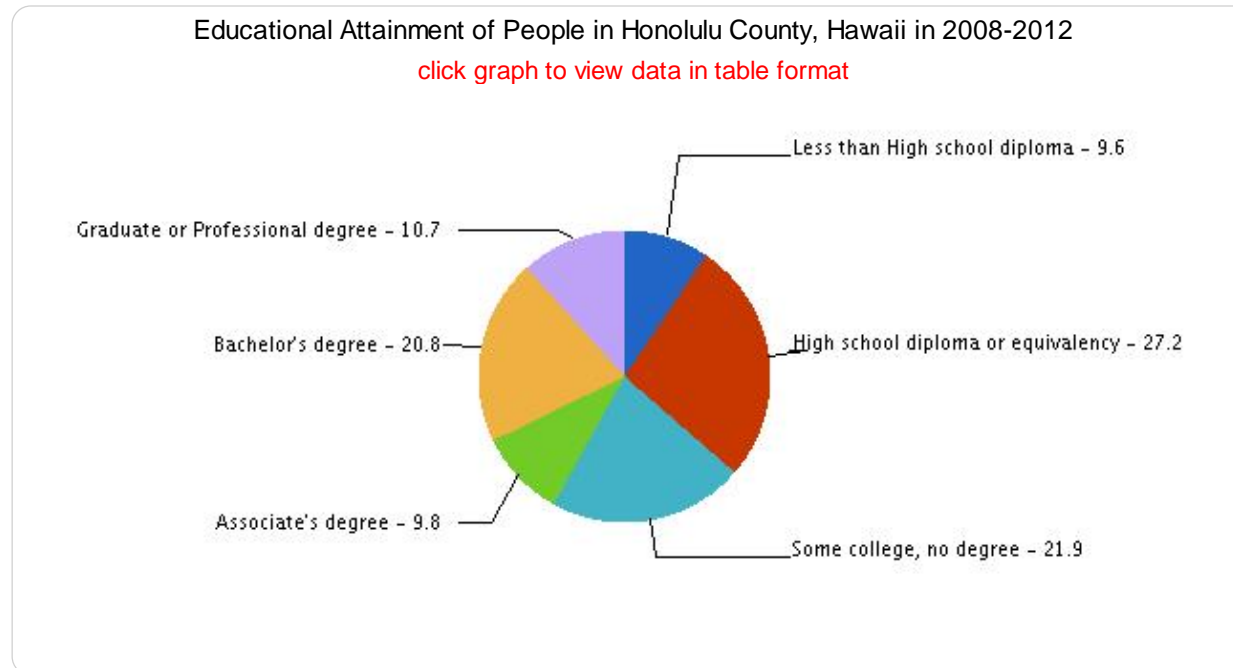

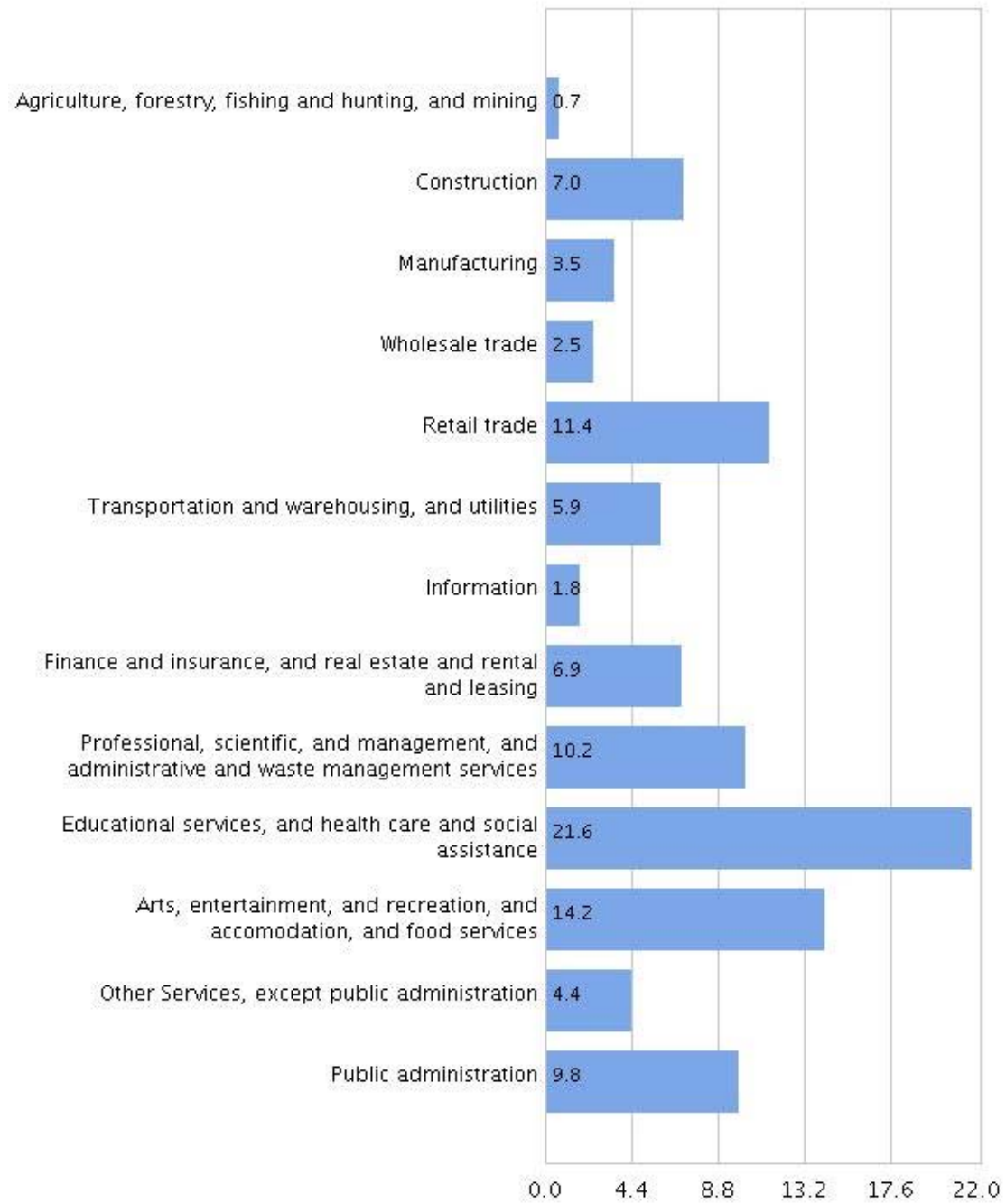

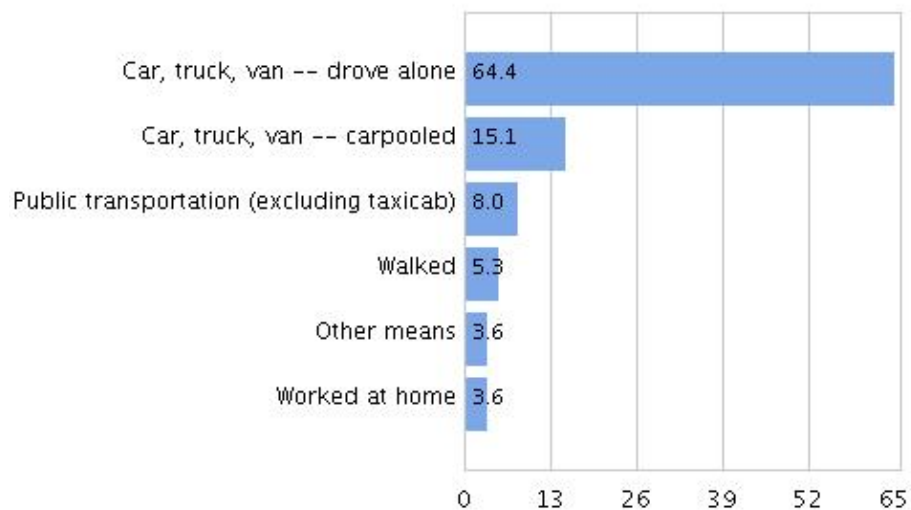

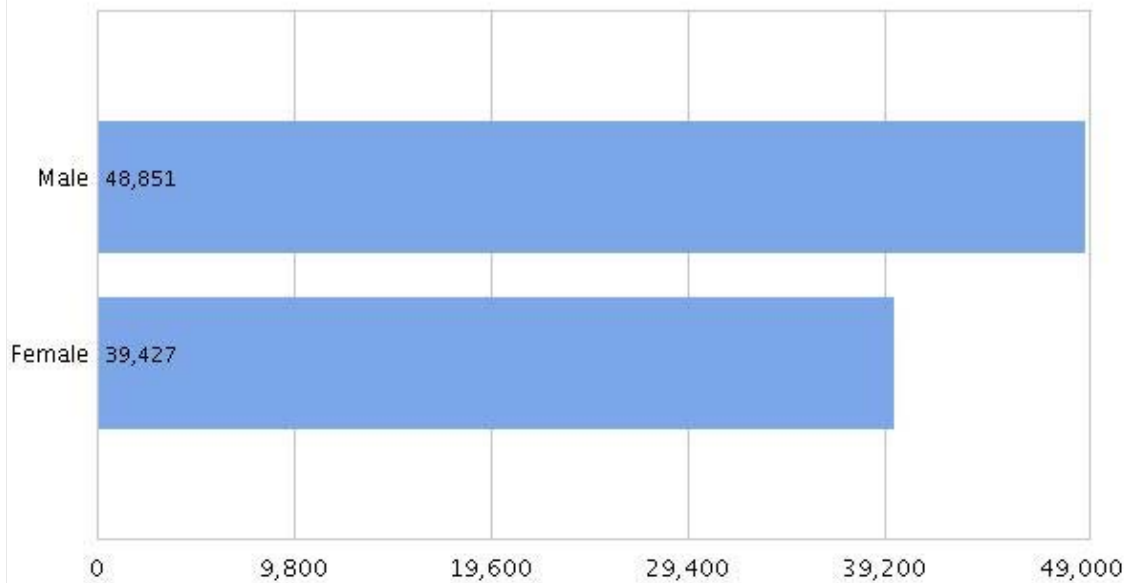

Median Earnings for Full-Time Year-Round Workers by Sex in Honolulu County, Hawaii in 2008-2012

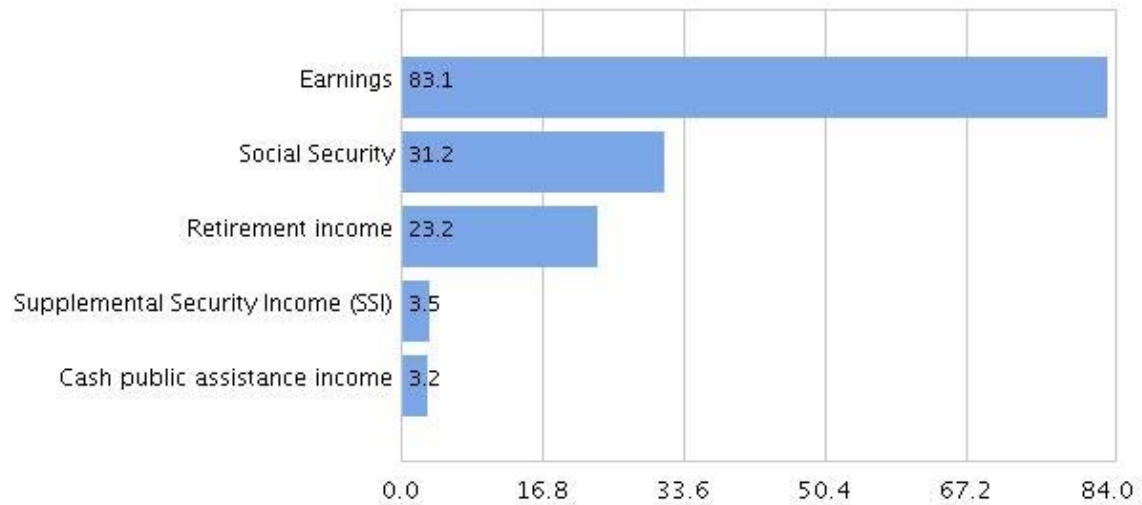

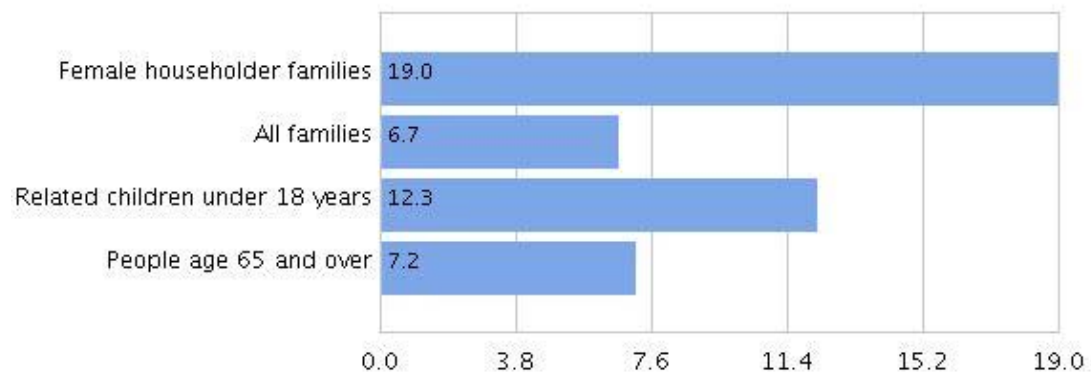

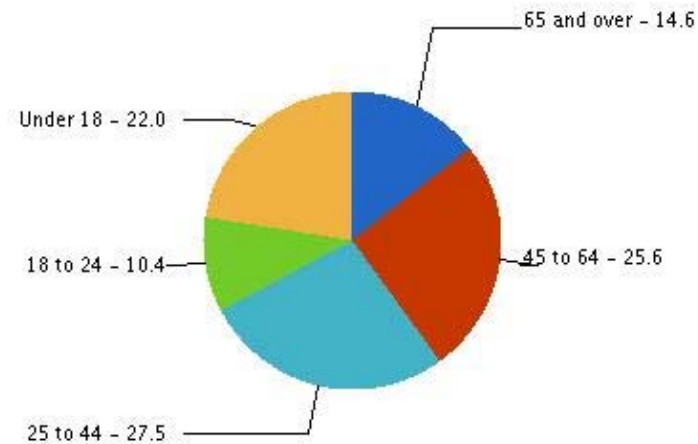

Age Distribution of People in Honolulu County, Hawaii in 2008-2012

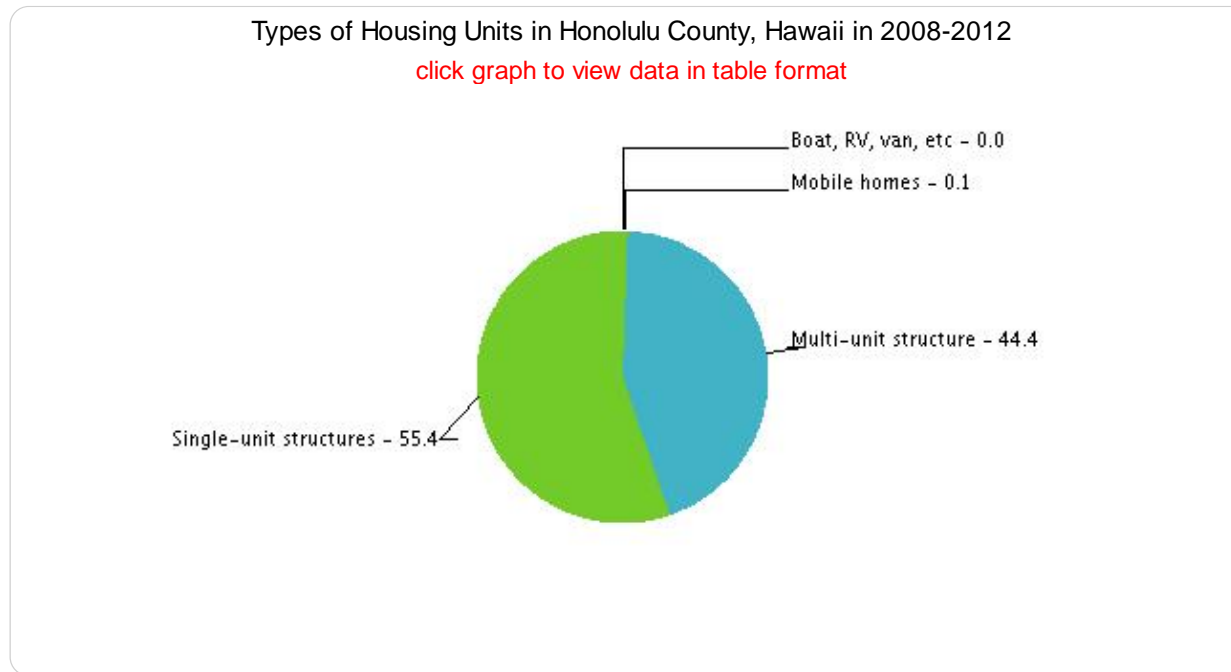

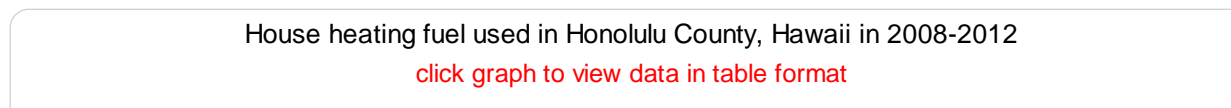

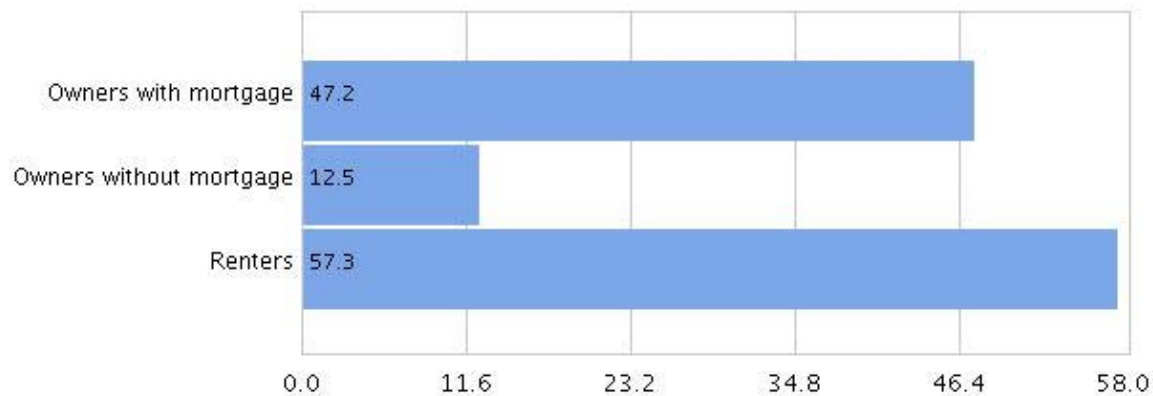

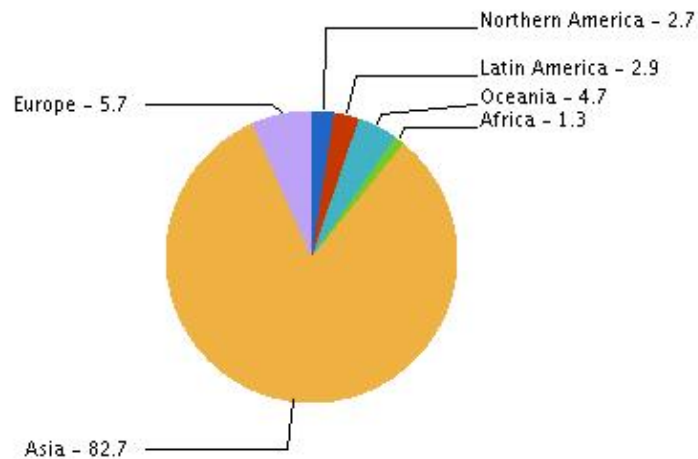

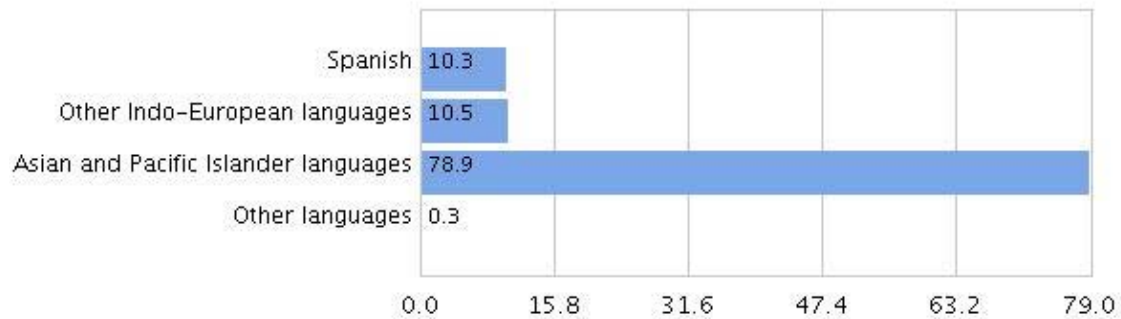

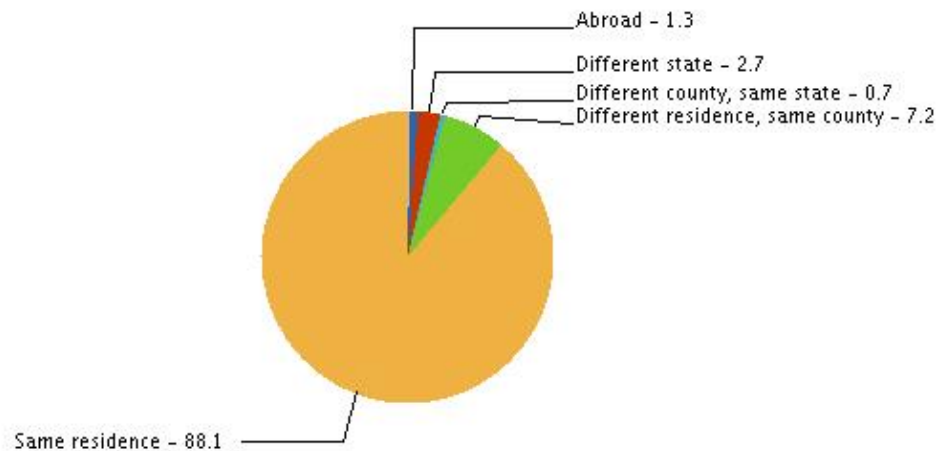

Geographic Mobility of Residents of Kauai County, Hawaii in 2008-2012

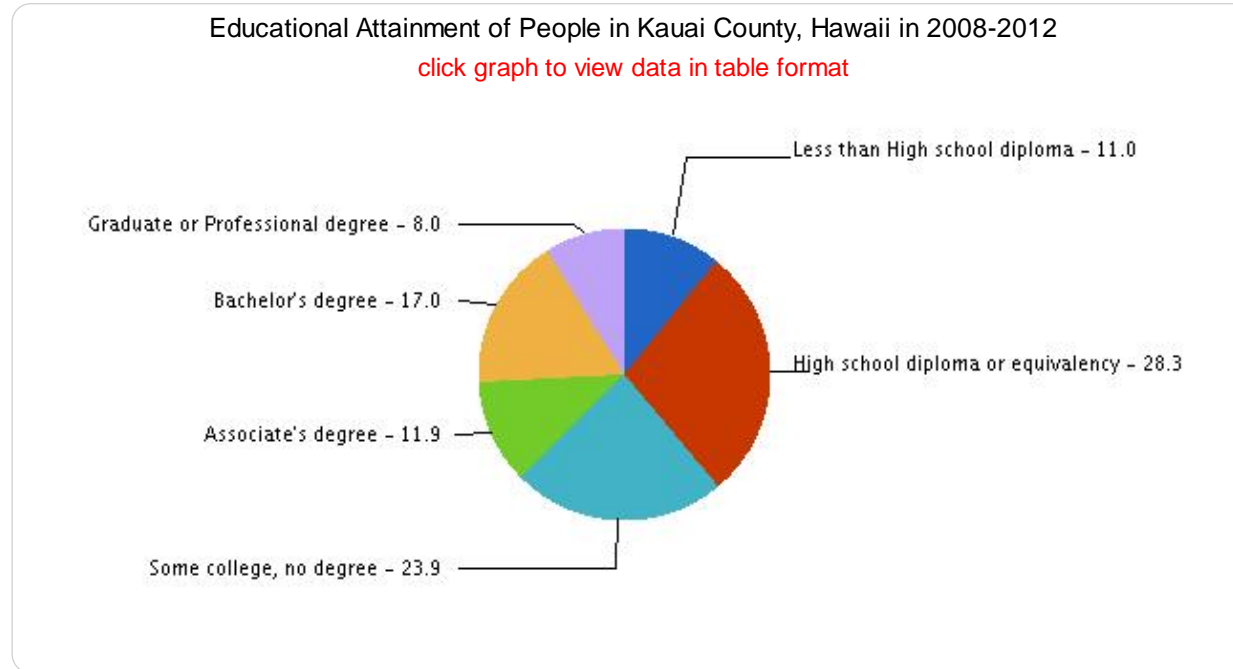

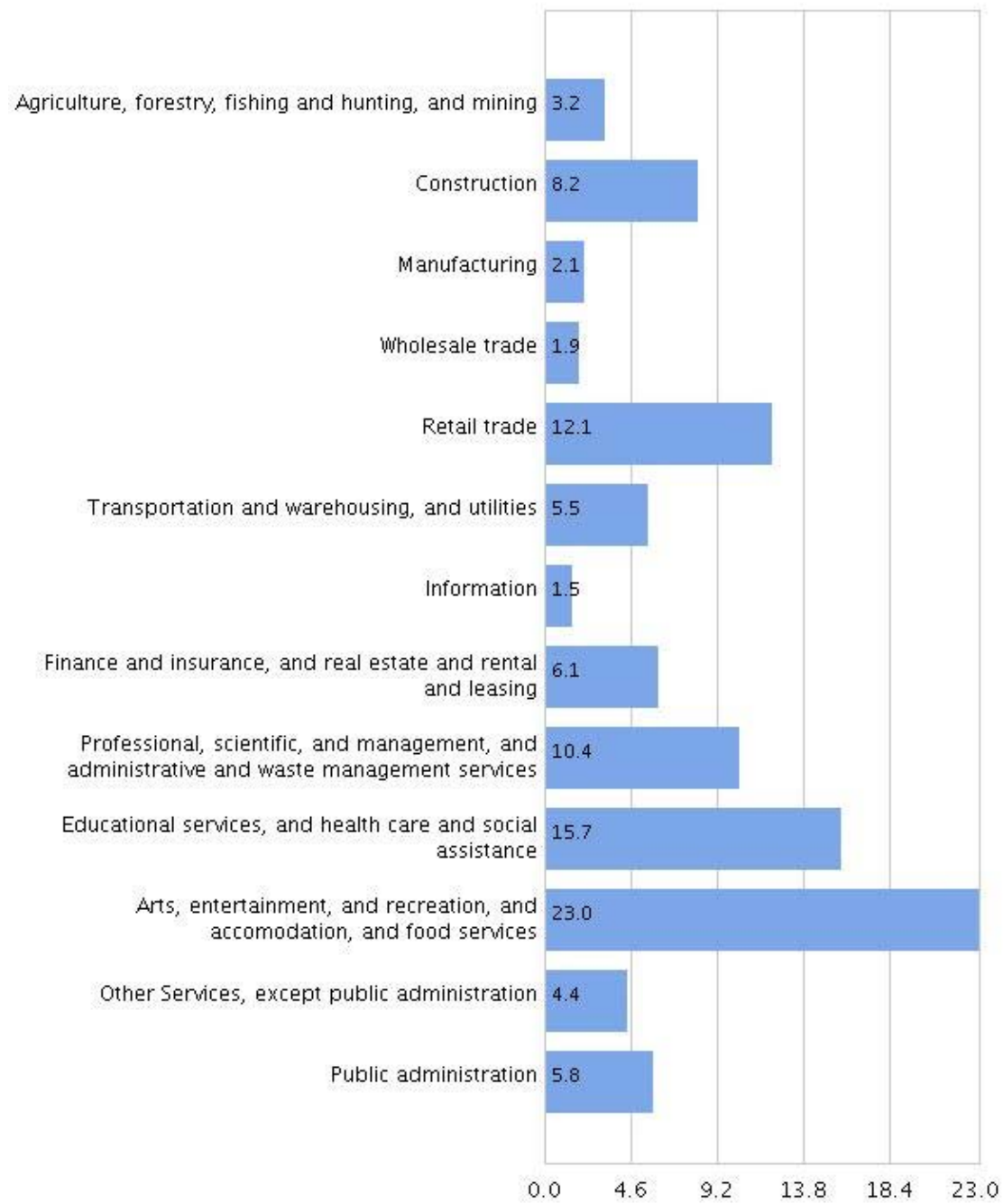

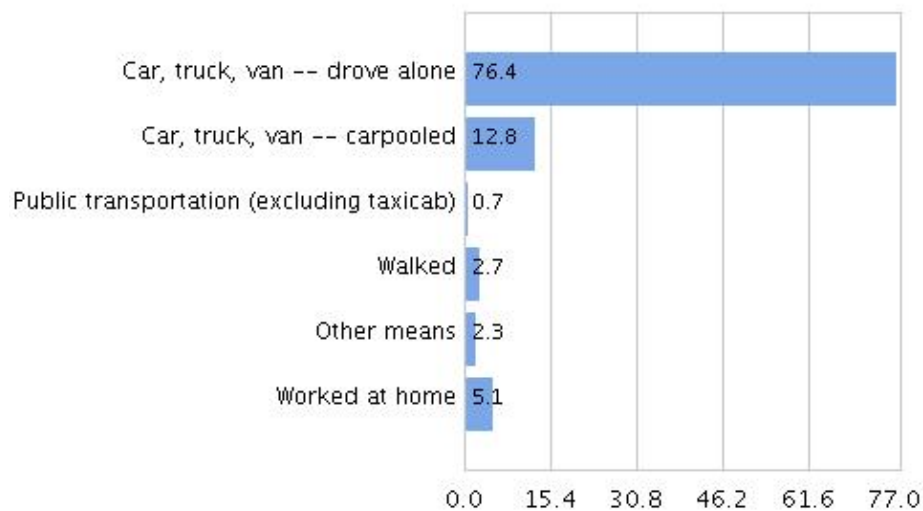

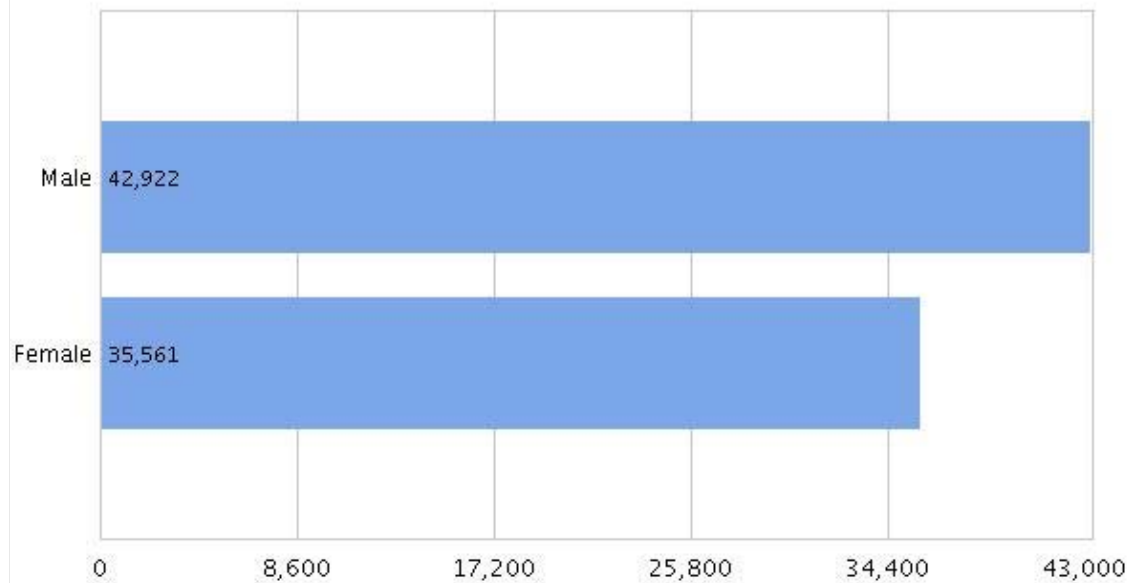

Median Earnings for Full-Time Year-Round Workers by Sex in Kauai County, Hawaii in 2008-2012

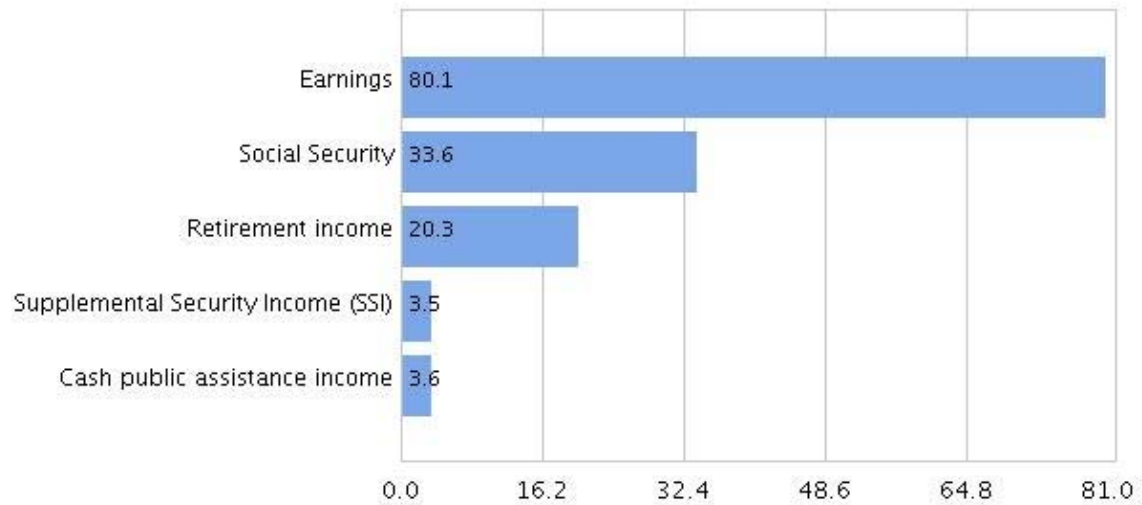

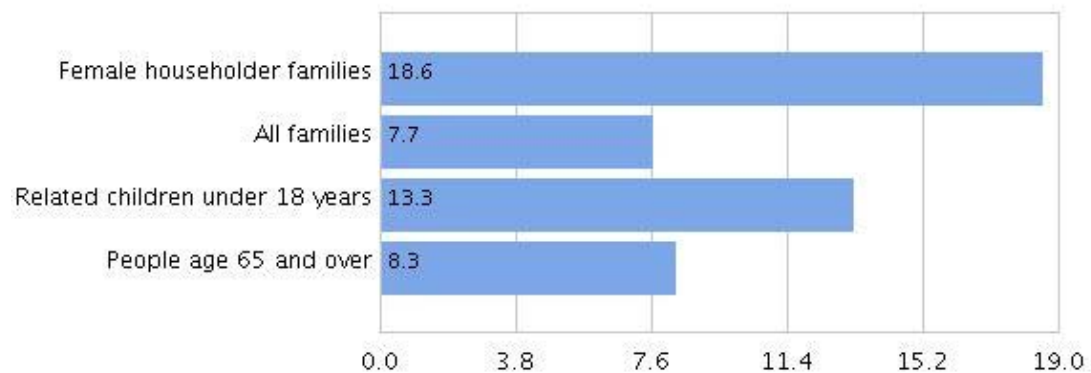

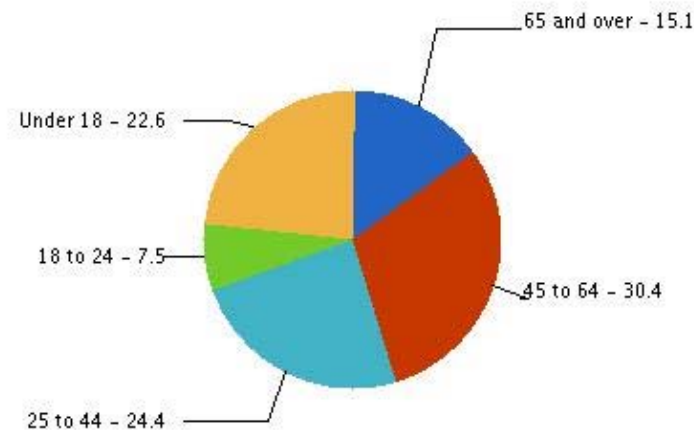

Age Distribution of People in Kauai County, Hawaii in 2008-2012

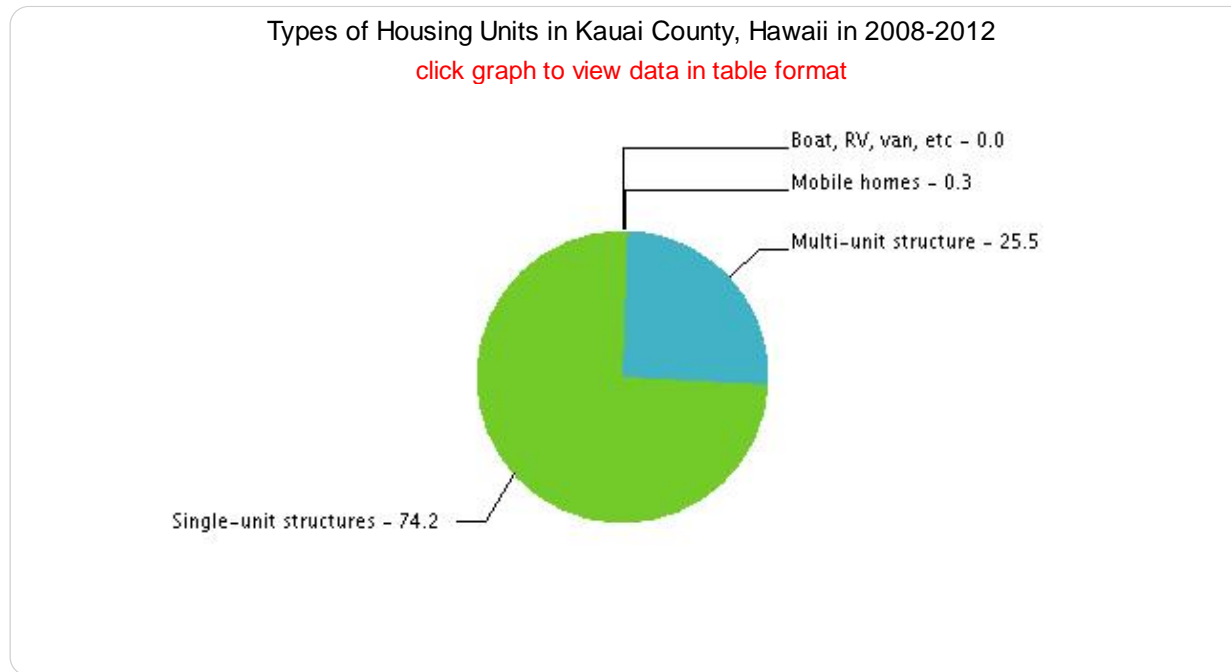

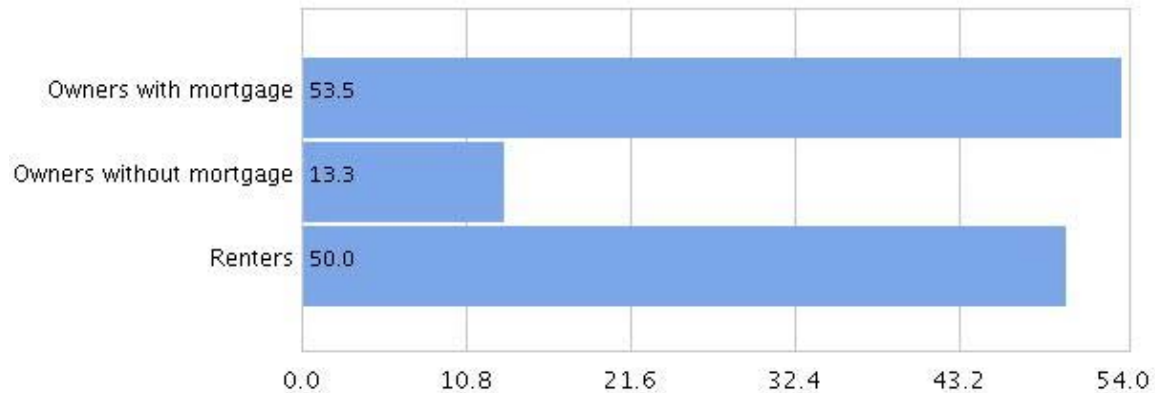

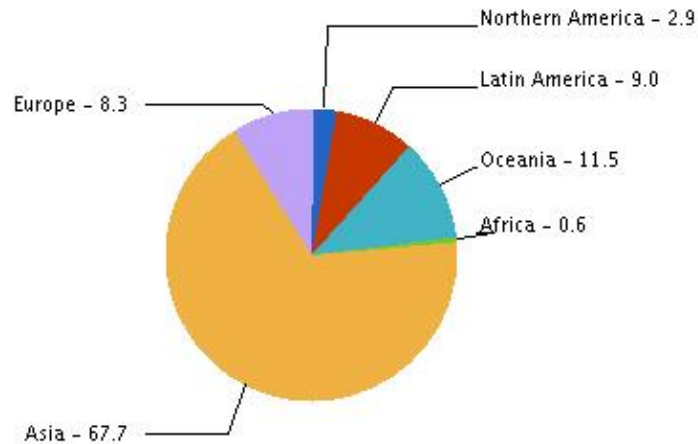

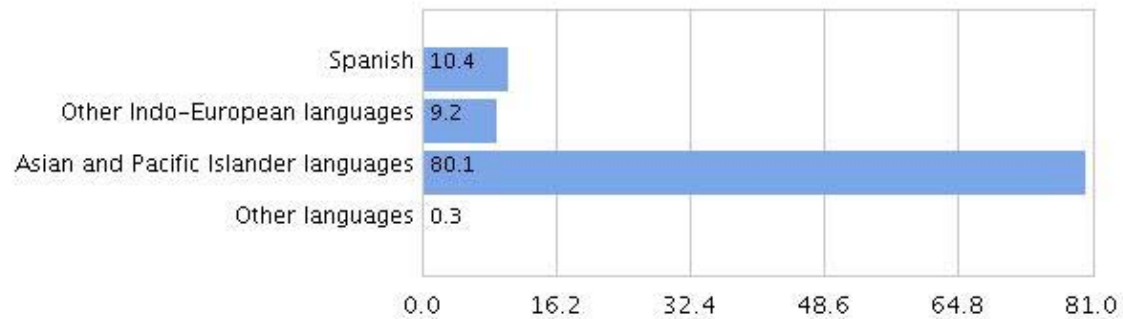

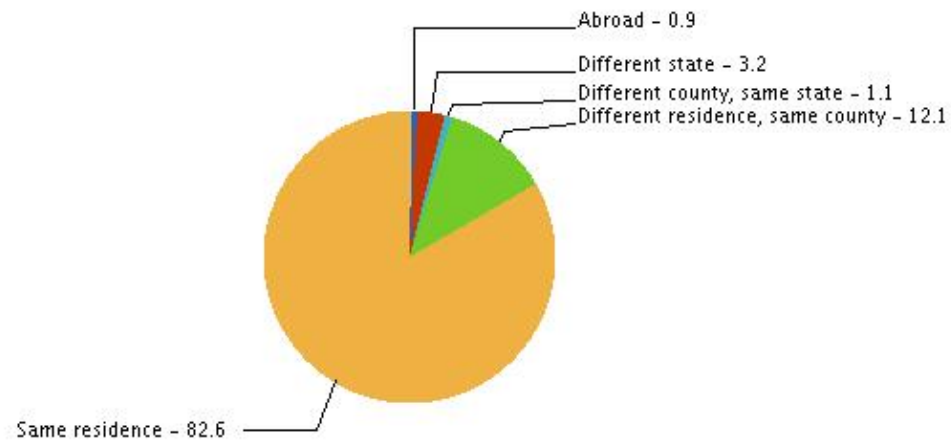

Geographic Mobility of Residents of Maui County, Hawaii in 2008-2012

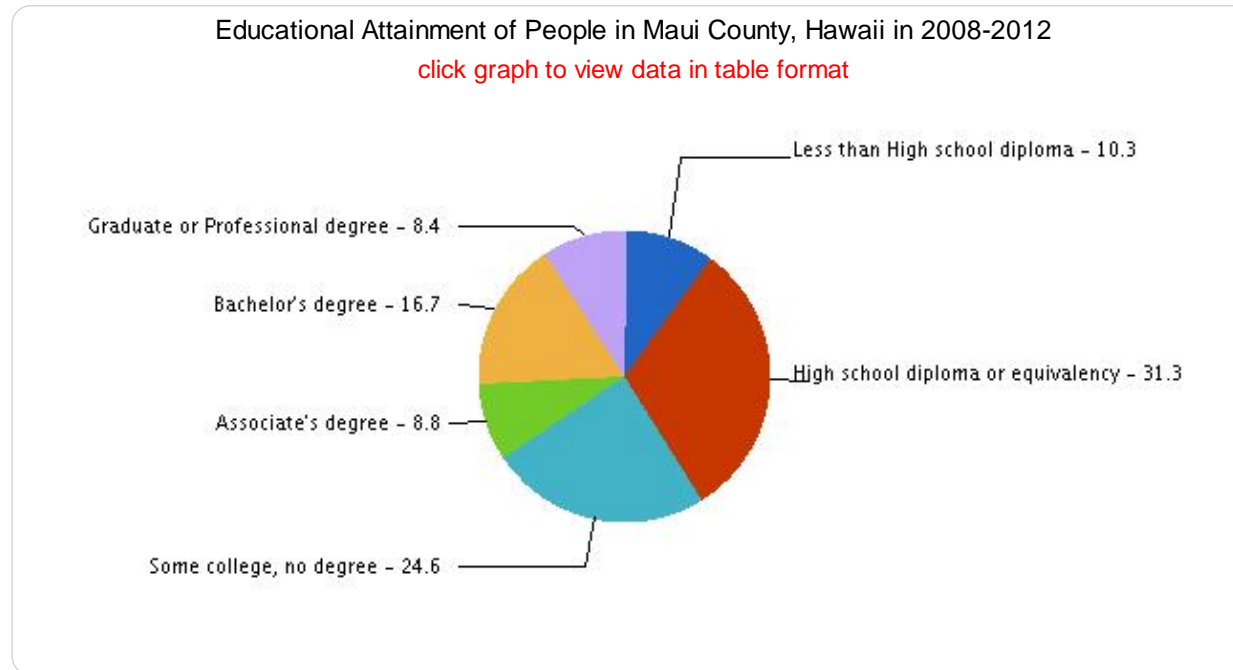

► Employment Status and Type of Employer

In Maui County, Hawaii, 64 percent of the population 16 and over were employed; 30 percent were not currently in the labor force.

An estimated 75 percent of the people employed were private wage and salary workers; 14 percent were federal, state, or local government workers; and 11 percent were self-employed in their own (not incorporated) business.

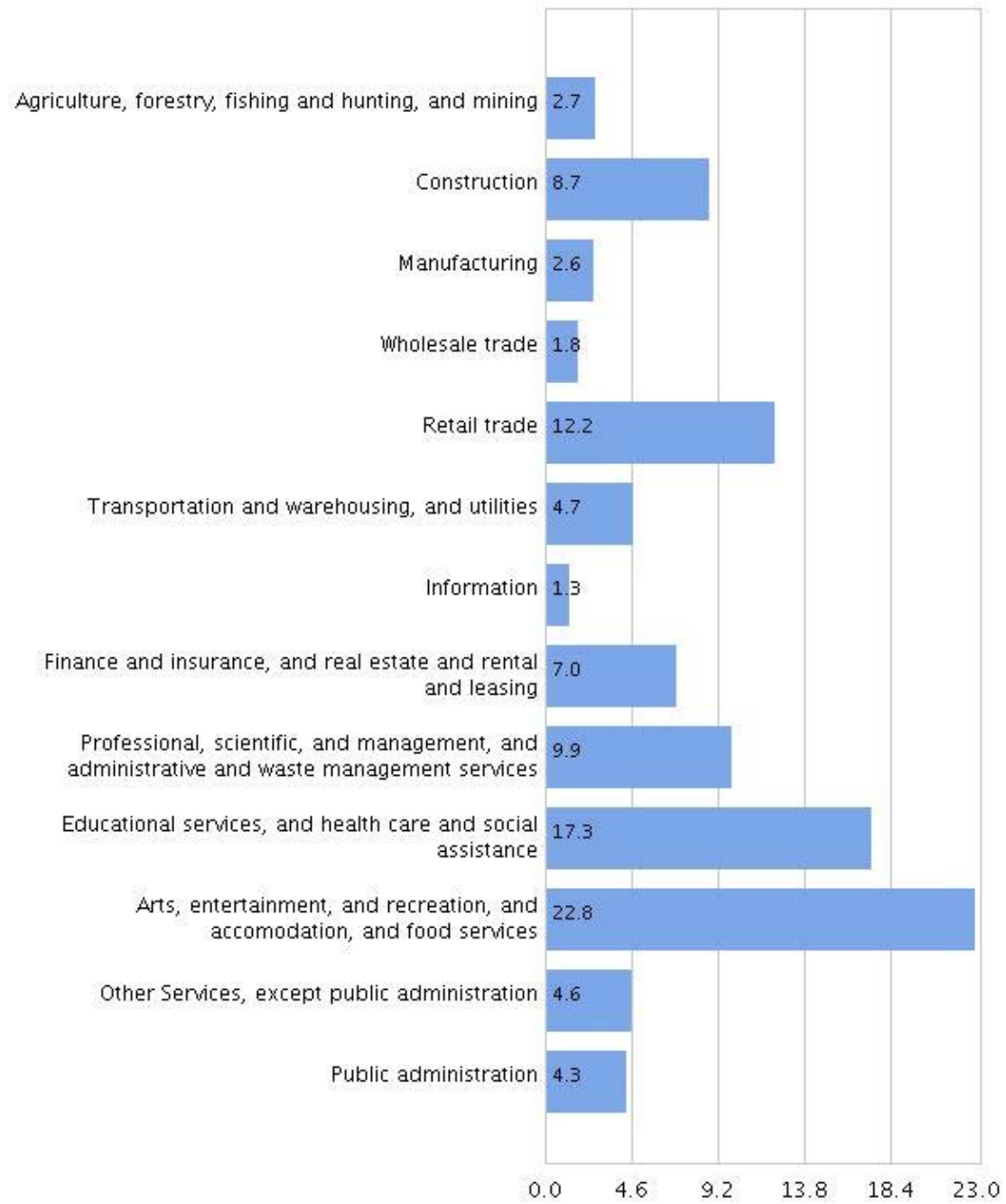

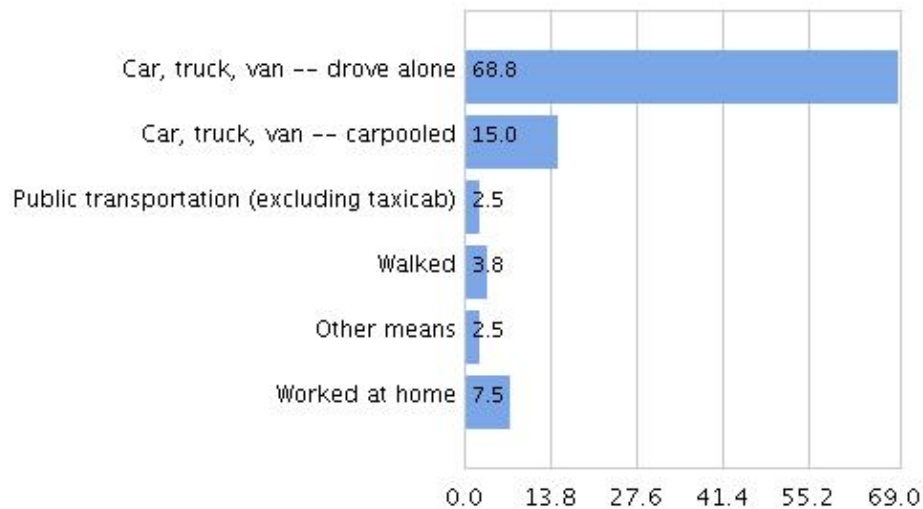

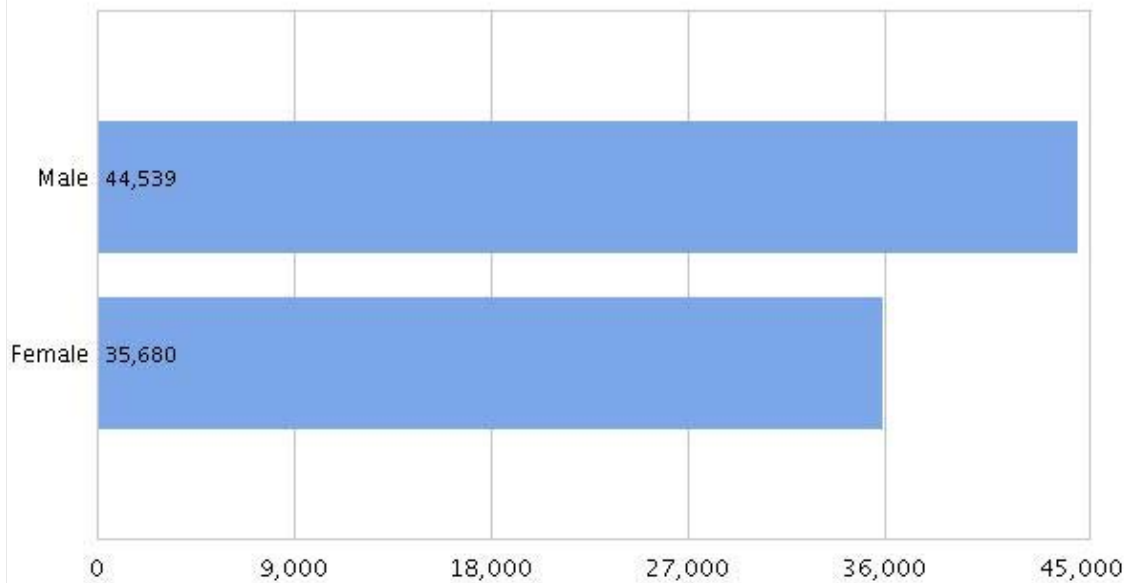


Income

The median income of households in Maui County, Hawaii was \$64,058. An estimated 9 percent of households had income below \$15,000 a year and 12 percent had income over \$150,000 or more.

Median Earnings for Full-Time Year-Round Workers by Sex in Maui County, Hawaii in 2008-2012

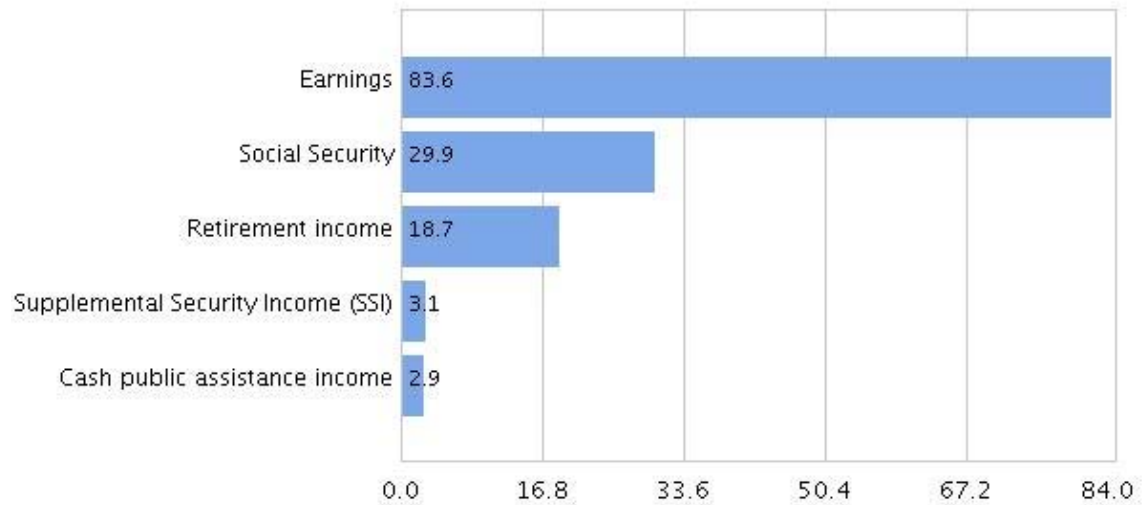

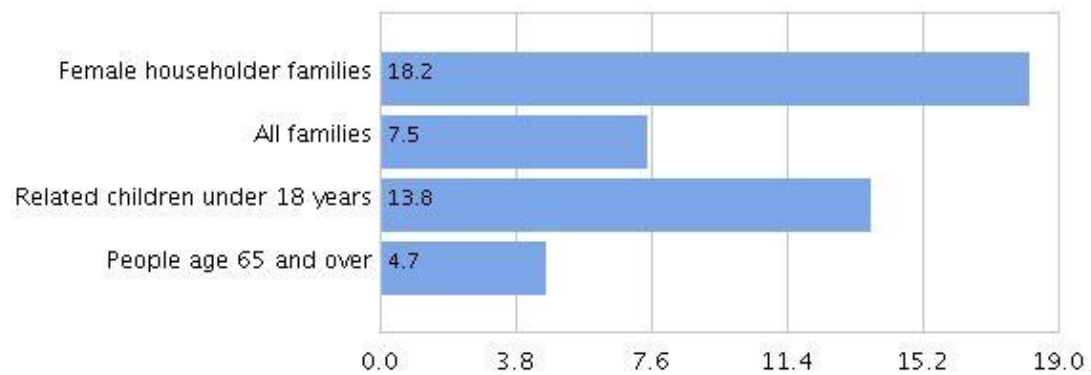


► Poverty and Participation in Government Programs

In 2008-2012, 10 percent of people were in poverty. An estimated 14 percent of related children under 18 were below the poverty level, compared with 5 percent of people 65 years old and over. An estimated 8 percent of all families and 18 percent of families with a female householder and no husband present had incomes below the poverty level.

▶ Health Insurance

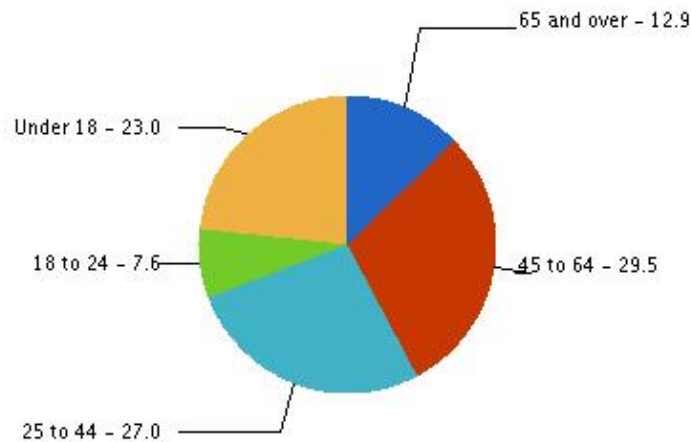
Among the civilian noninstitutionalized population in Maui County, Hawaii in 2008-2012, 91 percent had health insurance coverage and 9 percent did not have health insurance coverage. For those under 18 years of age, 5 percent had no health insurance coverage. The civilian noninstitutionalized population had both private and public health insurance, with 74 percent having private coverage and 28 percent having public coverage.

▶ Population

In 2008-2012, Maui County, Hawaii has a total population of 154,900 -- 77,100 (50 percent) females and 77,800 (50 percent) males. The median age was 39.5 years. An estimated 23 percent of the population was under 18 years and 13 percent was 65 years and older.

Age Distribution of People in Maui County, Hawaii in 2008-2012

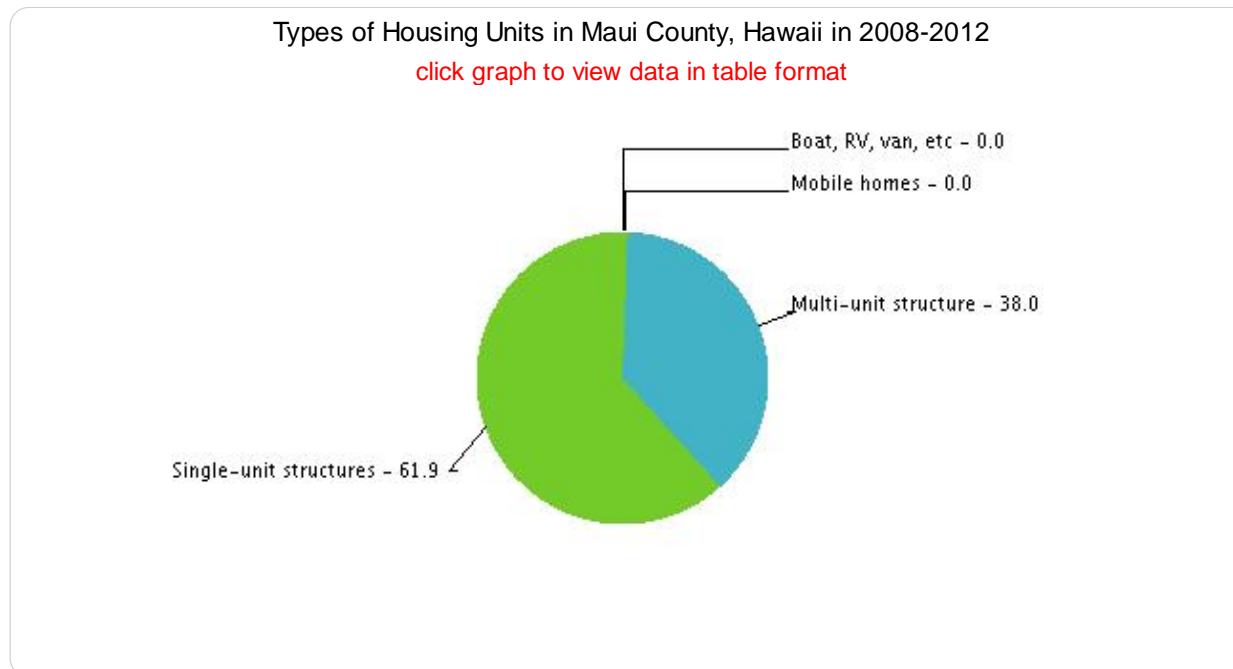

For people reporting one race alone, 48 percent were White; 1 percent were Black or African American; less than 0.5 percent were American Indian and Alaska Native; 36 percent were Asian; 14 percent were Native Hawaiian and Other Pacific Islander, and 1 percent were some other race. An estimated 28 percent reported two or more races. An estimated 10 percent of the people in Maui County, Hawaii were Hispanic. An estimated 32 percent of the people in Maui County, Hawaii were White non-Hispanic. People of Hispanic origin may be of any race.

► Housing Characteristics

In 2008-2012, Maui County, Hawaii had a total of 70,200 housing units, 26 percent of which were vacant. Of the total housing units, 62 percent were in single-unit structures, 38 percent were in multi-unit structures, and less than 0.5 percent were mobile homes. An estimated 33 percent of the housing units were built since 1990.

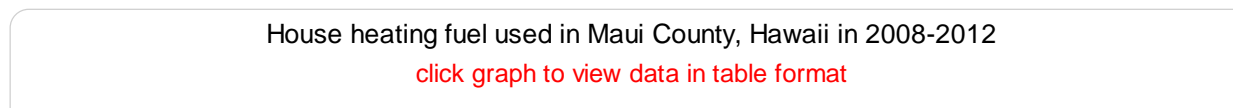


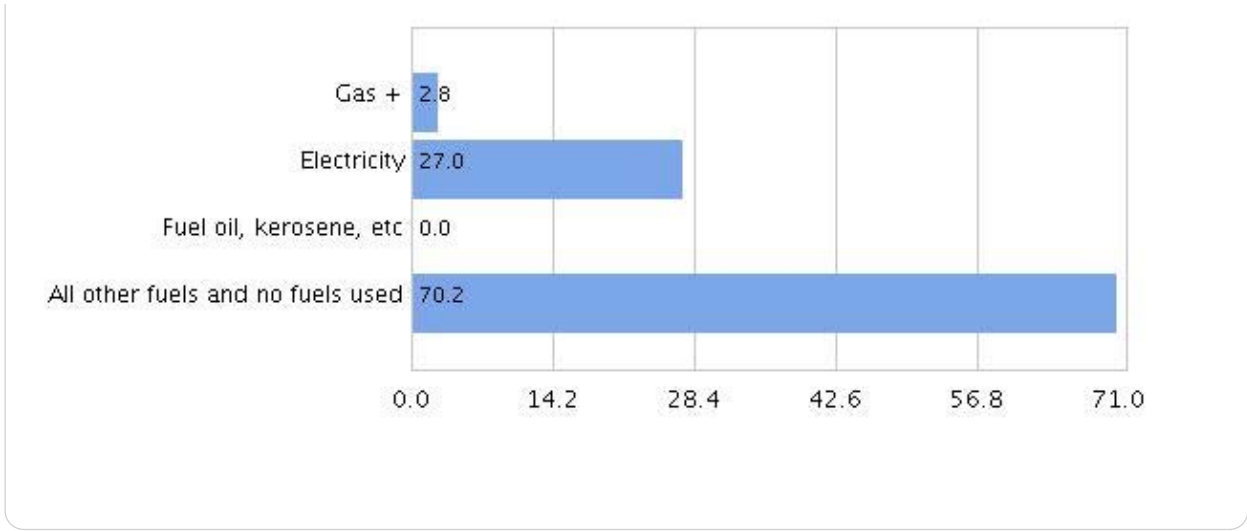
The median number of rooms in all housing units in Maui County, Hawaii is 4. Of these housing units, 48 percent have three or more bedrooms.

► Occupied Housing Unit Characteristics

In 2008-2012, Maui County, Hawaii had 52,300 occupied housing units - 30,400 (58 percent) owner occupied and 21,900 (42 percent) renter occupied. An estimated 64 percent of householders of these units had moved in since 2000. An estimated 71 percent of the owner occupied units had a mortgage. An estimated 3 percent of the households did not have telephone service. An estimated 5 percent had no vehicles available and another 24 percent had three or more.

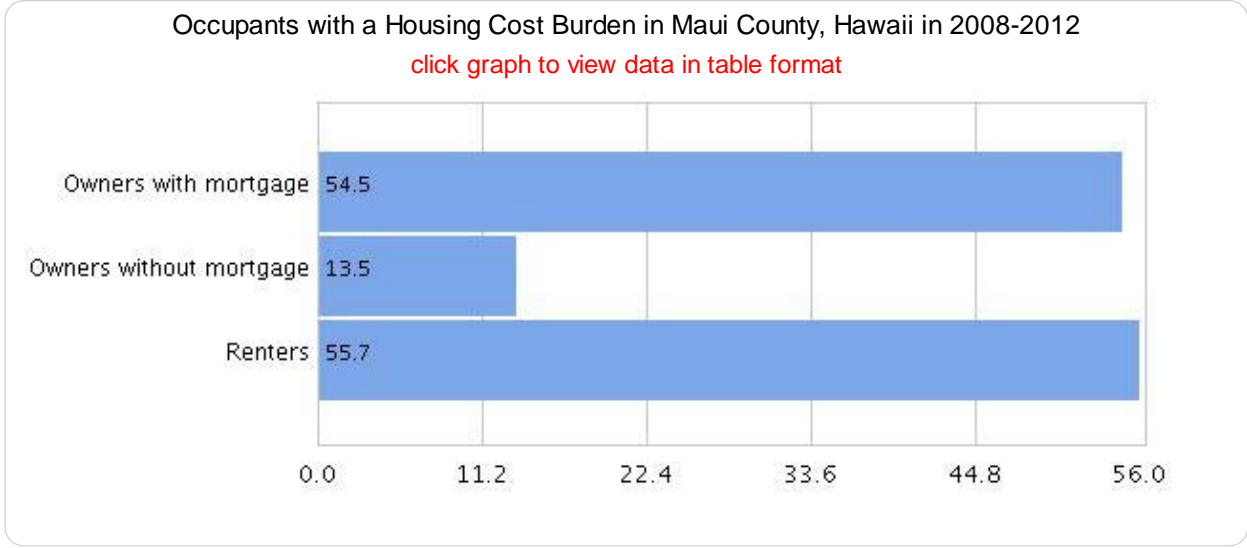

Housing Costs

The median monthly housing costs for mortgaged owners was \$2,445, nonmortgaged owners \$463, and renters \$1,293. An estimated 54 percent of owners with mortgages, 14 percent of owners without mortgages, and 56 percent of renters in Maui County, Hawaii spent 30 percent or more of household income on housing.
