





Percent by Industry in Hawaii County, Hawaii in 2009-2013 click graph to view data in table format










Income






Age Distribution of People in Hawaii County, Hawaii in 2009-2013






Foreign born residents of Honolulu County, Hawaii come from different parts of the world.

Region of Birth for the Foreign Born Population in Honolulu County, Hawaii in 2009-2013 click graph to view data in table format














Age Distribution of People in Honolulu County, Hawaii in 2009-2013



Region of Birth for the Foreign Born Population in Kalawao County, Hawaii in 2009-2013 click graph to view data in table format












Age Distribution of People in Kalawao County, Hawaii in 2009-2013




Foreign born residents of Kauai County, Hawaii come from different parts of the world.

Region of Birth for the Foreign Born Population in Kauai County, Hawaii in 2009-2013 click graph to view data in table format




Language



In 2009-2013, 88 percent of the people at least one year old living in Kauai County, Hawaii were living in the same residence one year earlier.






Education

labor force.



Percent by Industry in Kauai County, Hawaii in 2009-2013 click graph to view data in table format






Commuting to Work




Income




Health Insurance


Age Distribution of People in Kauai County, Hawaii in 2009-2013






Foreign born residents of Maui County, Hawaii come from different parts of the world.

Region of Birth for the Foreign Born Population in Maui County, Hawaii in 2009-2013 click graph to view data in table format







Percent by Industry in Maui County, Hawaii in 2009-2013 click graph to view data in table format














Age Distribution of People in Maui County, Hawaii in 2009-2013




