# STATE OF THE ECONOMY

Hawaii's major economic indicators were mostly positive in the third quarter of 2014. State general fund tax revenues, visitor arrivals, visitor expenditures, wage and salary jobs, personal income, and private building permits increased in the quarter as compared to the same quarter of 2013. However, Government contracts awarded decreased in the quarter.

After seventeen quarters of positive growth from the third quarter of 2009 to the third quarter of 2013, Hawaii's tourism sector experienced two quarters of negative growth from the fourth quarter of 2013 to the first quarter of 2014. In the second and third quarter of 2014, however, Hawaii's tourism sector returned to positive growth compared with the same quarter of 2013. In the third quarter of 2014, the total number of visitors arriving by air to Hawaii increased 33,509 or 1.6 percent. Due to shorter lengths of stay, the daily visitor census decreased in the quarter. However, since visitors spent more on a daily basis during the third quarter of 2014, the total spending by visitors arriving by air increased 1.2 percent in the quarter.

In construction, the government contracts awarded decreased, but the value of private building permits increased. In the third quarter of 2014, government contracts awarded decreased \$86.5 million, but the permit value for private construction increased \$101.2 million. The construction sector added 150 jobs compared with the same quarter of 2013. According to the most recent data available, current construction put-in-place based on excise tax data decreased \$168.7 million or 8.7 percent in the second quarter of 2014 compared with the same quarter of 2013.

In the third quarter of 2014, State general fund tax revenues were up \$36.0 million or 2.7 percent over the same period of 2013. As an indicator of current economic activity, state general excise tax revenue increased \$55.8 million or 8.0 percent in the third quarter of 2014 compared to the same quarter in 2013. For the first three quarters of 2014, State general fund tax revenues decreased \$44.3 million or 1.1 percent, and the state general excise tax revenue increased \$28.7 million or 1.3 percent, compared with the same period last year.

The labor market conditions were positive. After ten consecutive quarterly decreases in jobs from the second quarter of 2008 to the third quarter of 2010, Hawaii's jobs increased for the 16<sup>th</sup> quarter. In the third quarter of 2014 Hawaii's civilian non-agricultural wage and salary jobs averaged 621,200 jobs, an increase of 7,950 jobs or 1.3 percent from the same quarter of 2013.

The job increase in the third quarter of 2014 was due to job increases in both the private sector and the government sector. In this quarter, the private sector added about 6,450 non-agricultural jobs compared to the third quarter of 2013. Jobs increased the most in Professional & Business Services, adding 1,750 jobs or 2.2 percent; followed by Food Services and Drinking Places, adding 1,350 jobs or 2.2 percent, Transportation, Warehousing & Utilities, adding 850 jobs or 2.9 percent, Accommodation, adding 850 jobs or 2.2 percent, Health Care & Social Assistance, adding 650 jobs or 1.0 percent, and Financial Activities, adding 550 jobs or 2.0 percent in the quarter. In this quarter, Information lost 600 jobs, Retail Trade and Arts, Entertainment & Recreation both lost 100 jobs compared to the same quarter of 2013. During the third quarter of 2014, the three levels of government added 1,500 jobs or 1.3 percent compared to the same quarter of 2013. The Federal Government lost 550 jobs; the State Government added 2,100 jobs, while Local Government lost 50 jobs compared to the same quarter of 2013.

The most recent data from the U.S. Bureau of Economic Analysis (BEA) shows that Hawaii's total nominal annualized personal income in the second quarter of 2014 increased \$2,400.6 million or 3.8 percent from the same quarter of 2013. This increase includes inflation so the growth of real personal income was smaller. The increase in nominal personal income during the second quarter of 2014 was due to increases in all major components of personal income. In dollar terms, the largest increases occurred in wage and salary disbursements, followed by personal current transfer receipts, dividends, interest, and rent, supplements to wage and salaries, which include retirement and unemployment insurance benefits, and proprietors' income. For the first half of 2014, total annualized personal income was \$65,294.9 million, an increase of 3.7 percent from the same period last year.

Consumer prices in Honolulu increased 1.1 percent in the first half of 2014 compared with the same period of 2013, as measured by the Honolulu Consumer Price Index for Urban Consumers (CPI-U). In contrast, the U.S. CPI-U increased 1.7 percent in the first half of 2014. In 2013, the Honolulu CPI-U increased 1.8 percent from the previous year. In the first half of 2014, the Honolulu CPI-U increased the most in the price index of Education and Communication (2.7 percent), followed by Recreation (2.5 percent), Transportation (2.1 percent), Medical Care (1.4 percent), Food & Beverages (1.0 percent), Housing (0.9 percent), and Other Goods and Services (0.8 percent). The price of Apparel decreased 5.9 percent, compared to the first half of 2013.

# **OUTLOOK FOR THE ECONOMY**

Based on the most recent developments in the national and global economies, the performance of Hawaii's tourism industry, the labor market conditions, and growth of personal income and tax revenues, Hawaii's economy is expected to continue positive growth for the rest of 2014 and into 2015. Overall, the current DBEDT forecast is more optimistic compared with the previous forecast.

Hawaii's economy depends significantly on conditions in the U.S. economy and key international economies, especially Japan. According to the November 2014 *Blue Chip Economic Consensus Forecasts*, U.S. real GDP is expected to increase by 2.2 percent in 2014 as a whole, 0.1 of a percentage point higher than the 2.1 percent growth rate projected in the August 2014 forecast. For 2015 the consensus forecast now expects an overall 3.0 percent growth in U.S. real GDP, the same as the August 2014 forecast.

According to the November 2014 *Blue Chip Economic Consensus Forecast*, real GDP growth for Japan is now expected to increase 0.9 percent in 2014, 0.5 of a percentage point lower than the 1.4 percent growth rate projected in the August 2014 forecast. For 2015, the consensus forecast now expects an overall 1.3 percent growth in Japanese real GDP, same as the August 2014 forecast.

For the local economy, DBEDT expects some of the economic indicators will grow at a faster rate than that of the previous forecast, and some other economic indicators will grow at the same growth rate projected in the previous forecast.

Overall, Hawaii's economy measured by real GDP, is projected to show a 2.6 percent increase in 2014, the same as the growth rate forecasted last quarter. Real GDP growth in 2015 is expected at 2.8 percent, 0.6 of a percentage point higher than the growth rate forecasted last quarter.

Hawaii's unemployment rate is projected to be 4.4 percent in 2014 and 4.1 percent in 2015, the same as the previous forecast.

Visitor arrivals are expected to increase 0.8 percent in 2014, 0.1 of a percentage point higher than the previous forecast. The forecast for visitor days in 2014 decreased 0.5 of a percentage point to 0.3 percent. The forecast for visitor expenditure in 2014 is revised upward to 2.7 percent, from 2.6 percent growth projected in the previous forecast. For 2015, the growth rates of visitor arrivals, visitor days, and visitor expenditures are now expected to be 1.9 percent, 2.2 percent, and 3.6 percent, respectively.

The projection for non-agricultural wage and salary job growth rate in 2014 is 1.3 percent, 0.1 of a percentage point higher than the previous forecast. In 2015, jobs are projected to increase 1.5 percent, also same as the previous forecast.

The Honolulu Consumer Price Index (CPI), which increased 1.8 percent in 2013, is now expected to increase 1.5 percent in 2014, the same as the previous forecast. In 2015, the CPI is projected to increase 2.2 percent, also the same as the previous forecast.

Personal income in current dollars is now expected to increase 4.0 percent in 2014, the same as the previous forecast. Real personal income is currently projected to grow 2.6 percent in 2014, also the same as the previous forecast. In 2015, current-dollar personal income and real personal income are expected to increase 4.5 percent and 2.5 percent, respectively.

Beyond 2015, the economy will be on an expansion path, with job growth expected to increase 1.4 percent in 2016 and 1.3 percent in 2017. Visitor arrivals are expected to increase 1.9 percent in 2016 and 2017. Visitor expenditures are expected to increase 4.6 percent in 2016 and 4.2 percent in 2017. Real personal income is projected to increase 2.3 percent in 2016 and 2.0 percent in 2017. Hawaii's real GDP growth is expected to increase 2.5 percent in 2016 and 2.2 percent in 2017. The unemployment rate is expected to decrease to 3.8 percent in 2016 and 3.5 percent in 2017.

## COUNTY ECONOMIC CONDITIONS

Overall economic conditions were mostly positive across the counties in the third quarter of 2014. The unemployment rate decreased in all counties and total non-agricultural wage and salary jobs increased in all counties. Total visitor arrivals by air increased in Honolulu, remained about the same in Hawaii County and Maui, but decreased in Kauai. The value of private building permits increased in all counties in the quarter.

In the third quarter of 2014, the unemployment rate in all counties decreased. The unemployment rate in Honolulu decreased 0.4 of a percentage point from 4.4 percent to 4.0 percent; the unemployment rate in Maui County decreased 0.7 of a percentage point from 5.1 percent to 4.4 percent; the unemployment rate in Hawaii County decreased 1.1 percentage point from 6.7 percent to 5.6 percent; and the unemployment rate in Kauai County decreased 0.6 of a percentage point from 5.5 percent to 4.9 percent.

In the third quarter of 2014, Honolulu gained 4,550 or 1.0 percent of non-agricultural wage and salary jobs over the same quarter of 2013. Food Services and Drinking Places added the most jobs in the quarter (1,150 jobs), followed by Health Care & Social Assistance (950 jobs), Transportation, Warehousing, and Utility (700 jobs), Financial Activities (550 jobs), and Accommodation (550 jobs). The Government sector added 900 jobs. The largest private sector job losses occurred in Retail Trade (lost 900 jobs), followed by Information (lost 400 jobs, and Natural Resources, Mining, and Construction (lost 300 jobs).

In the third quarter of 2014, Hawaii County gained 1,400 non-agricultural wage and salary jobs or 2.2 percent over the same quarter of 2013. Professional and Business Services added the most jobs in the quarter (450 jobs), followed by Natural Resources, Mining, and Construction (300 jobs), Retail Trade (200 jobs), Wholesale Trade (150 jobs), and Educational Services (150 jobs). Manufacturing lost 150 jobs, and Information and Health Care & Social Assistance each lost 100 jobs in the quarter. In the third quarter of 2014, Government added 400 jobs.

Maui County saw a net gain of 1,450 jobs or a 2.1 percent increase in the third quarter of 2014 over the same quarter of 2013. Job gains in Professional and Business Services (600 jobs), Retail Trade (500 job), and Accommodation (350 jobs) exceeded job losses in Other Services (lost 200 jobs), Health Care & Social Assistance (lost 200 jobs), and Information (lost 100 jobs). Government added 150 jobs in the quarter.

In the third quarter of 2014, Kauai County gained 300 wage and salary jobs or 1.0 percent from the same quarter of 2013. Professional and Business Services added 200 jobs, followed by Retail Trade (150 jobs). Health Care & Social Assistance and Accommodation each lost 100 jobs in the quarter. In this quarter, Government gained 200 jobs.

In the third quarter of 2014, visitor arrivals by air increased in Honolulu, remained about the same in Hawaii County and Maui, but decreased slightly in Kauai. Visitor arrivals by air increased 1.5 percent in Honolulu, and decreased 0.2 percent in Kauai. Visitor days increased 0.1 percent in Hawaii County, but decreased 0.7 percent, 1.7 percent, and 2.2 percent, respectively in Honolulu, Maui, and Kauai, compared to the same quarter of 2013. According to the most recent data available, in the second quarter of 2014, the hotel occupancy rate decreased in Honolulu and Maui, but increased in Hawaii and Kauai. The hotel occupancy rate was the highest in Honolulu (at 81.6 percent and decreased 0.4 of a percentage point), followed by Kauai (at 69.4 percent and increased 2.6 percentage points), Maui (at 69.0 percent and decreased 1.0 percentage point), and Hawaii County (at 56.4 percent and increased 1.1 percentage point in the quarter).

In the third quarter of 2014, the growth rates of the values of total private building permits were positive in all counties. In this quarter, private building permits increased \$51.1 million or 10.4 percent in Honolulu; increased \$24.8 million or 21.7 percent in Hawaii County; increased \$23.1 million or 40.5 percent in Maui, and increased \$2.2 million or 8.9 percent in Kauai from the same quarter of the previous year.

# A. LABOR FORCE AND JOBS

Hawaii's labor market conditions continued to improve in the third quarter of 2014. Since the civilian labor force increased less than the civilian employment, the civilian unemployment rate decreased 0.5 of a percentage point in the quarter. For the 16<sup>th</sup> consecutive quarter, civilian nonagricultural wage and salary jobs increased.

In the third quarter of 2014, the civilian labor force averaged 666,250 people, an increase of 17,750 people or 2.7 percent from the same quarter of 2013 (Table A-1). For the first three quarters of 2014, the civilian labor force increased 13,750 people or 2.1 percent from the same period last year.

Civilian employment totaled 637,600 people in the third quarter of 2014, an increase of 20,300 people or 3.3 percent compared to the same quarter of 2013 (Table A-2). This is the eighth quarterly increase following three consecutive quarterly decreases from the first quarter of 2012 to the third quarter of 2012. For the first three quarters of 2014, average civilian employment increased 15,750 people or 2.6 percent from the same period last year.

In the third quarter of 2014, the number of civilian unemployed averaged 28,700, a decrease of 2,500 people or 8.0 percent from the same quarter of 2013 (Table A-3). For the first three quarters of 2014, the number of unemployed decreased 2,050 people or 6.5 percent from the same period last year.

The unemployment rate (not seasonally adjusted) decreased from 4.8 percent in the third quarter of 2013 to 4.3 percent in the third quarter of 2014 (Table A-4). For the first three quarters of 2014, the unemployment rate decreased 0.4 of a percentage point from the same period last year.

In the third quarter of 2014, Hawaii's civilian non-agricultural wage and salary jobs averaged 621,200 jobs, an increase of 7,950 jobs or 1.3 percent from the same quarter of 2013 (Table A-6). This is the 16<sup>th</sup> consecutive quarterly increase in non-agricultural wage and salary jobs

after ten consecutive quarterly decreases in jobs since the second quarter of 2008. For the first three quarters of 2014, average non-agricultural wage and salary jobs increased 1.2 percent or 7,500 jobs from the same period last year.

The job increase in the third quarter of 2014 was due to job increases in both the private sector, especially the visitor-related industries, and the government sector. In this quarter, the private sector added about 6,450 non-agricultural jobs compared to the third quarter of 2013. Jobs increased the most in Professional & Business Services, adding 1,750 jobs or 2.2 percent (Table A-14)); followed by Food Services and Drinking Places, adding 1,350 jobs or 2.2 percent (Table A-19), Transportation, Warehousing & Utilities, adding 850 jobs or 2.9 percent (Table A-11), Accommodation, adding 850 jobs or 2.2 percent (Table A-18), Health Care & Social Assistance, adding 650 jobs or 1.0 percent, and Financial Activities, adding 550 jobs or 2.0 percent (Table A-13) in the quarter.

In the third quarter of 2014, in the private sector, Information lost 600 jobs (Table A-12), Retail Trade (Table A-10) and Arts, Entertainment & Recreation both lost 100 jobs (Table A-17) compared to the same quarter of 2013.

During the third quarter of 2014, the three levels of government added 1,500 jobs or 1.3 percent (Table A-21) compared to the same quarter of 2013. The Federal Government lost 550 jobs or 1.6 percent (Table A-22); the State Government added 2,100 jobs or 3.1 percent (Table A-23), while the Local Government lost 50 jobs or 0.3 percent (Table A-24) compared to the same quarter of 2013.

The initial liable claims for unemployment, which measures the number of people who lost jobs in Hawaii and moved to other states, decreased 10.0 percent in the third quarter of 2014 compared to the same quarter of 2013 (Table A-27). For the first three quarters of 2014, the initial liable claims for unemployment increased 5.3 percent from the same period last year.

# **B. INCOME AND PRICES**

Hawaii's total personal income increased during the second quarter of 2014 over the same quarter of 2013, all major components of personal income increased in the quarter. In dollar terms, the largest increases occurred in wage and salary disbursements, followed by personal current transfer receipts, dividends, interest, and rent, supplements to wage and salaries, which include retirement and unemployment insurance benefits, and proprietors' income (Table B-1).

In the second quarter of 2014, total nominal annualized personal income (i.e., not adjusted for inflation) increased \$2,400.6 million or 3.8 percent from the second quarter of 2013 (Table B-2). For the first half of 2014, total annualized personal income was \$65,294.9 million, for an increase of 3.7 percent from the same period last year.

In the second quarter of 2014, wage and salary disbursements increased \$1,053.0 million or 3.3 percent from the second quarter of 2013. This was the sixteenth quarterly year-over-year increase since the third quarter of 2010. For the first half of 2014, wage and salary disbursements increased 3.0 percent from the same period last year (Table B-3).

Supplements to wages and salaries, consisting of employer payments to retirement plans, private group health insurance plans, private workers compensation plans, and other such benefits, increased \$261.2 million or 2.8 percent in the second quarter of 2014 from the same quarter of 2013 (Table B-4). For the first half of 2014, supplements to wages and salaries increased 2.9 percent from the same period last year.

Proprietors' income increased \$159.2 million or 3.3 percent in the second quarter of 2014 over that of 2013 (Table B-5). For the first half of 2014, proprietors' income was up 2.8 percent from the same period last year.

Dividends, interest, and rent increased \$471.3 million or 3.5 percent in the second quarter of 2014 from the same quarter of 2013. For the first half of 2014, income in this category was up 3.8 percent from the same period last year (Table B-6).

The annualized personal current transfer receipts grew by \$692.0 million or 7.1 percent in the second quarter of 2014 from the same quarter of 2013 (Table B-7). For the first half of 2014, personal current transfer receipts increased 7.1 percent over the same period last year.

Contributions to government social insurance, which is subtracted from total personal income, increased \$236.0 million or 4.4 percent in the second quarter of 2014, compared to the second quarter of 2013. For the first half of 2014, contributions to government social insurance increased 4.3 percent from the same period last year (Table B-8).

In the second quarter of 2014, total non-farm private sector annualized earnings increased \$1,172.4 million or 3.8 percent from the second quarter of 2013. In dollar terms, the largest increase occurred in accommodation and food services, followed by health care and social assistance, administrative and waste services, professional and services. transportation technical and warehousing. In the private sector, only finance and insurance had decreased earnings in the second quarter of 2014. During the second quarter of 2014, total government earnings increased \$276.5 million or 2.0 percent from the same quarter of 2013. Earnings from the federal government decreased \$60.7 million or 0.7 percent in the second guarter of 2014. Earnings from the state and local governments increased \$337.2 million or 5.8 percent in the quarter.

In the first half of 2014, Honolulu's Consumer Price Index for Urban Consumers (CPI-U) increased 1.1 percent from the same period in 2013, lower than the U.S. average CPI-U increase of 1.7 percent for the same period (Table B-9). In 2013, the Honolulu CPI-U increased 1.8 percent from the previous year. In the first half of 2014, the Honolulu CPI-U increased the most Education and Communication (2.7 percent), followed by Recreation (2.5 percent), Transportation (2.1 percent), Medical Care (1.4 percent), Food & Beverages (1.0 percent), Housing (0.9 percent), and Other Goods and Services (0.8 percent). The price of Apparel decreased 5.9 percent, compared to the first half of 2013.

## C. TAX REVENUES

The State general fund tax revenues increased in the third quarter of 2014 compared to the same quarter of 2013.<sup>1</sup> The small decrease in net Individual Income Tax revenues and Net Corporate Income Tax revenues were more than offset by increases in GET and Transient Accommodations Tax (TAT) revenues in the quarter.

In the third quarter of 2014, total tax collections distributed to the State general fund totaled \$1,347.1 million, an increase of \$36.0 million or 2.7 percent over the same quarter of 2013 (Tables C-1 and C-2). For the first three quarters of 2014, State general fund tax revenues were down \$44.3 million or 1.1 percent over the same period last year.

During the third quarter of 2014, GET revenues (excluding the Honolulu County Surcharge) totaled \$754.5 million, an increase of \$55.8 million or 8.0 percent over the same quarter of 2013 (Table C-3). For the first three quarters of 2014, GET revenues increased \$28.7 million or 1.3 percent from the same period last year.

Compared to the third quarter of 2013, Net Individual Income Tax revenues decreased \$0.8 million or 0.2 percent to \$453.2 million in the third quarter of 2014 (Table C-4). In the third quarter of 2014, Declaration of Estimated Taxes decreased \$31.0 million or 32.8 percent (Table C-5); Payments with Returns increased \$2.6 million or 19.3 percent (Table C-6); Revenues from Withholding Tax on Wages increased \$24.1 million or 6.2 percent (Table C-7); and Refunds decreased \$3.4 million or 8.0 percent (Table C-8). For the first three quarters of 2014,

Net Individual Income Tax collections remained about the same from the same period last year.

Net Corporate Income Tax revenues, which tend to be volatile in nature, decreased \$23.9 million in the third quarter of 2014 compared to the same quarter of 2013 (Table C-9). In the third quarter of 2014, the Declaration of Estimated Taxes decreased \$27.3 million or 53.2 percent (Table C-10), the Payment with Returns decreased \$1.9 million or 46.7 percent (Table C-11), and the Refunds decreased \$5.3 million or 33.3 percent (Table C-12), compared with the same quarter of 2013. For the first three quarters of 2014, Net Corporate Income Tax revenues decreased \$72.2 million or 60.7 percent from the same period last year.

In the third quarter of 2014, Transient Accommodations Tax (TAT) revenues increased \$8.6 million or 8.7 percent compared to the same quarter of 2013 (Table C-13). For the first three quarters of 2014, TAT revenues increased \$19.1 million or 6.4 percent from the same period last year.

According to the most recent data available, in the second quarter of 2014, the Retailing tax base increased 7.6 percent or \$576.0 million (Table C-14), the Services tax base increased 2.7 percent or \$94.2 million (Table C-15), the Contracting tax base decreased 8.7 percent or \$168.7 million (Table C-16), and the Hotel Rentals tax base increased 6.6 percent or \$67.0 million (Table C-17), compared to the same quarter of 2013. For the first half of 2014, only the Contracting tax base decreased 7.5 percent; the Retailing tax base, the Services tax base, and the Hotel Rentals tax base increased 10.0 percent. 6.9 percent, and 10.1 respectively, from the same period last year.

### D. TOURISM

After seventeen quarters of positive growth from the third quarter of 2009, to the third quarter of 2013, with especially strong growth in 2012. Hawaii's tourism sector experienced two consecutive quarters of negative growth in the fourth quarter of 2013 and the first quarter of 2014. However, in the second and third quarter of 2014, Hawaii's tourism sector returned to positive growth compared with the same quarters in 2013. Both domestic and international visitor arrivals increased in the third quarter. Due to shorter lengths of stay, the daily visitor census decreased in the quarter. However, since visitors spent more on a daily basis during the third quarter of 2014, total visitor spending increased in the quarter.

The total number of visitors arriving by air to Hawaii increased 33,509 or 1.6 percent in the third quarter of 2014, compared to the same quarter of 2013 (Tables D-1 and D-2). The total average daily census was down 2,131 or 1.0 percent in the quarter. For the first three quarters of 2014, total visitor arrivals by air increased 55,003 or 0.9 percent, while the average daily census decreased 144 or 0.1 percent from the same period of last year.

In the third quarter of 2014, total visitor arrivals on domestic flights increased 27,435 or 2.0 percent compared to the same quarter of 2013 (Table D-3). This follows a 0.2 percent increase in the third quarter of 2013 over 2012. For the first three quarters of 2014, domestic arrivals were down 13,525 or 0.3 percent from the same period last year.

Arrivals on international flights increased 6,074 or 0.9 percent in the third quarter of 2014 compared to the third quarter of 2013 (Table D-4). For the first three quarters of 2014, international arrivals were up 68,528 or 3.6 percent from the same period in 2013.

In terms of major market areas, from the third quarter of 2013 to the same period of 2014, arrivals from the U.S. West increased 36,537 or 4.4 percent (Table D-5); arrivals from the U.S. East decreased 4,031 or 0.9 percent (Table D-6); and arrivals from Japan decreased 10,294 or 2.4 percent (Table D-7). For the first three quarters of 2014, arrivals from U.S. West were down 13,049 or 0.5 percent; arrivals from the U.S. East were down 4,312 or 0.3 percent; and Japanese

arrivals were up 4,215 or 0.4 percent from the same period last year.

Due to shorter lengths of stay, the average total daily visitor census decreased in the quarter. The total average daily visitor census was down 1.0 percent or 2,131 visitors per day in the third quarter over the same quarter of 2013 (Table D-8). The domestic average daily census increased 0.5 percent or 697 visitors per day (Table D-9), while the international average daily census decreased 5.1 percent or 2,827 visitors per day (Table D-10). For the first three quarters of 2014, the domestic average daily census decreased 539 or 0.4 percent; and the international average daily census increased 395 or 0.7 percent from the same period last year.

Nominal visitor expenditures by air totaled \$3,688.1 million in the third quarter of 2014, up 1.2 percent or \$43.2 million from the same quarter of 2013 (Table D-11). For the first three quarters of 2014, visitor expenditures increased \$230.7 million or 2.1 percent compared with the same period last year.

Total airline capacity, as measured by the number of available seats flown to Hawaii, increased 4.2 percent or 118,136 seats (Table D-12) in the third quarter of 2014; domestic seats increased 7.6 percent or 144,285 seats (Table D-13); international seats decreased 2.9 percent or 26,149 seats (Table D-14), compared to the same quarter of 2013. For the first three quarters of 2014, the number of total available seats increased 2.8 percent or 229,491 seats from the same period last year.

According to the most recent data available, in the second quarter of 2014, the statewide hotel occupancy rate averaged 74.0 percent, 0.2 of a percentage point lower than that of the same quarter of 2013 (Table D-15). For the first half of 2014, the statewide hotel occupancy rate averaged 77.3 percent, 0.7 of a percentage point lower than that of the previous year.



#### E. CONSTRUCTION

The indicators of Hawaii's construction industry were mixed in the third quarter of 2014. The value of private building authorizations and construction jobs increased, but Government contracts awarded decreased in the quarter.

Construction was one of the major contributors to job growth in Hawaii over the past few years. From 2002 to 2007, construction job growth averaged 8.0 percent per year. In the fourth quarter of 2007, the average number of construction jobs reached a peak of 40,000 jobs. Since the second quarter of 2008, however, the quarter-over-quarter growth rate of construction jobs has been negative in all quarters until the third quarter of 2011. In the third quarter of 2014, the construction sector added 150 jobs or 0.5 percent compared with the same quarter of 2013. For the first three quarters of 2014, the construction sector lost 50 jobs or 0.2 percent (Table A-7) from the same period last year.

In the third quarter of 2014, the private building authorizations for the whole state increased \$101.2 million or 14.7 percent compared with the third quarter of 2013 (Table E-8). For the first three quarters of 2014, private building authorizations for the state increased \$332.9 million or 15.9 percent compared with the same period last year.

In the third quarter of 2014, the private building authorizations in Honolulu increased \$51.1 million or 10.4 percent compared with the third quarter of 2013 (Table E-8). For the first three quarters of 2014, private building authorizations in Honolulu increased \$84.7 million or 6.0 percent compared with the same period of last year.

In the third quarter of 2014, the private building authorizations in Hawaii County increased \$24.8 million or 21.7 percent compared with the third quarter of 2013 (Table E-8). In the first three quarters of 2014, private building authorizations in Hawaii County increased \$157.1 million or 50.0 percent compared with the previous year.

In the third quarter of 2014, the private building authorizations in Maui increased \$23.1 million or 40.5 percent compared with the third quarter of 2013 (Table E-8). For the first three quarters of 2014, private building authorizations in Maui increased

\$71.0 million or 27.7 percent compared with the same period last year.

In the third quarter of 2014, the private building authorizations in Kauai increased \$2.2 million or 8.9 percent compared with the third quarter of 2013 (Table E-8). For the first three quarters of 2014, private building authorizations in Kauai increased \$10.2 million or 17.1 percent compared with the same period last year.

Government contracts awarded decreased \$86.5 million or 18.0 percent in the third quarter of 2014 compared to the same quarter of 2013. For the first three quarters of 2014, government contracts awarded decreased \$239.3 million or 22.1 percent compared with the same period last year (Table E-1). State Government CIP expenditures increased \$78.3 million or 28.4 percent in the second quarter of 2014 (Table E-2). For the first half of 2014, CIP expenditures increased \$125.9 million or 22.0 percent from the same period last year.

The Honolulu Construction Cost Indexes increased 7.4 percent for Single Family Residence (Table E-6) and increased 7.3 percent for High-Rise Building (Table E-7) in the second quarter of 2014 over that of 2013.

In the first three quarters of 2014, Honolulu's median price for single family resales was \$669,500, an increase of \$29,239 or 4.6 percent from the same period of 2013 (Table E-9); the median price for condominium units was \$350,000, an increase of \$18,000 or 5.4 percent from the same period of 2013 (Table E-10). In the third quarter of 2014, the number of single-family unit resales was down 1.9 percent, and the number of condominium unit resales was down 0.3 percent compared with the third quarter of 2013 (Tables E-11 and E-12). For the first three quarters of 2014, the number of single-family unit resales was up 0.2 percent, and the number of condominium unit resales was up 0.7 percent compared with the same period last year.

In the third quarter of 2014, single-family unit resales increased 1.5 percent, and condominium unit resales decreased 25.7 percent in Maui County compared to the same quarter of 2013 (Tables E-17 and E-18).

# F. OTHER INDICATORS

The total number of bankruptcy filings in Hawaii decreased 11.7 percent or by 59 cases for the third quarter of 2014 from the same quarter of 2013. This was the 15th quarter-over-quarter decrease since the first quarter of 2011. For the first three quarters of 2014, total filings decreased 17.6 percent or 288 cases from the same period last year.

The number of Chapter 7 filings, the largest category, with a decrease of 17.9 percent or 67 cases in the third quarter of 2014. Chapter 7 filings are intended to liquidate assets and discharge debt. For the first three quarters of 2014, Chapter 7 filings were down 22.8 percent or 278 cases from the same period last year.

Chapter 11 filings decreased from 7 cases in the third quarter of 2013 to 3 cases in the third quarter of 2014. For the first three quarters of

2014, Chapter 11 filings decreased to 7 cases from 17 cases in the same period last year. Chapter 11 filings involve the structuring of repayment plans for companies.

Chapter 13 filings in the third quarter of 2014 increased 9.7 percent or 12 cases from the third quarter of 2013. For the first three quarters of 2014, Chapter 13 filings remained the same from the same period last year. Chapter 13 bankruptcy allows debtors to work out repayment arrangements with creditors.
