4/ The Urban Honolulu MSA consists of the City and County of Honolulu, comprising Oahu and the Northwestern Hawaiian Islands (except Midway). It was previously known as Honolulu MSA. There were 381 metropolitan statistical areas in 2012.

5/ Metropolitan Statistical Areas (MSAs) contains a core urban area of 50,000 or more population.

6/ The Kahului-Wailuku-Lahaina MSA consists of Maui County (excluding Kalawao County)

7/ The City and County of Honolulu consists of Oahu and the Northwestern Hawaiian Islands (except Midway). There are 3,143 U.S. counties in 2010 and 2012.

8/ Among all 726 incorporated places with over 50,000 population in 2012.

9/ The Honolulu CDP used to consist of Honolulu District, comprising the area between Red Hill and Makapuu Point, south and southwest of the crest of the Koolau Mountains, and the Northwestern Hawaiian Islands (except Midway). In 2010, this CDP was split into three separate CDPs - Urban Honolulu, East Honolulu, and Hickam (a portion of the new CDP).

11/ In 2010, Kalawao County had the second lowest county population in the United States. The county with the lowest population was Loving, Texas with a population of 82. In 2012, Kalawao County again had the second lowest county population in the United States, with Loving Texas having the lowest population of 71 people.

13/ Micropolitan statistical areas contains an urban core of at least 10,000 (but less than 50,000) population. Hilo Micropolitan consists of Hawaii County and Kapaa Micropolitan consists of Kauai County. There were 536 micropolitan statistical areas in 2012.
