Hawaii Environmental Council EIS Rules Update Process Status Update – January 9, 2018

Overview

The Environmental Council is nearing the end of the first major stage of the rulemaking process to revise Hawaii Administrative Rules (HAR) Chapter 11-200, the Environmental Impact Statement (EIS) Rules. This process began in earnest in July 2017. Since July, the Council has released three separate drafts of the proposed EIS Rules. A fourth draft, version 0.4 (v0.4), is scheduled for release on January 31, 2018. The Council anticipates that decision making regarding v0.4 of the draft EIS Rules will occur at a meeting scheduled for February 20, 2018. If approved, v0.4 of the draft EIS Rules, as amended, would be requested to go to formal public hearings, likely to be scheduled in April of 2018.

Interested parties can also sign up for email updates on the rule revision process by registering on the EIS Rules Update website.

Public Comments

The Environmental Council has been actively soliciting public comments throughout the rulemaking process. The public comment period for v0.3 of the draft EIS Rules has been extended to January 12, 2018 (since its initial release on October 29, 2017). Comments received by January 12, 2018 will be considered and incorporated into v0.4 of the draft EIS Rules, as appropriate. Comments submitted after January 12, 2018 may not be considered during the drafting of v0.4 of the draft EIS Rules. However, comments that are submitted between January 13 and February 19, 2018 will be distributed to members of the Environmental Council for their consideration.

EIS Rules Package

Version 0.4 of the draft EIS Rules will include four distinct documents. Decision making at the February 20, 2018 meeting of the Environmental Council will consider all four documents as a package.

- An official clean copy of v0.4 of the draft EIS Rules (note, since HAR Chapter 11-200 will be completely reorganized and restated into HAR Chapter 11-200.1, the official copy of v0.4 will not contain any Ramseyer markups).
- 2. A detailed staff report that explains the rationale for the proposed changes to the EIS Rules.
- 3. An unofficial copy of v0.4 of the draft EIS Rules that highlights the changes between the existing EIS Rules and the draft EIS Rules.
- 4. A draft of the notice to be published for the public hearings.

Schedule

A schedule of major events is provided below, and can also be found at the EIS Rules Update website. Updates to the schedule will be posted on the website, and also distributed to the email list.

January 9, 2018	Environmental Council meeting. Agenda to include additional discussion of v0.3 of the draft EIS Rules.

February 6, 2018	Environmental Council meeting. Agenda to include presentation and discussion of v0.4 of the draft EIS Rules.
February 19, 2018	Deadline to submit comments regarding the draft EIS Rules for consideration by the Environmental Council.
February 20, 2018	Environmental Council meeting. Agenda to include decision making regarding approval of version 0.4 of the draft EIS Rules (as amended) for public hearings.

Proposed Decision Making Process

The February 20, 2018 meeting of the Environmental Council will start with discussion of v0.4 of the draft EIS Rules package, followed by an up-or-down vote to send the package out for public comment. If the vote does not pass by a majority of the Council, the floor will be open for amendments.

Council members who wish to propose amendments are expected to come to the meeting with prepared written amendments to the draft EIS Rules *and* suggested changes to the accompanying rationale document.

In order to determine the order in which amendments will be considered, each Council member will be given three minutes to present his/her proposed amendments, with no discussion or questions (additional time may be granted depending on schedule constraints). After all proposed amendments have been presented, Council members will decide the order in which the proposed amendments will be considered through a simple vote. The amendment with the most votes will be considered first.

The Council will then discuss and vote on v0.4 as amended with the first-considered amendment. If v0.4 as amended with the first-considered amendment does not pass, then the first amendment will be removed, and the second amendment will be considered in a similar fashion. All amendments will be considered individually until a majority of the Council votes yes to send v0.4 as amended out for public comment.

If the Council does not pass v0.4 after all the amendments have been considered individually, then the Chair will ask for a motion to consider a suggested combination of two or more amendments to v0.4. When a motion is made and seconded, then the Council will vote on v0.4 as amended with that combination of amendments. If v0.4 as amended by the first suggested combination of amendments does not pass, the Chair will request a motion to consider a second suggested combination of two or more amendments to v0.4, and the Council will vote on v0.4 as amended with that combination of amendments. This process will continue, as the schedule allows, until a majority of the Council approves v0.4 as amended of the draft EIS Rules to be sent for public comment.

If the Council does not approve any v0.4 rules package as amended, or the schedule prohibits all amendments from being considered before the Council reaches a decision on a satisfactory combination of amendments that it would approve by a majority, then the Council will decide whether to request a draft v0.5 be produced, or to continue considering combinations of amendments at its next scheduled Council meeting.
