  - d. Presentation to the Small Business Regulatory Review Board of repealing Chapter 11-200, HAR and promulgating Chapter 11-200.1, HAR;
  - e. Revisions to the unofficial Ramseyer version of Chapter 11-200.1, HAR to reflect the official version of Chapter 11-200.1, HAR; and

The executive session may only be held, however, upon an affirmative vote of two-thirds of the members preset, which must also be the majority of the members to which the board is entitled. The reason for holding the executive session shall be publicly announced and the vote of each member on the question of holding a meeting closed to the public shall be recorded and entered into the minutes of the meeting. HRS Sections 92-4, 92-5(a) and 92-7(a).
