Legislative Discussion

Ms. Nihipali distributed a legislative tracking list for *informational and discussion* purposes. The list is comprised of bills that may be of-interest to ORMP network agencies and includes bills that OP is tracking as well as bills submitted by other agencies.

ORMP Agency Updates and Announcements

PacIOOS representative, Fiona Langenberger shared that PacIOOS contributed to a project related to water flow and sediment monitoring on coral reefs. Maui County Planning Department representative, Jim Buika shared that the Department is procuring services to conduct a beach nourishment study for Kahana Bay, Maui as well as an analysis on the feasibility of offshore sand resources.

Kauai County Planning Department representative, Jody Galinato shared that the department is experiencing small successes with properties for retreat and redesign of structures via the shoreline ordinance. *Supports MP#1&2*

They are also providing assistance to a hui that will be undertaking a mangrove removal and fishpond restoration project. *Supports MP#7*

Kauai County shared a resource that provided guidance on appropriate landscaping methods for public plantings in Hawaii. Rick Barboza delivered training on native Hawaiian plants including low-water, water-cleaning, species that can be planted along shorelines. *Supports MP#1&2*

County of Honolulu Department of Planning & Permitting representative shared that the first meeting of the East Honolulu Climate Adaptation Study Group was held last week to discuss climate change and impacts on the area. Dolan Eversole provided a presentation on climate change impacts to the group. The discussion focused on soliciting a list of areas that the group would like to examine and focus on for increasing community resilience to impacts of sea level rise and coastal hazards. *Supports MP#1&2.*

On behalf of DPP, Bob Stanfield appeared on the program: Insights on PBS Hawaii – Climate Change. *The University of Hawaii's Sea Grant Program predicts Hawaii will become increasingly warmer and stormier, and will be at risk of more vector-borne and water-borne diseases, over the next few decades. The most drastic change may be the rise in sea levels, which scientists predict will be one to three feet higher by the time today's infants reach retirement. What does all of this mean for Hawaii's ecosystem and economy?*
