AGENDA ITEM 1: Call to Order

Mr. Kamana'o Mills called the meeting to order at 1:10 pm.

AGENDA ITEM 2: Approval of Meeting Minutes of May 27, July 15, and August 19, 2015

Ms. McEldowney informed board members that the meeting minutes of the May 27, July 15, August 19 and September 16 meetings had not yet been completed. The board deferred

approval of the May minutes. Ms. Delos Santos stated that she had prepared draft/abbreviated minutes for those meetings, and that they were available on the HBGN website.

AGENDA ITEM 3: Update on Status of Request to Change Name of downstream portion 'Īao Stream to Wailuku River

- a) Ms. Delos Santos reminded the board and guests that the US Board, since the request had been significantly modified, suggested that the Hawai'i Board send notification of changes to all interested parties to be sure that there were no objections to the changed application. Letters and/or emails were sent to anyone who submitted written (via postal letter or email) or verbal testimony on the case, informing them of the change and inviting them to submit any additional comments. Only one response was received, which was from EarthJustice, and was in support of the change to the application and of the revised stream extent to which the name change would apply. Ms. Delos Santos forwarded the communication to the US Board.
- b) Ms. Summer Kupau-Odo of EarthJustice provided oral comments to the Board in support of the amended name change request.
- c) Ms. Delos Santos notified the US Board that there had been no comments in opposition received, and so the U.S. Board informed Ms. Delos Santos that the name change would be placed on either the November 12, 2015 or December 10, 2015 US Board docket. A decision by the US Board can be expected shortly after that.
- d) The US Board will inform Ms. Delos Santos of the outcome of the US Board vote.

AGENDA ITEM 4: Update on status of board approval to recognize 'Ohe-o-Kapo as a variant name to 'Ohe'o Gulch (feature ID 362741)

Ms. Delos Santos informed the board that the variant name request had been submitted to the US Board, along with a notification of the citation used and an excerpt from the draft September 16, 2015 meeting minutes. She showed the Board and guests that the addition of the variant name to the US geographic names information system had already been added to the national database and was noted in the online record for 'Ohe'o Gulch.

AGENDA ITEM 5: Continued review of Maui Island place names for spelling and diacritical marks

Board members reviewed 27 names. Of those, 1 was determined to be non-Hawaiian, 4 were determined to require more research, 10 names were corrected, 11 names were determined to be already correct in the

GNIS and it was found that one name was no longer in the database – Office of Planning will follow up with the US Board for more information. Name decisions are shown on the following page. (Secretary will fill in details).

Ms. Silva requested that sources listed in the HBGN Style Guide be obtained or purchased for reference during meetings. Mr. Asuncion said that funds may be available, and that the Office of Planning would look into sources and costs for those items and report back at the next meeting.

Mr. Akana announced that Mr. Kamoia Quitevas of the Office of Hawaiian Affairs has offered the services of some of his staff to assist the Board in conducting research on those names requiring more research. Ms. Delos Santos will extract those names when the Board has finished with Maui and forward the data to him.

Names reviewed and decisions:

Of note:

Palaua Beach: PNH has name as Palaua Beach. HPN (Clark) has Palau‘ea. Ms. Rodrigues is familiar with area, and has only heard the beach referred to as Palaua. Decision to keep name as is, unless requested by public, in which case, will consider submitting Palau‘ea Beach as a variant name.
