Planning Context

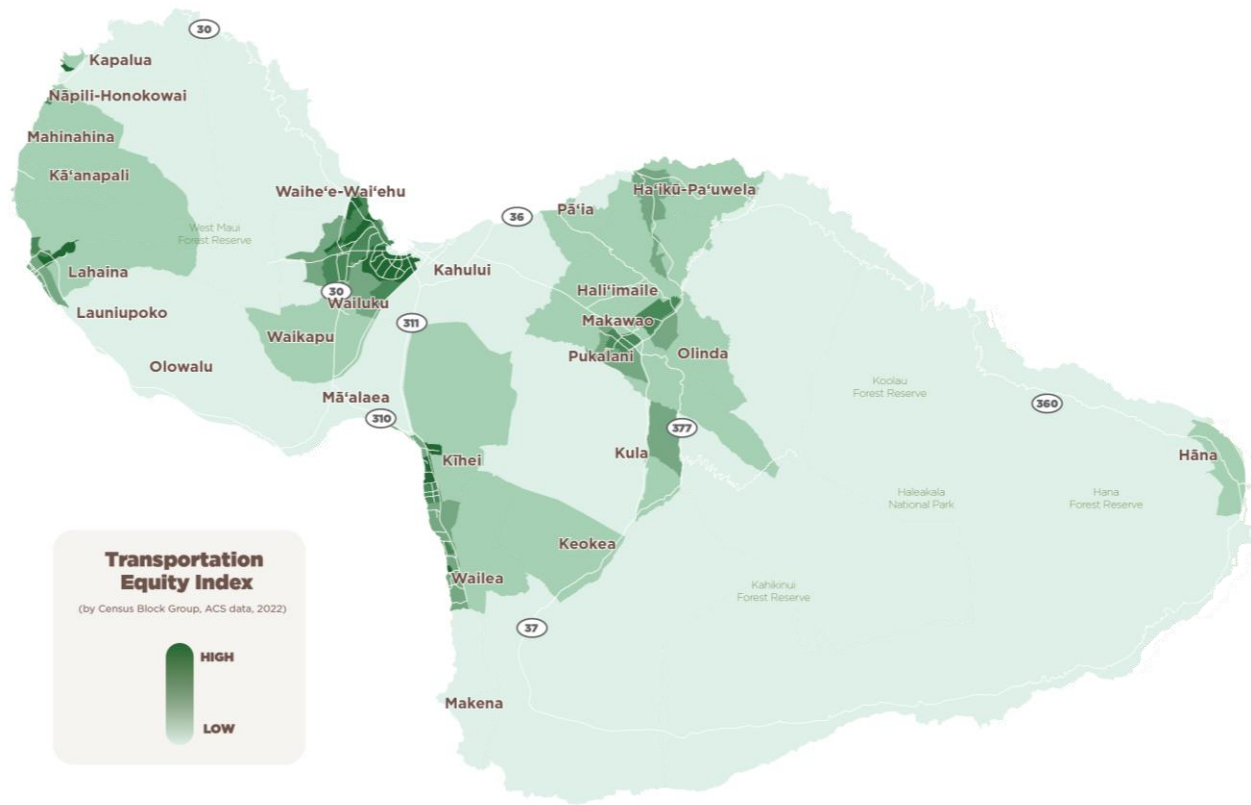
- Focus on resiliency, climate adaptation and mitigation, safe evacuation routes and more mobility options

Current Conditions

– Data Analysis

- As Maui continues to evolve, an understanding of demographic, economic, and transportation trends is essential to plan for the next 20 years
- LRTP update includes analysis of:
 - Maui's population
 - Housing
 - Employment
 - Travel trends
 - Transportation equity analysis (at right)



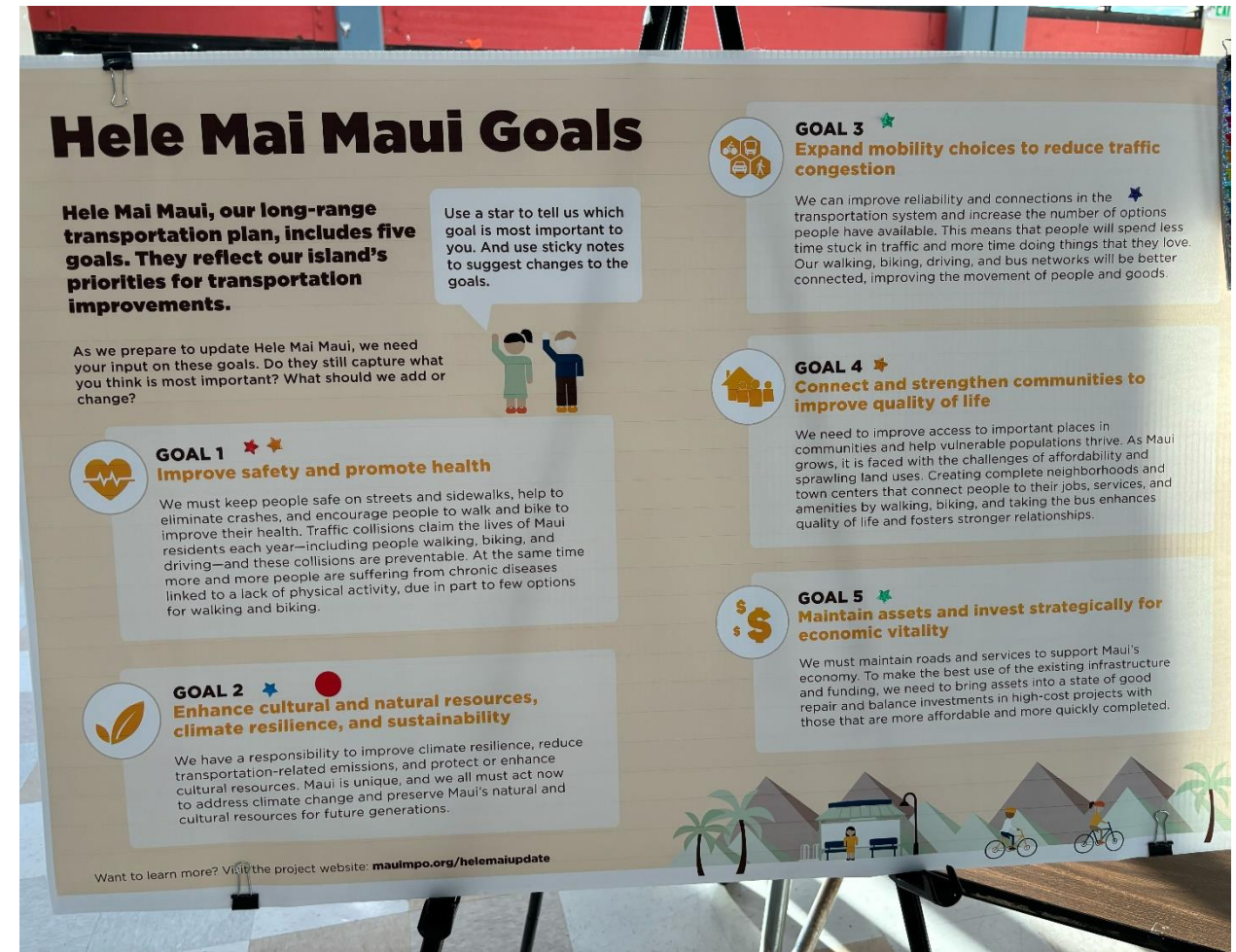
Public Outreach

- Hele Mai Maui 2045 relies on community input received through recent planning efforts rather than a standalone outreach process.
- Maui residents are currently participating in many planning processes, including those led by the Office of Recovery.
- Input on the LRTP is always welcome—it is a living document with continuous opportunities to comment on and amend the plan, as needed.



Public Outreach

- Hele Mai Maui 2045 is built on the engagement process used to develop Maui's FFY 2025-2028(+2) Transportation Improvement Program
- We gathered feedback via:
 - Maps, surveys
 - Workshops, focus groups
 - Email blasts, social media posts
 - Newspaper and radio coverage
 - Partner agency coordination

- 5th**  **Maintain assets and invest strategically for economic vitality**

- Projects from TIP
- Projects from County Capital Improvement Program
- High-priority projects from other plans

Long Term

Years 11-20

- Additional high-priority projects from other plans
- Medium-priority projects from other plans
- Higher cost projects

Illustrative

Unconstrained

- Longer-range transportation priorities that are outside the fiscal constraint





Review

- Public review occurred from 2/28/25 through 3/29/25
- Detailed review of cost estimates and phasing with DPW, MDOT and HDOT
- Comments were documented and addressed in disposition (Appendix B)

What Changed?

- Recognition of HDOT's commitment to complete pedestrian and bicycle networks in the next 5 years as a result of Navahine Settlement

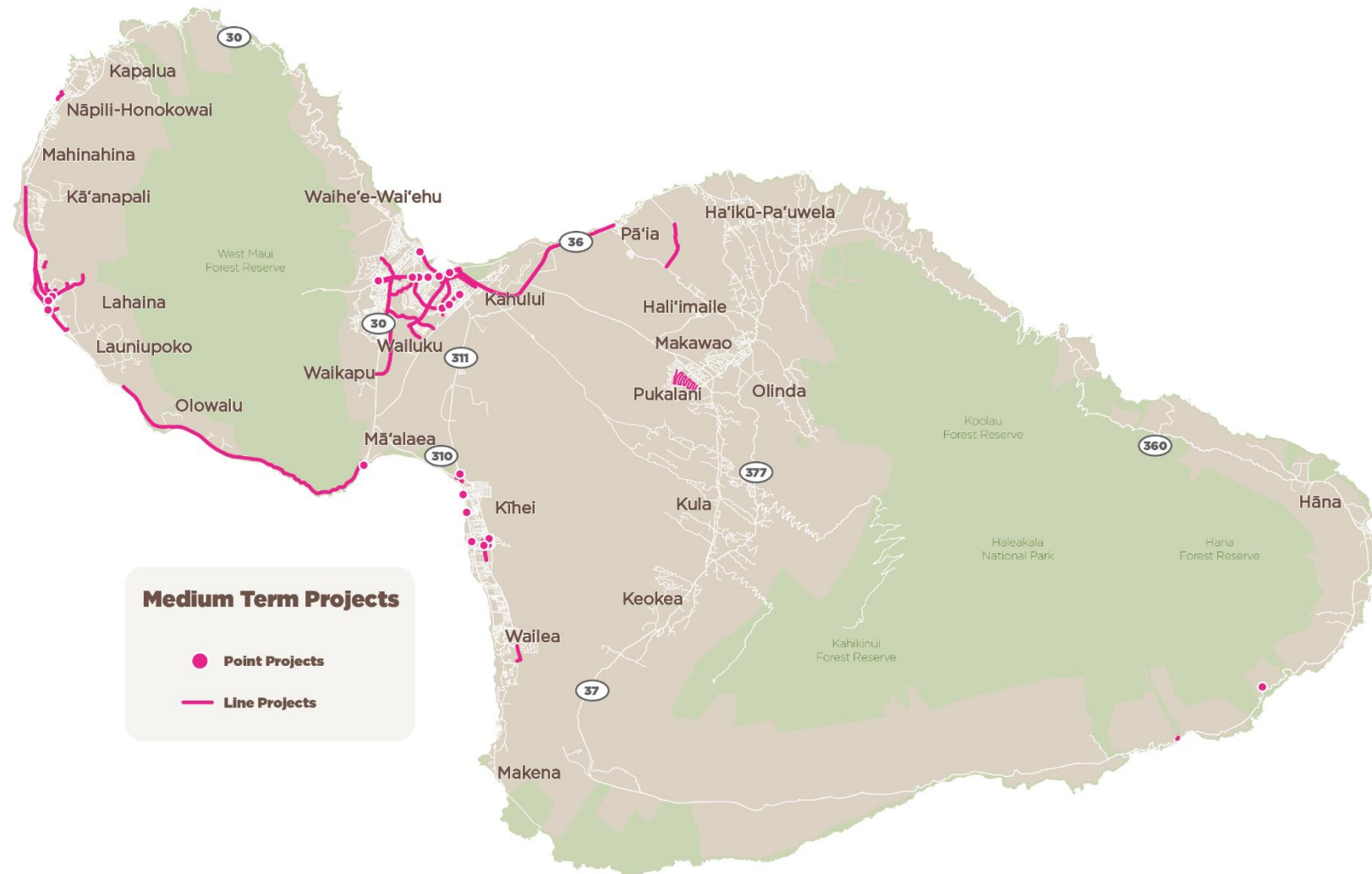

 Improve safety and promote health	+	Project provides safe, protected multimodal facilities and includes safety countermeasures, such as improved crossings
 Enhance climate resilience, sustainability, and cultural and natural resources	+	Project supports non-driving modes, increases resilient and flexible travel options, serves emergency vehicles, and improves overall mobility
 Expand mobility choices to reduce traffic congestion	+	Project includes improved access to transit to support improved travel time, supports safe local freight movements and connections, and includes facilities and connections for people walking, rolling, biking, taking the bus, and driving
 Connect and strengthen communities to improve quality of life	+	Project serves high-need areas, as defined by <i>Hele Mai Maui</i> 2045 equity assessment
 Maintain assets and invest strategically for economic vitality	+	Project includes pavement resurfacing and repair

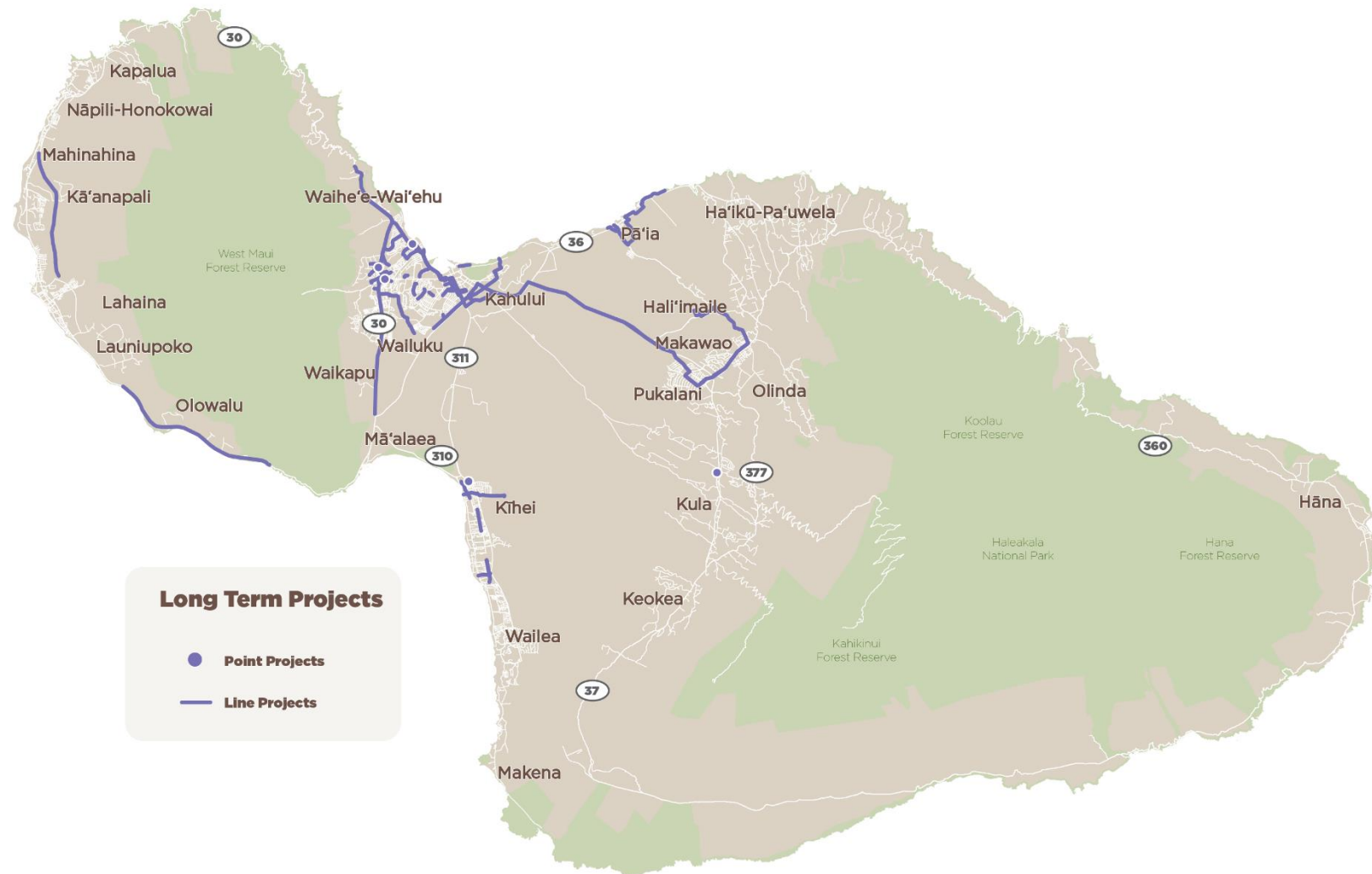

 Improve safety and promote health	+	Project provides multimodal facilities
 Enhance climate resilience, sustainability, and cultural and natural resources	+	Project supports non-driving modes and electric bus fleet and provides resiliency to support travel options and emergency needs, including evacuation
 Expand mobility choices to reduce traffic congestion	+	Project includes transit facilities that can help to improve transit transfers and travel times, as well as connections to transit for people walking, rolling, biking, and driving
 Connect and strengthen communities to improve quality of life	+	Project serves high-need areas, as defined by <i>Hele Mai Maui</i> 2045 equity assessment
 Maintain assets and invest strategically for economic vitality	+	Project improves and expands existing transit assets

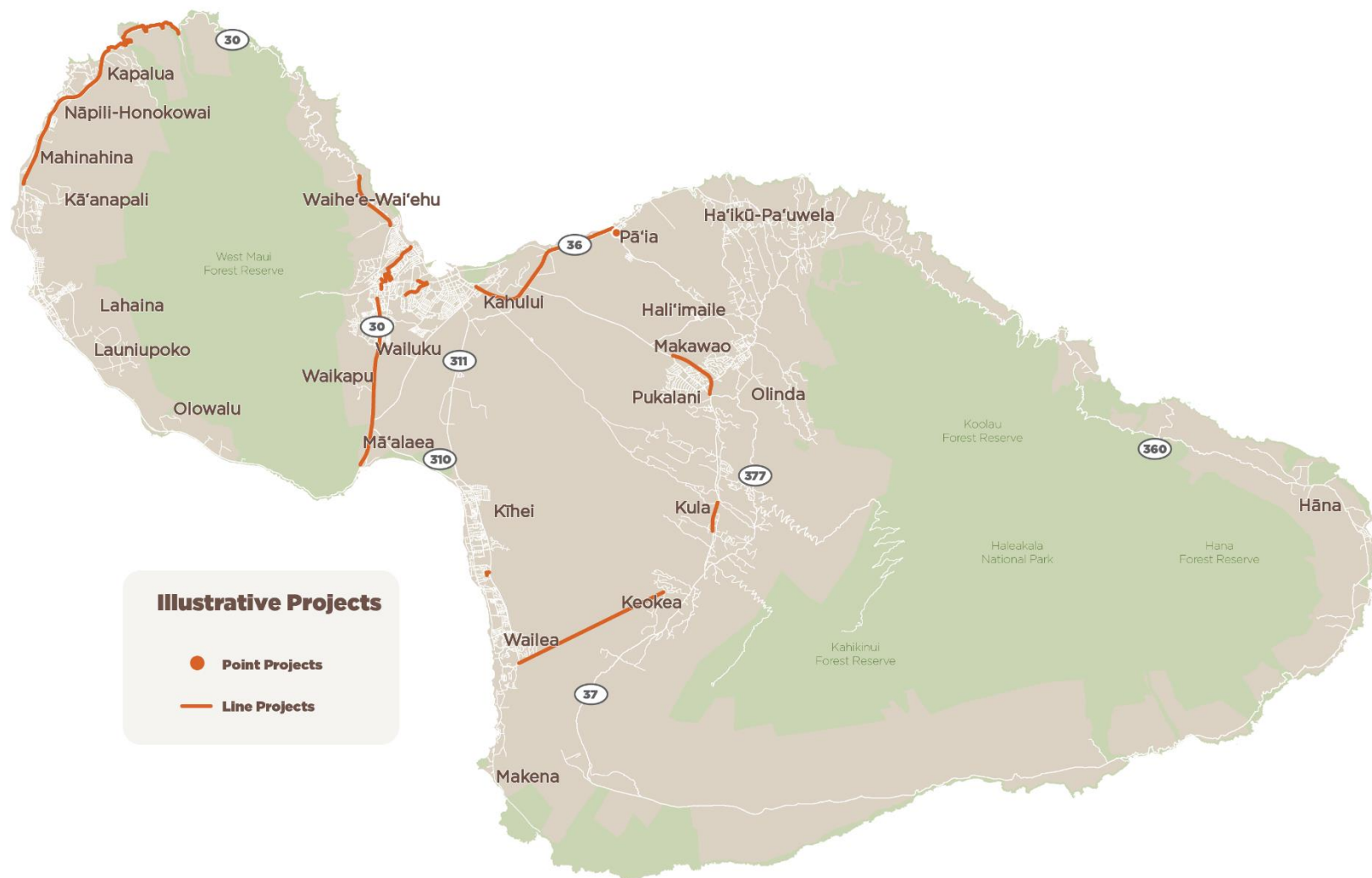
