# Act 278 (SLH 2019) Study of Land Subdivision and Condominium Property Regimes (CPR) related to Agricultural Land on Oahu

The State Office of Planning (OP) will be holding a public hearing on Act 278, Session Laws of Hawaii 2019, which requires OP to study land subdivision and condominium property regime (CPR) laws related to agricultural land on Oahu. The study examines the use of existing subdivision and CPR laws to allow small lot, non-farm residential uses in the State Agricultural District.

**Purpose:** Act 278 directs OP to conduct a public hearing to gather information from the general public, and to submit a report of its findings and recommendations including any proposed legislation at least 20 days prior to the 2021 legislative session.
