A Symposium on Building Best Practices

The Symposium will feature three speakers, moderated by HTDC's Executive Director and CEO, Ms. Yuka Nagashima and hosted in conjunction with the Broadband Assistance Advisory Council. Each speaker, although all from very different backgrounds, have all engaged with and/or implemented ambitious broadband initiatives elsewhere. The aim is not to have one voice as an authority of how Hawaii will move forward with the initiative, but instead to present a variety of tangible working models that all members of the community can use as tools in creating Hawaii's own method of deployment.

ICF co-founder Louis Zacharilla is the developer of the Top Seven and Intelligent Community of the Year Awards programs. In addition to his role communicating the purpose of the Intelligent Community movement to audiences worldwide, he leads the effort to extend ICF's mission through international affiliations and the formation of Institutes. He is a frequent speaker and moderator at a range of different types of conferences and events worldwide. He has appeared at the National Broadband Network Conference (Whittlesea, Australia), the Pacific Telecommunications Council (Hawaii, USA), Broadband World Forum and World Satellite Business Week (Paris) and the eGovernment Conference (Seoul, Korea.) He appears regularly on the Internet, TV and radio, where he speaks on the Intelligent Community movement and the impact of broadband and access technologies on economic and social development. He is a contributing author of *Broadband Economies: Building the Community for the 21st Century*. His articles and opinion pieces appear in publications including Continental, the in-flight magazine of Continental Airlines, *Satellite Business Executive*, *Business Facilities*, *Municipal World* and *Ideas Magazine* (Taiwan). Mr. Zacharilla has served as an adjunct professor at Fordham University in New York and an annual guest lecturer at New York University's Polytechnic School of Innovation Technology & Enterprise. He is also the co-author of *B2B Without the BS*.

Jane Smith Patterson
e-NC Authority



Jane Smith Patterson is the director of e-NC, an innovative, publicly funded initiative to increase broadband access and encourage all residents of North Carolina to use technology, and especially the Internet, to improve the quality of their lives and their economic prospects. Jane's career has concentrated on information technology

infrastructure and its impact on government, industry and education. She has consulted with more than 20 countries and 38 states about the design and operation of information networks. She has served in administrations of North Carolina Governor Jim Hunt, and in his fourth term she was Senior Advisor for Science and technology and Director of the Office for Technology. Her work in private industry included service as vice president of ITT Corp.-Network Systems Group. She was also interim vice chancellor of the University of North Carolina at Wilmington. In 1997, she was selected by the National Academy of Public Administration and the Alliance for Redesigning Government to receive the Public Innovator Award for her work in advancing the use of information technology in government.

Scot Rourke
President & CEO of OneCommunity



Under Scot's leadership since its beginning, OneCommunity is widely considered to be a pioneer in helping communities develop and implement strategies for sustainable, universal broadband access and usage. The organization has been fortunate to experience remarkable growth and has garnered international recognition for its innovative approach and many accomplishments. In 2009, Scot was recognized as one of Ernst and Young's Entrepreneurs of the Year for his Support of Entrepreneurship in Northeast Ohio. The previous year, he was named the Visionary of the Year by the Intelligent Community Forum, an international think tank focused on economic growth in the broadband economy. Prior to launching OneCommunity, Scot was president of a national information technology and services company with annual sales of more than \$100 million. That followed many years of turnaround management experience, working primarily with large industrial businesses leveraging innovative use of the latest information technologies. He received a B.S. from the University of Michigan, concentrating in business administration and organizational studies.
