Applicable Law: Hawai'i Revised Statutes, Title 24, Chapter 431, Article 19 (Enacted May 1986)

Supervisory Jurisdiction: Insurance Division, Department of Commerce and Consumer Affairs

Permitted Coverages: All Property/Casualty and Workers Compensation; Securitization of Insurance

Risks, Other lines as may be allowed by Insurance Commissioner

Organizational Structures: Stock, Nonprofit, Mutual, Reciprocal or Limited Liability Company

Classes of Captives: Class 1 - Single Owner; Reinsurance only

Class 2 - Single Owner; Direct and Reinsurance

Class 3 – Multi Owner; Association or Risk Retention Captive

Class 4 - Sponsored Captive; Protected cells may be established to segregate

risks of participants

Class 5 - Reinsurance or Excess Insurance only

Fees: Initial Incorporation Fee: \$ 50

Annual Business Registration Fee: \$ 15 Captive Application Fee: \$ 1,000

Captive Annual License Fees:

Class 1 and 2 \$ 300 Class 3 \$ 500 Class 4 and 5 \$ 1,000

State Taxes: Tax on captive's premiums only. Rates as follows:

0.25% on premiums from \$0 up to \$25 million

0.15% on premiums from \$25 million up to \$50 million 0.05% on premiums from \$50 million up to \$250 million

0.00% on premiums more than \$250 million

No minimum premium tax. Maximum premium tax of \$200,000.

No taxation of captive premiums if premiums were previously subjected to tax in jurisdiction where underlying risk is located, or on reinsurance premiums assumed by captive.

Captive License Activity: 179 active at 12/31/2012; 258 licensed since inception.

Capital and Surplus Minimum required capital and surplus determined by Insurance Commissioner

Provisions: based on each captive program.

Minimum statutory requirements:

Class 1: \$ 100,000 Class 2: \$ 250,000

Class 3: \$ 500,000 (RRG & Association)

Class 4: \$ 500,000

Class 5: As determined by Insurance Commissioner


