DearMr. Matsunaga:

By letter dated March 30, 2007, Applicant Hawaiian Telcom Services Corporation, Inc. ("HTSC" or "Applicant") submitted a seventh request to the Department of Commerce and Consumer Affairs ("Department"), pursuant to Section 440G-7(4), Hawaii Revised Statutes ("HRS"), to further extend the one hundred-twenty (120) day time limit for final action by the Department on its Application for a Cable Franchise to May 31, 2007.

Pursuant to Applicant's September 21, 2006 request, the Department granted Applicant's request on September 26, 2006, and the time limit for final action was extended to November 17, 2006. In its second request, Applicant sought approval for a further extension of one week, to Friday, November 24, 2006, which was granted by the Department. Pursuant to Applicant's third extension request, on November 13, 2006 the Department granted a further extension to Friday, December 8, 2006. On November 24, 2006, Applicant submitted a fourth extension request to the Department to extend the time limit to Friday, December 22,2006, which was approved. On December 8, 2006, Applicant submitted a fifth extension request to the Department to extend the time limit to Wednesday, January 31,2007. Subsequently, in a letter dated January 8, 2007 Applicant requested a sixth extension of time until Friday, March 30, 2007 for final action. Applicant updated its Application and responses to the Department's requests for information/clarification on March 1 and 15, 2007.

The Department agrees with HTSC's request to extend the time and approves HTSC's seventh request. The time limit for final action is therefore extended until May 31, 2007.

The Department continues to be available and ready to discuss franchise provisions with HTSC at its convenience and looks forward to receiving more information from the Applicant on the outstanding issues.

Thank you for your continuing cooperation and prompt attention to this matter.
