By letter dated October 24, 2006, Applicant Hawaiian Telcom Services Corporation, Inc. ("Applicant") submitted a request to the Department of Commerce and Consumer Affairs ("Department"), pursuant to Section 440G-7(4), Hawaii Revised Statutes ("HRS"), to further extend the one hundred-twenty (120) day time limit for final action by the Department on its Application for a Cable Franchise to Friday, November 24, 2006.


As you are aware, the Department has been available and ready to discuss the franchise provisions at the Applicant's convenience. There are currently issues that remain outstanding, and the Department has requested that Applicant provide it with more information on these matters.

Pursuant to Applicant's September 21, 2006 request, the Department granted Applicant's request on September 26, 2006, and the time limit for final action was extended to November 17, 2006. By this second request, Applicant seeks approval for a further extension of one week, to Friday, November 24, 2006.
