

NOTICE OF PUBLIC HEARINGS

Pursuant to Hawaii Revised Statutes sections 440G-10.1 and 440G-7 and chapter 91 and Hawaii Administrative Rules section 16-133-14, the Director of the Department of Commerce and Consumer Affairs (DCCA) will hold public hearings in each Hawaii franchise area on the Federal Communications Commission (FCC) Form 394s submitted on March 20, 2012 by Time Warner Entertainment Company, L.P. (TWE) for the transfer of its Hawaii cable franchises to Oceanic Time Warner Cable LLC (OTWC).
