Re: Franchise Required Channel for the City and County of Honolulu

As you may be aware, Decision and Order No. 346 ("D&O") requires Time Warner Entertainment Company, L.P. ("TWE") to make available to the Mayor of the City and County of Honolulu ("Mayor") and the Honolulu City Council ("City Council"), collectively, one statewide digital channel for governmental programming originating from Honolulu Hale ("Channel"). At this time, the Mayor and City Council have submitted a request to the Department that TWE provide a direct connection to its headend from Honolulu Hale for this Channel. The Mayor and City Council also wish to enter into direct discussions with TWE on the logistics of setting up the Channel.


Accordingly, pursuant to the D&O, we are asking TWE to make available one statewide digital Franchise Required Channel for governmental programming originating from Honolulu Hale within 30 days from the date of this letter. TWE shall be solely responsible for all costs for the connection to Honolulu Hale. The cost of any facilities and equipment to implement this digital Channel at the terminal in Honolulu Hale and for the operation of the Channel is the responsibility of the Mayor and City Council.

TWE shall notify the Department when the provision of this Channel to the Mayor and City Council has been accomplished. Except as otherwise provided in this letter, the remaining provisions in D&O No. 346 shall continue to remain in full force and effect.
