Re: Updated Inventory of PEG Access Facilities and Equipment, and List of Liabilities

This letter is to follow up on the lists of assets and inventory of facilities, equipment, and financial assets that each PEG access organization submitted to the Department of Commerce and Consumer Affairs (“**Department**”) in 2006. As you know, the Department is currently in the process of drafting a Request for Proposals (“RFP”) for PEG access services, and intends to attach the lists and inventories to the RFP.

Because a considerable amount of time has passed since the submission of the lists and inventories in 2006, the Department hereby requests that each PEG access organization provide the Department with the following:

- (1) Balance sheet accounts showing the balance in each account (not aggregated but separately stated); unaudited balances are acceptable;
- (2) All facilities, buildings, and real estate, irrespective of funding source;



- (3) All equipment and supplies irrespective of funding source; and
- (4) For each item of debt shown in (1) above, describe the collateral securing the debt. Exclude accounts payable and expense accruals.
