Per Act 199, the Work Group was established to streamline the permitting and approval processes relating to the development of broadband services and infrastructure.

Members of the Work Group have met four times to discuss issues regarding the approval and permitting required by Broadband providers in the deployment of their services.

The focus of the group has been the pole attachment issue (the ability for the providers to attach new fiber cables to existing utility poles). The current requirements are viewed as obstacles to the expeditious deployment of infrastructure.

The Work Group hopes to identify various solutions to this issue at future meetings.
