ORDER

I.

By Decision and Order No. 16232, filed on March 6, 1998, the commission granted KATHLEEN C. SULIEMAN (Petitioner), dba YASTER PAYPHONE SERVICES, a certificate of registration (COR) to operate as a pay telephone service provider in the State of Hawaii (State). Petitioner was issued COR-0006 by the commission.

By letter dated March 29, 2002, filed on April 2, 2002, Petitioner seeks commission approval to voluntarily surrender her COR. Petitioner states that she "was never able to place the phones for use."

The commission finds good cause to approve the proposed surrender of Petitioner's COR. In addition, because of Petitioner's status as a provider of pay telephone service, she has no customers per se to notify of her discontinuance of service. In any event, Petitioner states that she was never able to place pay telephones for use anywhere in the State.

Accordingly, the customer notification requirement set forth in Hawaii Administrative Rules § 6-80-123 does not apply.

II.


THE COMMISSION ORDERS:


2. This docket is closed.


