ORDER

I.

By Decision and Order No. 15420, filed on March 7, 1997, the commission granted GE CAPITAL COMMUNICATION SERVICES CORPORATION (Petitioner) a certificate of authority (COA) to operate as a reseller of intrastate telecommunications services.

By letter dated April 11, 2002, filed on April 15, 2002, Petitioner seeks to voluntarily surrender its COA, as a result of the commission's approval of Petitioner's: (1) merger with GE Capital Telemanagement Services Corporation; and (2) corresponding name change to GE Business Productivity Solutions, Inc.¹

Upon review, the commission will approve the proposed surrender of Petitioner's authority. This action is consistent with Docket No. 01-0128.


THE COMMISSION ORDERS:


1. Petitioner's request to surrender its COA to operate as a reseller of intrastate telecommunications services is granted, effective from the date of this order.


2. This docket is closed.


