I.

By Order No. 19427, filed on June 21, 2002, the commission suspended a section of the transmittal of NYNEX LONG DISTANCE COMPANY, dba VERIZON ENTERPRISE SOLUTIONS (Verizon ES), dated June 3, 2002 and filed on June 4, 2002. Specifically, the commission suspended the Business Plan D Bundled Service Option (Business Plan D), at section 3.6.5, pages 36.1 - 36.3, pending further review. Verizon ES was directed to respond to the commission's anti-competitive concerns relating to the Business Plan D.




II.




