ORDER

I.

By Decision and Order No. 15853, filed on August 26, 1997, the commission granted NETWORK PLUS, INC. (Petitioner) a certificate of authority (COA) to operate as a reseller of intrastate telecommunications services. Petitioner was issued COA-0087 by the commission.

By letter dated April 10, 2002, filed on April 11, 2002, Petitioner requests commission approval to voluntarily surrender its COA.¹ On July 29, 2002, in response to the commission's directive, Petitioner submitted its applicable annual financial reports and public utility fees.

Upon review, the commission will approve the proposed surrender of Petitioner's authority. Petitioner has complied with the customer notification requirement set forth in Hawaii Administrative Rules § 6-80-123.

¹On April 8, 2002, Petitioner notified its approximately 21 Hawaii-based customers of its intent to discontinue the provision of telecommunication services. A copy of its written notice is attached as Exhibit A to its April 10th letter.

II.

THE COMMISSION ORDERS:


