ORDER

I.

By Order No. 18044, filed on September 21, 2000, certificate of public convenience and necessity no. 1323-C (Certificate No. 1323-C), held by TETSUO KONDO, dba KONDO ENTERPRISE HAWAII (Petitioner), was placed on inactive status until September 21, 2001. By Order No. 18854, filed on August 22, 2001, Certificate No. 1323-C was placed on inactive status for an additional year, until September 21, 2002. The commission notes that under Hawaii Revised Statutes (HRS) § 271-19, the commission may grant inactive status for a cumulative period not to exceed two years over the life of the certificate.

By letter filed on August 12, 2002, Petitioner requests commission approval to voluntarily surrender his authority under Certificate No. 1323-C. Under Certificate No. 1323-C, Petitioner is authorized to transport passengers by motor vehicle over irregular routes on the island of Oahu in the (1) 1-to-7 passenger classification, and (2) 8-to-25 passenger classification, limited to limousines.

In accordance with Hawaii Revised Statutes (HRS) § 271-19, operating authority under a certificate of public convenience and necessity may be terminated upon application of the holder. The commission finds good cause to grant Petitioner's request to terminate his authority.

II.

THE COMMISSION ORDERS:

1. Petitioner's authority to transport passengers under CPCN No. 1323-C is terminated, effective from the date of this order.


2. Petitioner shall surrender his certificate, remove any markings from the vehicles used in his operations, and shall ensure that the vehicle identification cards for the motor vehicle equipment currently registered in his name are removed from the files of the Department of Transportation, Motor Vehicle Safety Office. Petitioner shall comply with the foregoing requirements within 30 days from the date of this order.


3. If Petitioner fails to comply with the foregoing requirements within the time period specified, he may be subject to penalties pursuant to HRS § 271-27.

4. This docket is closed.


