ORDER

I.

By Decision and Order No. 19422, filed on June 20, 2002, MOUNTAIN RIDERS, INC. (Applicant) was granted a certificate of public convenience and necessity to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Maui in the 1-to-7 and 8-to-25 passenger classifications, limited to providing transportation services in conjunction with its bike tours.

By a letter filed on September 16, 2002, Applicant now requests to surrender its authority in the 1-to-7 passenger classification. Accordingly, we find good cause to grant Applicant's request and amend Decision and Order No. 19422 to reflect such surrender of authority.

II.

THE COMMISSION ORDERS:

1. Applicant's request to surrender its authority in the 1-to-7 passenger classification is granted.

2. Decision and Order No. 19422 is amended consistent with the terms of this order. Specifically, ordering paragraph 1 in Decision and Order 19422 is amended as follows:

"Applicant is granted a certificate to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Maui in the 8-to-25 passenger classification, limited to providing transportation services in conjunction with its bike tours."

In all other respects, Decision and Order No. 19422 remains unchanged.
