ORDER

I.

By Decision and Order No. 19331, filed on May 3, 2002, D. OTANI PRODUCE, INC. (Applicant) was granted a certificate of public convenience and necessity to operate as a common carrier of property by motor vehicle over irregular routes on the islands of Oahu and Maui in the general commodities classification.

By a letter filed on September 18, 2002, Applicant now requests to surrender its general commodities authority on the island of Maui, as it has sold its Maui operations. Accordingly, we find good cause to grant Applicant's request and amend Decision and Order No. 19331 to reflect such surrender of authority.

II.

THE COMMISSION ORDERS:

1. Applicant's request to surrender its authority in the general commodities classification on the island of Maui is granted.


2. Decision and Order No. 19331 is amended consistent with the terms of this order. Specifically, ordering paragraph 1 in Decision and Order No. 19331 is amended as follows:


"Applicant is granted a certificate to operate as a common carrier of property by motor vehicle over irregular routes on the island of Oahu in the general commodities classification."




