DECISION AND ORDER

By Order No. 19585, filed on September 30, 2002, the commission ordered HAWAII GOLF TOURS, INC. (Respondent) to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on October 29, 2002 to show cause why Respondent's certificate of public convenience and necessity number 0892-C should not be suspended or revoked for Respondent's failure to timely file an annual financial report (AFR), pursuant to Hawaii Revised Statutes (HRS) § 271-25.

On October 18, 2002, Respondent filed its 2001 AFR and paid penalties assessed pursuant to HRS § 271-27(i) and Hawaii Administrative Rules § 6-62-42.


Based on the above, the commission finds that Respondent has fully complied, although belatedly, with the


motor carrier laws, rules, and regulations, and concludes that Order No. 19585 should be vacated.


