DECISION AND ORDER

By Order No. 19582, filed on September 30, 2002, the commission ordered HN KOBAYASHI CORPORATION, dba BIG GOLF TOURS (Respondent) to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on October 29, 2002 to show cause why Respondent's certificate of public convenience and necessity number 1549-C should not be suspended or revoked for failure to comply with the commission's order and pay a civil penalty of \$500.00 imposed by the commission.


On October 17, 2002, Respondent paid the civil penalty imposed by the commission.


Based on the above, the commission finds that Respondent has fully complied, although belatedly, with the motor carrier laws, rules, and regulations, and concludes that Order No. 19582 should be vacated.

THE COMMISSION ORDERS that Order No. 19582 is vacated and this docket is closed.
