ORDER

By Decision and Order No. 19752 (Decision and Order), filed on October 30, 2002, the commission vacated an order compelling CENTURYTEL LONG DISTANCE, INC. (Respondent) to appear at a hearing to show cause why its certificate of authority should not be revoked for failure to file an annual financial report. However, the Decision and Order contained a typographical error.¹ As a result, the commission finds that the second paragraph on page 1 of the Decision and Order should be modified to read as follows:

Based on the above, the commission finds that Respondent has fully complied, although belatedly, with the applicable laws, rules, and regulations, and concludes that Order No. 19620 should be vacated.

In all other respects, the Decision and Order remains unchanged.

¹The Decision and Order inadvertently referred to Respondent's compliance with "the motor carrier laws, rules, and regulations."


THE COMMISSION ORDERS that:


1. Decision and Order No. 19752, filed on October 30, 2002 is amended consistent with the terms of this order.
